Introduction to the Water Resources Council

The Tompkins County Water Resources Council (WRC) advises the Tompkins County Legislature on matters related to water resources management and planning, and is charged with identifying problems, proposing priorities, and promoting the coordination of activities in the management and protection of the County's water resources. The WRC provides a public forum for local communities and stakeholder groups to address and discuss their water resources concerns, and it is the intent of the group to coordinate the water resources-related efforts of local governments, public and private institutions, and agencies and organizations throughout the County.

The WRC also serves as the County's water quality coordinating committee, responsible for the development of the Tompkins

County Water Quality Strategy (WQS), which is intended to help prioritize local water resources issues and concerns and identify strategies to address these concerns. The strategies are incorporated into the WRC's bi-annual work plan, which is developed in conformity with the WQS, to help guide the activities of the WRC that are achieved through a number of standing and special committees. WRC membership consists of 21 voting members, who are appointed by the County Legislature, representing various water-related interests that include six non-voting members from relevant Federal and State agencies. The WRC welcomes Associate Members, who have committee-level voting rights.

To foster coordination and collaboration in the management of local water resources, WRC members serve as liaisons between the WRC and other groups, including the Finger Lakes-Lake Ontario Watershed Protection Alliance, Cayuga Lake Watershed Intermunicipal Organization and its Technical Advisory Committee, the Upper Susquehanna Coalition, Stormwater Coalition of Tompkins County, Tompkins County Agriculture and Farmland Protection Board, and Tompkins County Environmental Management Council. Informal relationships also exist between the WRC and other organizations and agencies such as the Fall Creek and Six Mile Creek volunteer monitoring groups, the Cayuga Lake Watershed Network, Hydrilla Taskforce, and the Town of Caroline Watersheds Committee.

Cayuga Lake Monitoring Partnership Committee

The Monitoring Partnership is working directly with representatives from DEC on the Cayuga Lake project investigating phosphorus levels and possible development of a Total Maximum Daily Load regulation. The group meets monthly to discuss current research. A DEC representative participates in the meetings.

Highlights from 2014 include:

Three Technical Advisory Committee meetings took place where the most current Cayuga Lake/Watershed research was presented. Members of the Partnership attended and/or reviewed summaries of the data presented and provided feedback to the DEC.

Special presentations by:

- **Upstate Freshwater Institute**, on phosphorus forms, analytical methods and specific characteristics of local water bodies,
- **Dave Bouldin**, on the scalability of phosphorus data from Fall Creek to the southern basin and whole lake as well as correlations between spring lake phosphorus and summer chlorophyll levels,
- **Steve Penningroth**, of Community Science Institute, on the strength of volunteer monitoring data to calculate stream sediment loads as well as individual stream characteristics.

The Monitoring Partnership debated the merits of the pathogen, nutrient and sediment listing for the south end of Cayuga Lake with the benefit of input from DEC. Ultimately, members of the Partnership submitted individual comments regarding the State's 303d list. Members of the Partnership also provided data (mostly regarding pathogens) to the Department of Environmental Conservation. The Department of Environmental Conservation's final recommendation was to de-list the southern end of Cayuga Lake for pathogens.

The Monitoring Partnership will continue partnering with DEC in 2015 on the Cayuga Lake project. The Partnership provides a place for exchange of information between regulators, local and regional scientists, and local stakeholders.

Aquifer Committee 2014 Annual Report

The Aquifer Committee investigated arsenic (As) in groundwater in Tompkins County during 2012-14. Data on concentrations of arsenic in groundwater were collected and compiled in 2012. In 2013, the committee began drafting a Fact Sheet based on those findings. In 2014, the draft was compiled and presented to the WRC for review. The committee prepared responses to the WRC members' comments and the document was revised. A final Fact Sheet (Arsenic in your groundwater?) was released to the public in December of 2014. Education Committee 2014 Annual Report

The Education Committee participated in the activities of the Outreach group of the Hydrilla Task Force including hosting public information programs and distributing information flyers to residents living along the east shore of the south end of Cayuga Lake. Sharon Anderson gave presentations to the Tompkins County Stormwater Coalition and the Planning, Energy & Environmental Quality Committee (PEEQ) of the Tompkins County Legislature on the Total Maximum Daily Load (TMDL), a process presently being undertaken by the DEC.

The Education Committee reviewed the Arsenic Fact Sheet prepared by the Streams Committee and added a link to it on the WRC web site which the Committee keeps current with pertinent information on water resources. The Committee also assisted with the layout of the Recreation Committee's brochure on paddling.

Executive Committee 2014 Annual Report

As a result of the City of Ithaca's newly proposed Stormwater Law the Executive Committee was instrumental in bringing together members of the WRC, the Stormwater Coalition, and the City's Public Works department to discuss the new proposal. This resulted in the City forming a review group under the guidance of Mike Thorne, City Public Works Commissioner, to tackle the issue of how the City handles its water related concerns particularly where the creeks are involved. This newly formed group will continue to work with Mr. Thorne, with the goal of compiling a strategy regarding the issue itself.

- The Executive Committee continues to participate with the Monitoring Partnership, Cornell University, and the DEC to address the concerns at the south end of the lake, and the TMDL issue.
- The Committee supported the City's application to the DEC for revised 6 Mile Creek stream bed excavation as proposed by the WRC's Streams Committee.
- The Committee supported the WRC's Wetlands Committee's recommendation to expand funding and the scope of study regarding the wetlands study to expand it to include all of Tompkins County. Funding from the Park Foundation was secured by the Cayuga Lake Watershed Network.

Grants Committee 2014 Annual Report

In 2014 the Grants committee met on an as-needed, informal, basis to discuss grant opportunities, applications and awards. A formal meeting was held in November to create and recommend the FLOWPA (Finger Lakes Lake Ontario Watershed Protection Alliance) work plan and budget. \$59,915.18 was approved for the 2014-2015 FY Tompkins County FLOWPA budget through the NYS Environmental Protection Fund.

The committee was also active in assisting the City of Ithaca apply for (and be awarded) a “Cleaner Greener Initiative” grant through the Environmental Protection Agency. The Committee also assisted the Tompkins County SWCD apply for a grant through the NYSDEC for a stream restoration project in the Town of Enfield. The District was awarded that grant of \$157,203.

Ongoing research, investigation and application submittal is a routine activity of the committee. As grant announcements are publicized the committee works to update the WRC membership. We look forward to a productive 2015 of grant activity!

Streams Committee 2014 Annual Report

The Streams Committee continued compilation of chloride values in Sixmile and Fall creeks over time, but tentatively decided to stop this, as the present values are below levels of concern. It also offered support to the Tompkins County Planning Department in their efforts to obtain funding to monitor pipeline stream crossings. A major effort was directed toward the problem of flooding due to sediment accumulation along the Sixmile Creek channel in downtown Ithaca. This

involved advising the DEC as to that danger, working with the City Public Works superintendent concerning reduction of that hazard, and interaction with the office of Barbara Lifton. Members of the Committee were also involved in a field review of a channel remediation project along Inlet Creek.

Wetlands Committee 2014 Annual Report

For a number of years, an objective of the Water Quality Strategy has been to identify and map wetlands that are not currently regulated by the State or federal government. The Wetlands Committee continued discussions with a local GIS consultant on how to use new mapping data to locate vulnerable wetlands. The committee partnered with the Stormwater Coalition of Tompkins County, Tompkins County Soil and Water Conservation District, and the Cayuga Lake Watershed Network to garner sufficient funds to support a pilot project for mapping wetlands in a portion of Tompkins County. A contract between the consultant and Cayuga Lake Watershed Network was executed in late 2013, and we look forward to providing technical assistance in 2014.
