a. NYS PP Spillman Touch Discussion

Julie Malysa from NYS Park Police presented a request from NYS PP to access Spillman Touch. She, along with Deputy Smith, spoke of numerous instances where PP assist with other TC LEA's and having access to name records, images and previous history are vital to officer safety. Items of discussion:

- -To allow access, PP need to be voted in to LETSS as a non-voting member. A motion was made to approve Non-voting status for NYS PP, approved, unanimous. Chief Steinmetz asked that Julie have her supervisor follow up with a written request.
- -There will be approximately 15 users for Touch, 9 officers, 2 sgts and 2 dispatchers. (Touch is the best fit for implementation at this time as PP do not have mobile connectivity in their vehicles)
