2. TraCS 10

a. Project Implementation

Kim reported that with the help of the Team from Albany, ITS and DOER, the consolidation of the 6 servers to one County hosted SQL solution was completed. She gave high praise and appreciation for the Team rolling out the implementation in just 3 days.

c. Database Cleanup

d. Bandwidth @ CH/TB

Kim reported that the connection to TraCS at these two agencies is painfully slow. Both agencies are aware and are looking into alternate options.

TraCS reporting is no longer built into TraCS. ITS will allocate resources to attempt to have some reports built by the end of July.

3. LiveScan

Kim reported that the initial grant was rescinded. DCJS has replaced, TCSO and IPD need to reapply. Additionally, Village PD's are now eligible, but would need to meet the 50% funding requirement.
