Legal Impacts of Supreme Court Marriage Equality Decision

Because states *may no longer restrict marriage based on gender*, federal and state spousal and "surviving spouse" rights and benefits may no longer be denied to same-sex spouses. Likewise, for a transgender or transitioning person, a change in what gender a spouse is recognized to be does not affect the legality of an existing marriage.

This decision has a broad impact in the areas of federal and state income tax filing status and retirement and survivors' benefits including Social Security, Veterans, state and private employer benefits and retirement plans.
