
RESIDENTIAL DEMAND POTENTIAL TOMPKINS COUNTY, NEW YORK IN-COMMUTERS

I. <u>INTRODUCTION</u>

Over 25% of the Tompkins County work force commutes from outside Tompkins County, creating significant issues for employers with respect to employee retention and absenteeism during inclement weather. This is primarily the result of the cost of housing in the county, which also impacts

the potential to attract new employees.

In 2013 (the most recent data available) there were a total 15,101 in-commuters, an increase of 10.1% from 2000. It is noteworthy that the rate of increase has diminished from 1.0% per year between 2000 and 2010 to 0.2% per year since 2010. It should be noted that out-commuters totaled only 4,202 in 2013, a decrease from 4,868 in 2010.



The following data is based on the internet survey of Tompkins County residents, students and employees which contained a subset of 439 incommuters.

II. SUMMARY OF IN-COMMUTERS

Following is a summary of characteristics of employees commuting into Tompkins County.

1. Most in-commuters are living in Tioga County (24.4%), followed by Cortland County (21.4%).

- 2. A total of 57.6% of in-commuters indicated that they would live in Tompkins County if "housing that met their needs at a price they could afford were available." A total of:
 - 95.3% said the move would be work related
 - 49.0% liked the proximity to night life, restaurants and entertainment
 - 41.9% wanted to be closer to shopping
 - 38.7% replied "quality of life"
- 3. Of those not wanting to reside in Tompkins County:
 - 63.4% just preferred their current home
 - 41.4% replied "family reasons"
 - 33.3% said housing was too expensive
 - 28.5% had a spouse employed in their county of residence and a move would not be convenient
- 4. One-half of commuters drive at least 38.7 minutes to their place of employment and 9.5% drive at least 60 minutes.
- 5. 45.8% of in-commuters are impacted at least 3 times per year in their ability to get to work.
- 6. 86.1% live in a single family home, 82.2% own their own home.
- 7. Among those who rent, the median rent is \$700 per month, unadjusted for utilities. After adjusting for utilities, the median rent (including water, sewer and trash removal), is estimated at \$783 per month. A total of 5.1% have a rent payment over \$1,500 per month.
- 8. Among home owners, the median house payment including taxes is \$874. A total of 13.4% have a house payment over \$1,500 per month.
- 9. When asked if they are planning to move within the next 5 years, 17.8% of in-commuters replied "yes" and another 24.0% replied "maybe." Among this group, 26.0% are "extremely or somewhat likely" to move to Tompkins County. Among this group:
 - 37.6% would prefer the Ithaca City school district, 30.9% would prefer Lansing Central schools and 21.8% would prefer Trumansburg Central Schools

III. <u>DEMAND ANALYSIS</u>

There are a total of 15,101 in-commuters. However, as there may be more than one person in the household employed in Tompkins County the number of households represented by the 15,101 in-commuters will be somewhat less. While there is no current data available, according to the 2014 American Communities Survey, 87.3% of Tompkins County vehicles commuting to work were single-passenger trips and 12.7% were car pools. It would be assumed that there would be a higher carpooling share for in-commuters. There is no way of ascertaining the share of the car pool vehicles that were members of the same household. For the purposes of this analysis we are assuming that 10% of the in-commuters are carpooling from the same household (deemed a very conservative estimate).
