TOMPKINS COUNTY, NEW YORK HOUSING DEMAND BY INCOME

The Tompkins County housing demand by income report is based on the single-family, condominium and apartment demand analysis reports in which the demand is reflected by price or rent range. For this report, the price and rent ranges have been converted to the appropriate income ranges that support the price range.

For the single-family and condominium tables, the price range was based on an assumption of a 75% mortgage and an underlying loan of 30% of total income.

For the rental demand, net rent (net of utilities) of 25% of income was used. For ease of comparison, the income ranges in the rental housing table have been changed to be the same as the ranges for single-family and condominiums in the \$45,000 and over categories.
