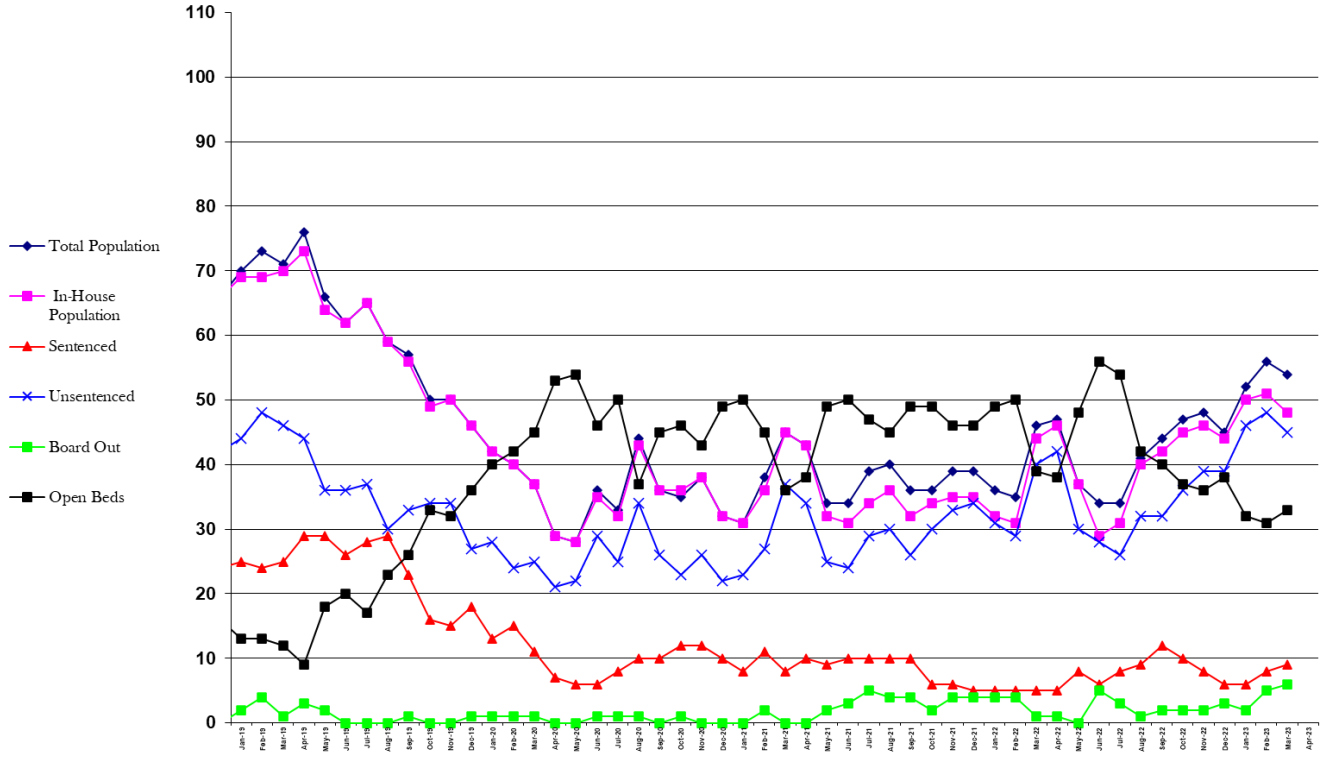

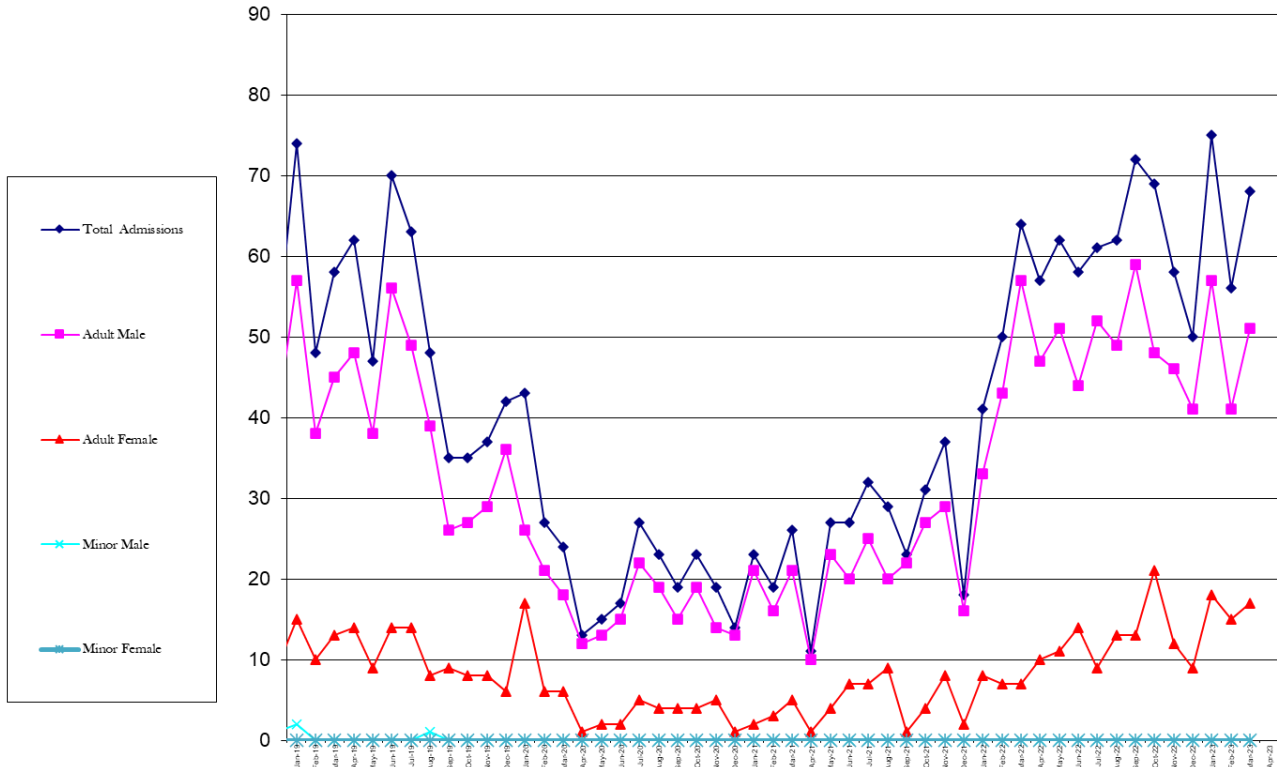

Average Jail Statistics

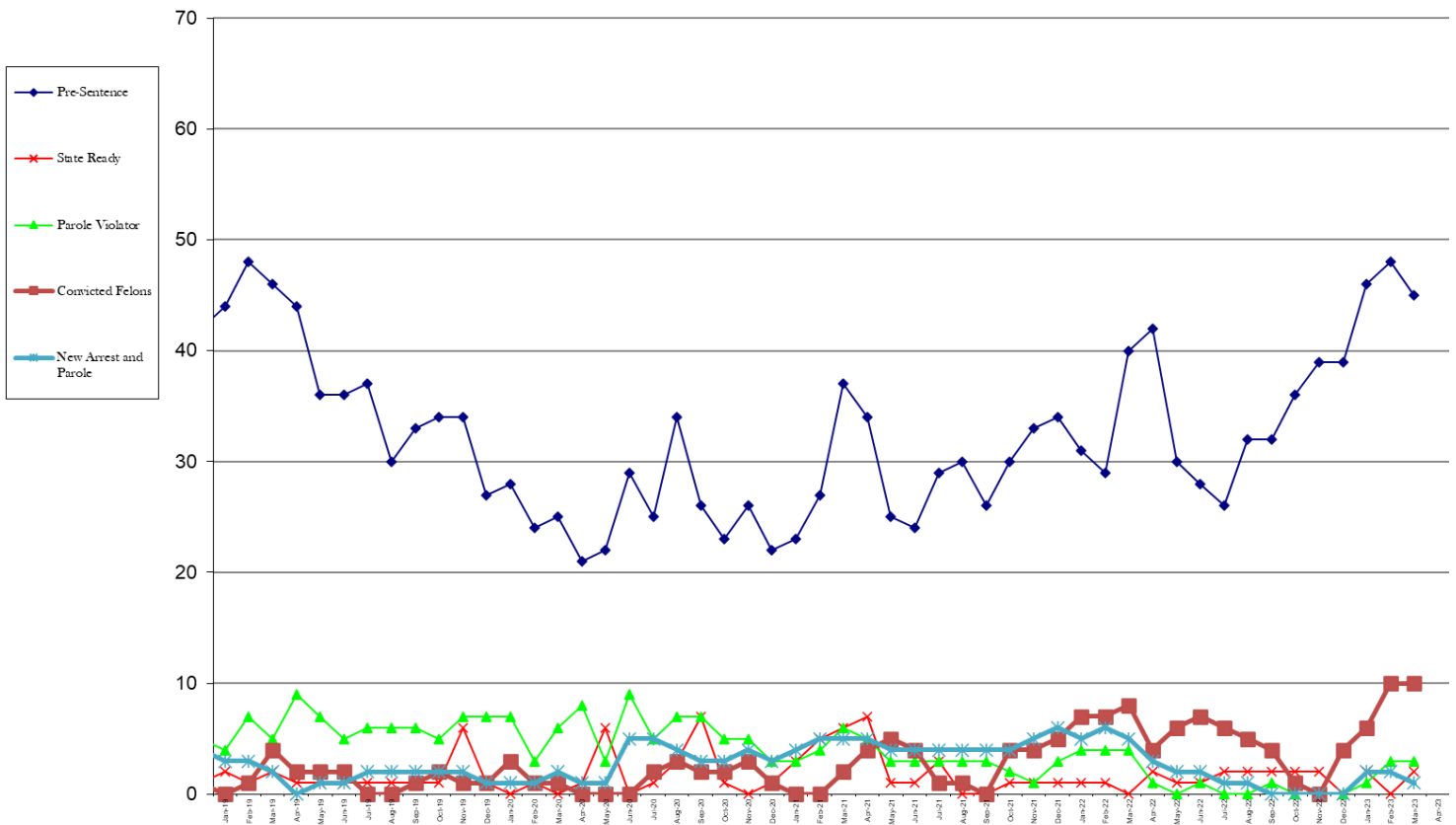


Monthly Admission Totals

- April 22nd, 2023: Sheriff Osborne attended the Trumansburg Fire Department Banquet in support of their partnership with TCSO and their service to the community.

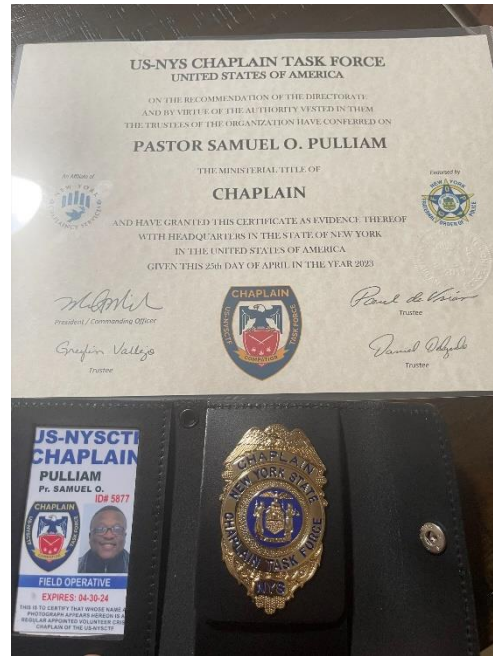
