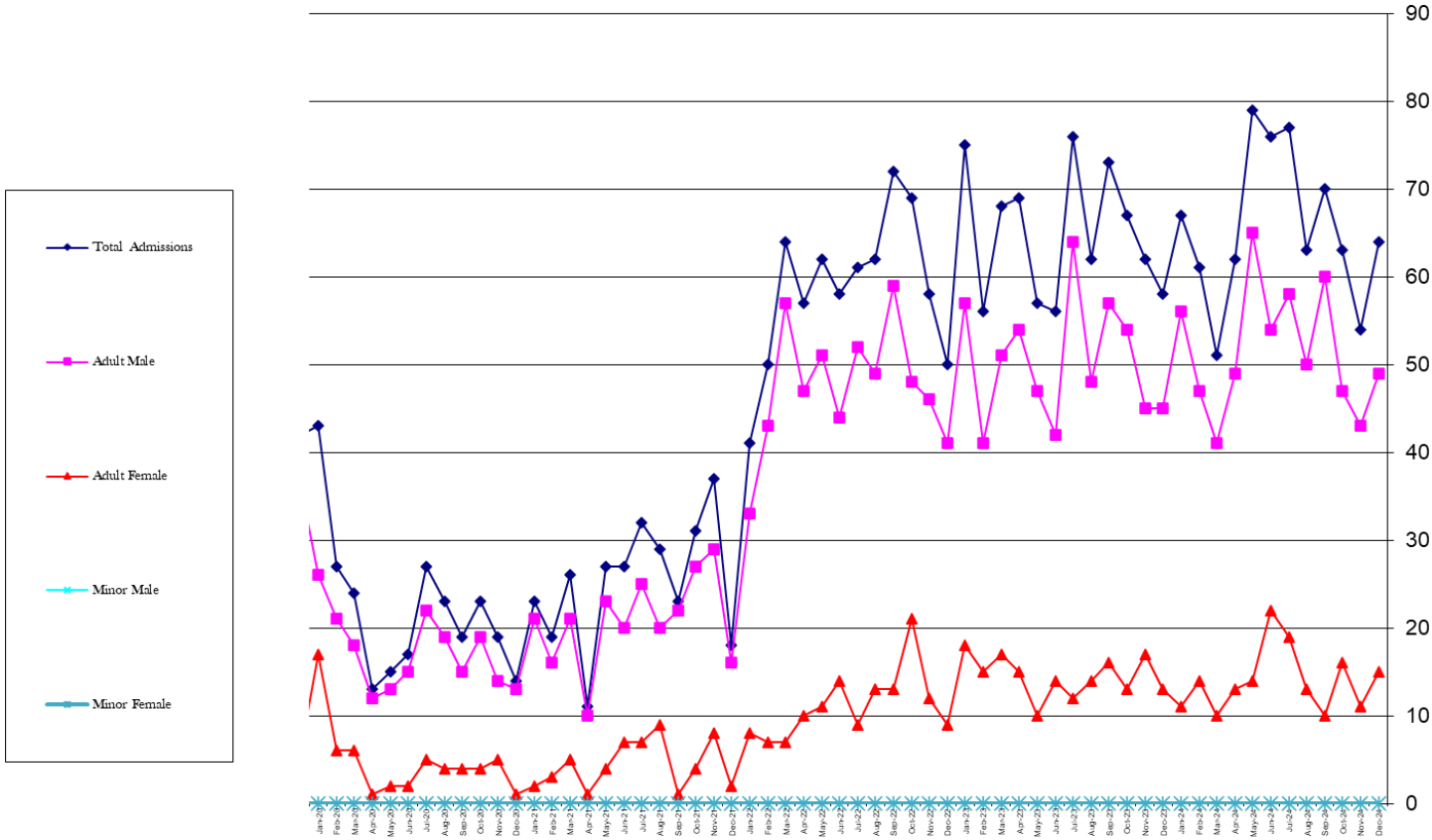

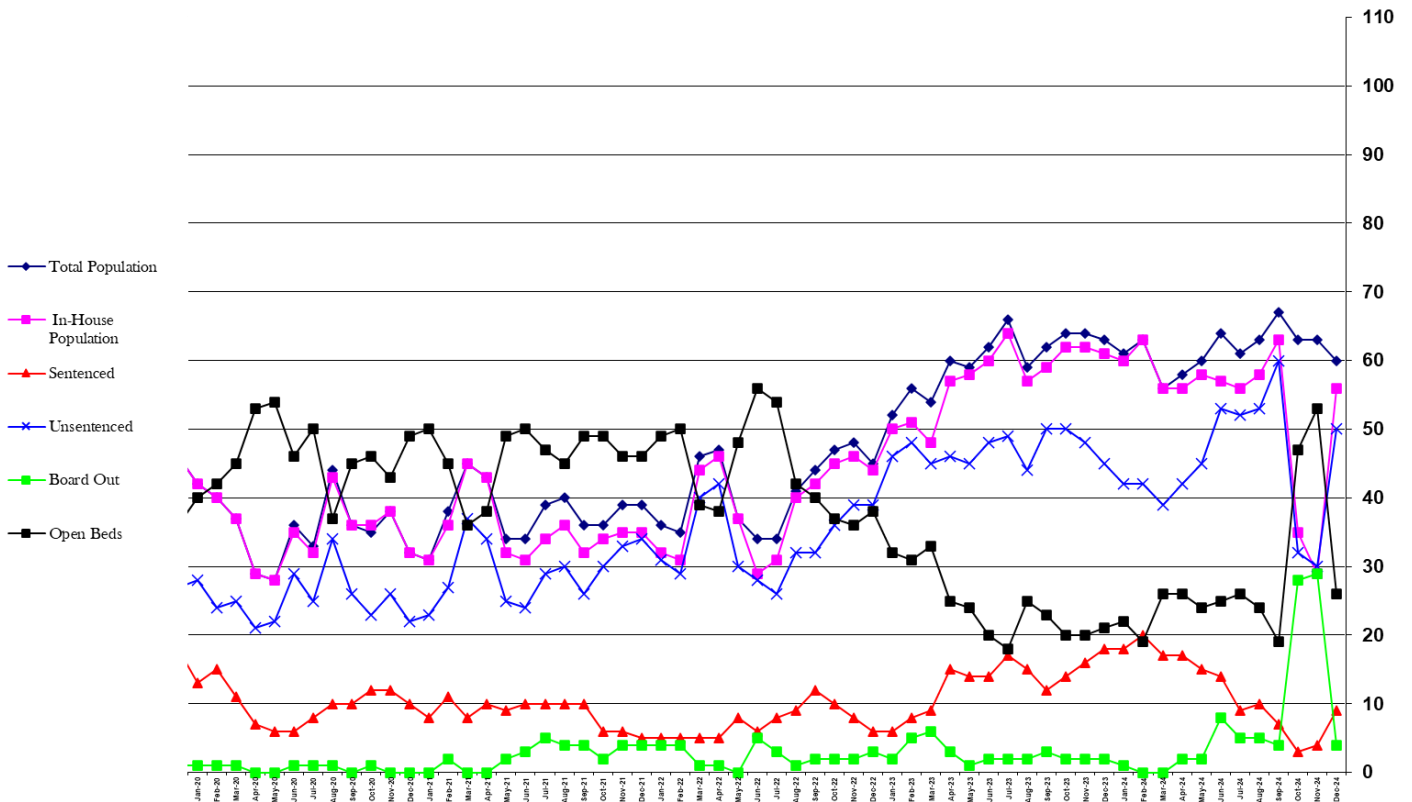

Monthly Admission Totals

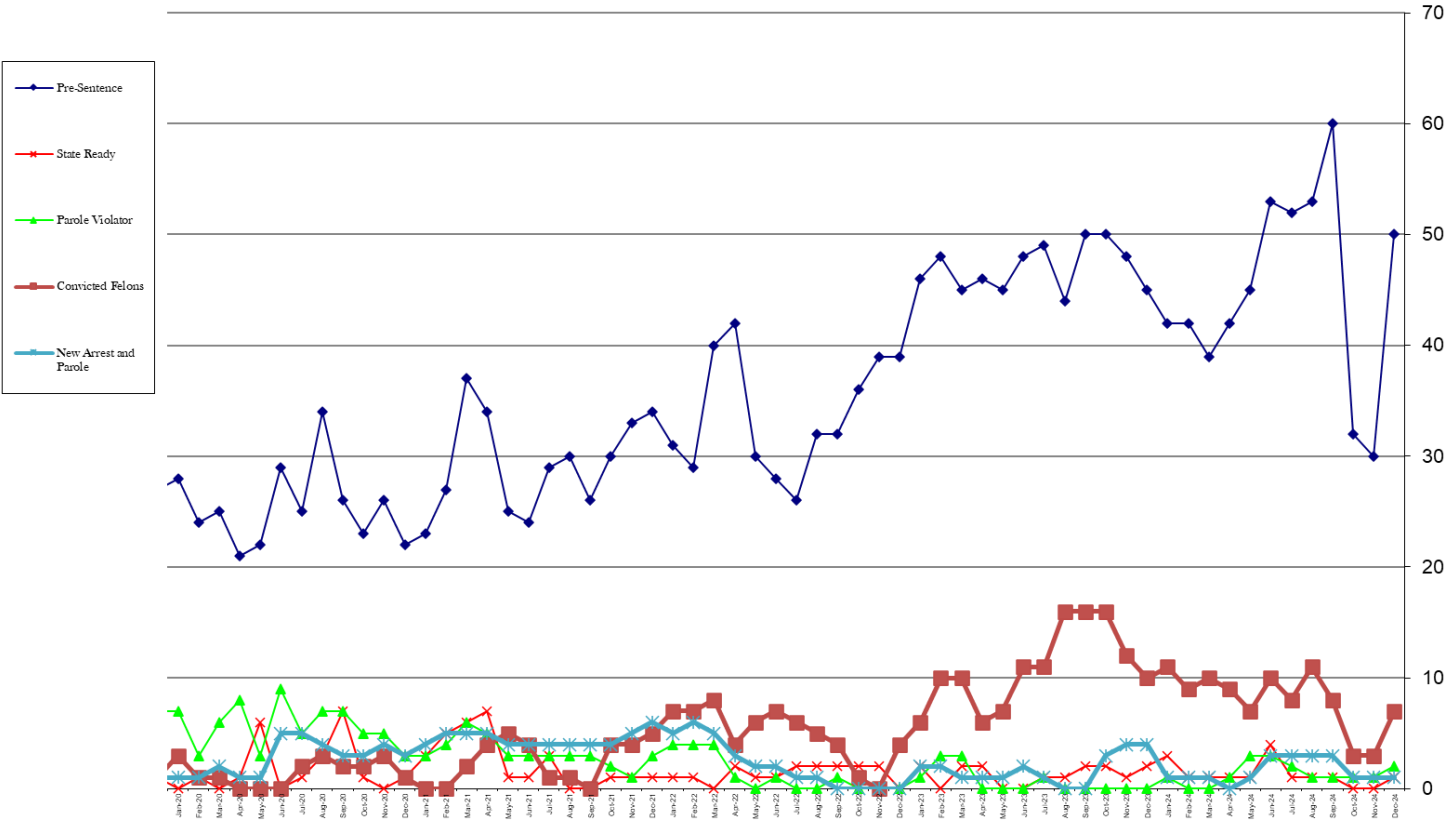


Average Jail Statistics

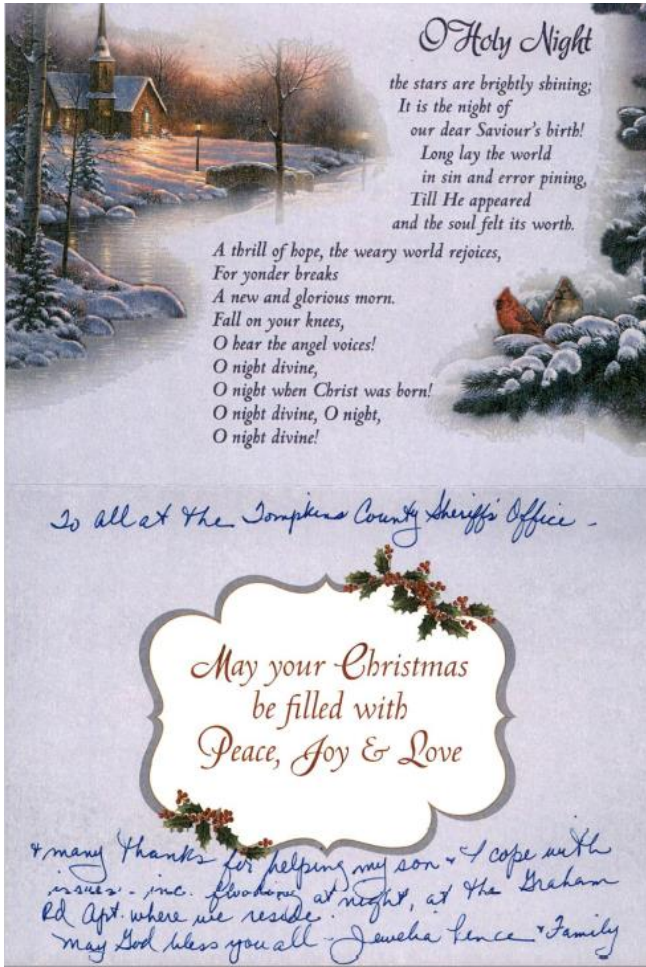
How we treat each other matters!
