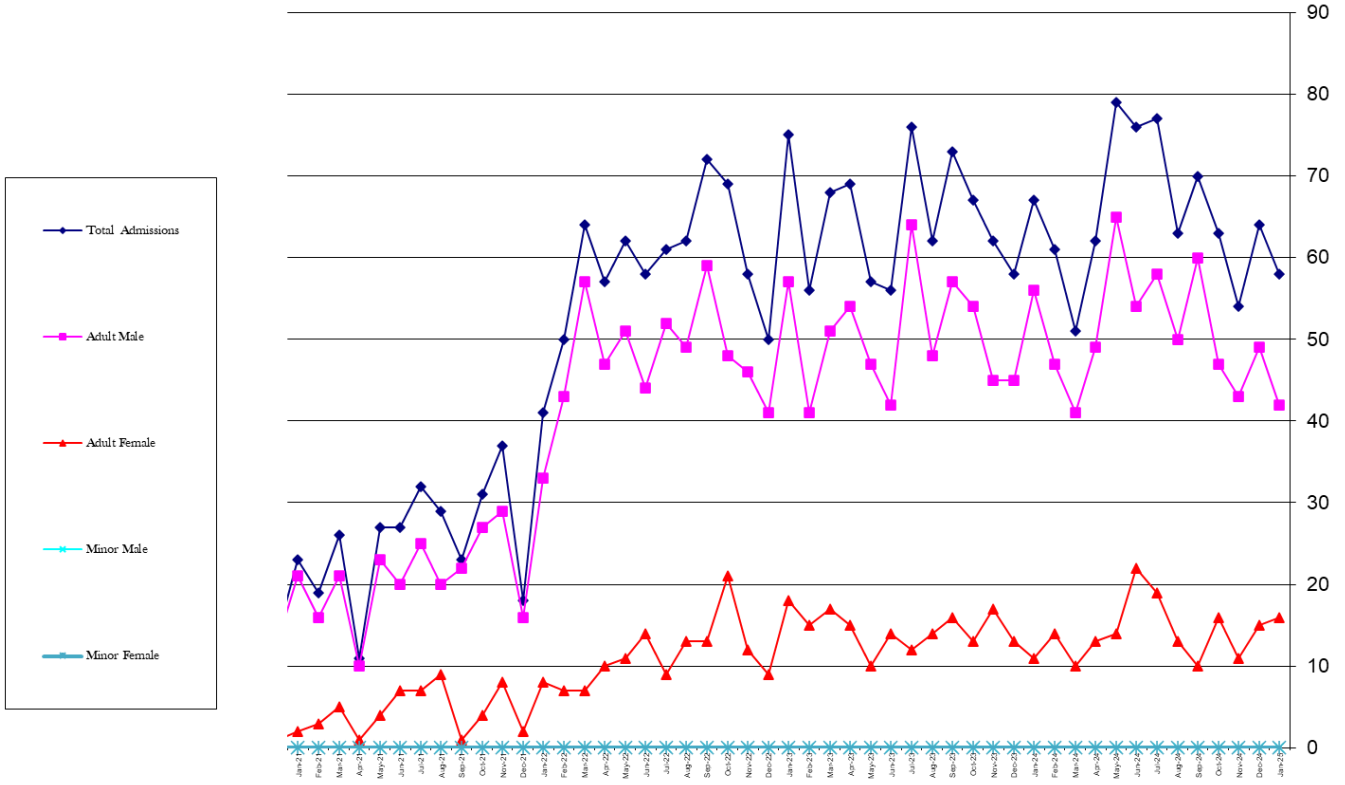

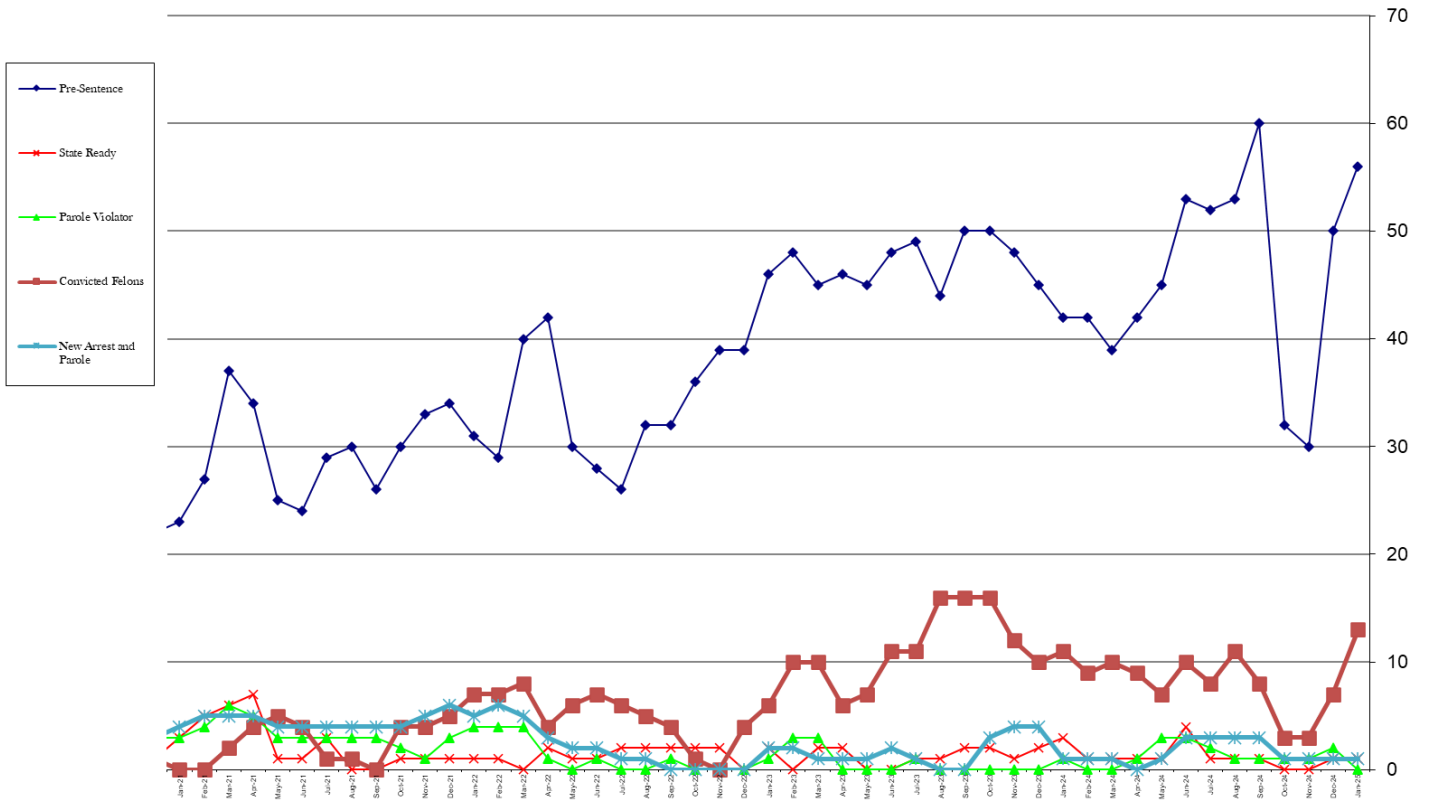

Monthly Admission Totals

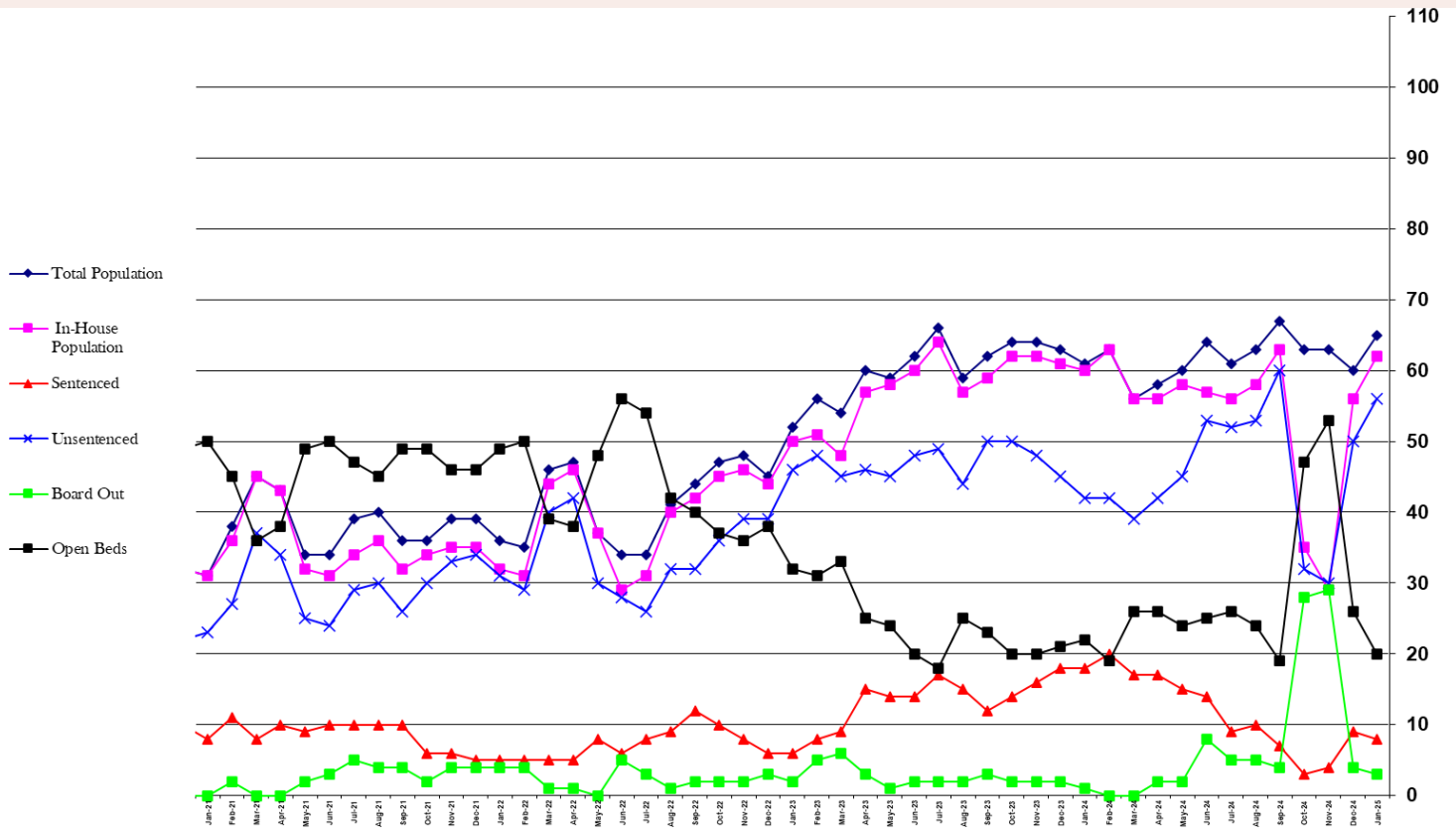


Unsentenced Inmate Breakdown (Averages)

Dear Undersheriff Olin:

Since your certification page or county resolution has been submitted, we are approving your 2025 STOP DWI Plan. Thank you for your dedication and continued work to address the problem of impaired driving.

NY CRR Section 172.3(e) states that a "written notification of all plan amendments and budget modifications which propose either expenditures in previously unfunded areas or items or increased expenditures in previously funded areas or items must be sent to the commissioner. In the case of previously unfunded areas or items, such notifications must be sent at least 15 days prior to the expenditure. Written approval by the commissioner is required of such budget modifications only if the sum total of all budget modifications within a fiscal year exceeds 10 percent of the originally approved budget."

We recognize that county governments continue to experience the same fiscal constraints as the rest of the state. In these difficult times, we have a duty to ensure that program spending is constrained to activities that prevent impaired driving, including the enforcement of impaired driving laws, and is not used to supplant local expenses. If you plan to modify this STOP DWI budget plan, you must notify the GTSC (Governor's Traffic Safety Committee) before incurring any costs.

ACTIVITIES CONTINUED

- **January 16, 2025:** The Tompkins County Sheriff's Office adopted the Blue Envelope Program, a safety initiative aimed at supporting drivers with Autism. It encourages drivers with autism to keep important documents such as their license, registration, and insurance in a Blue Envelope. When the officer observes the envelope, they are immediately alerted to the driver's condition and can adjust their response to the situation accordingly. Along with clear instructions for the driver, explanatory information is printed on the envelope for the law enforcement officer, to include an emergency contact. The New York State Sheriffs' Association is promoting this program statewide, with many sheriff's offices, including Tompkins County, participating.
