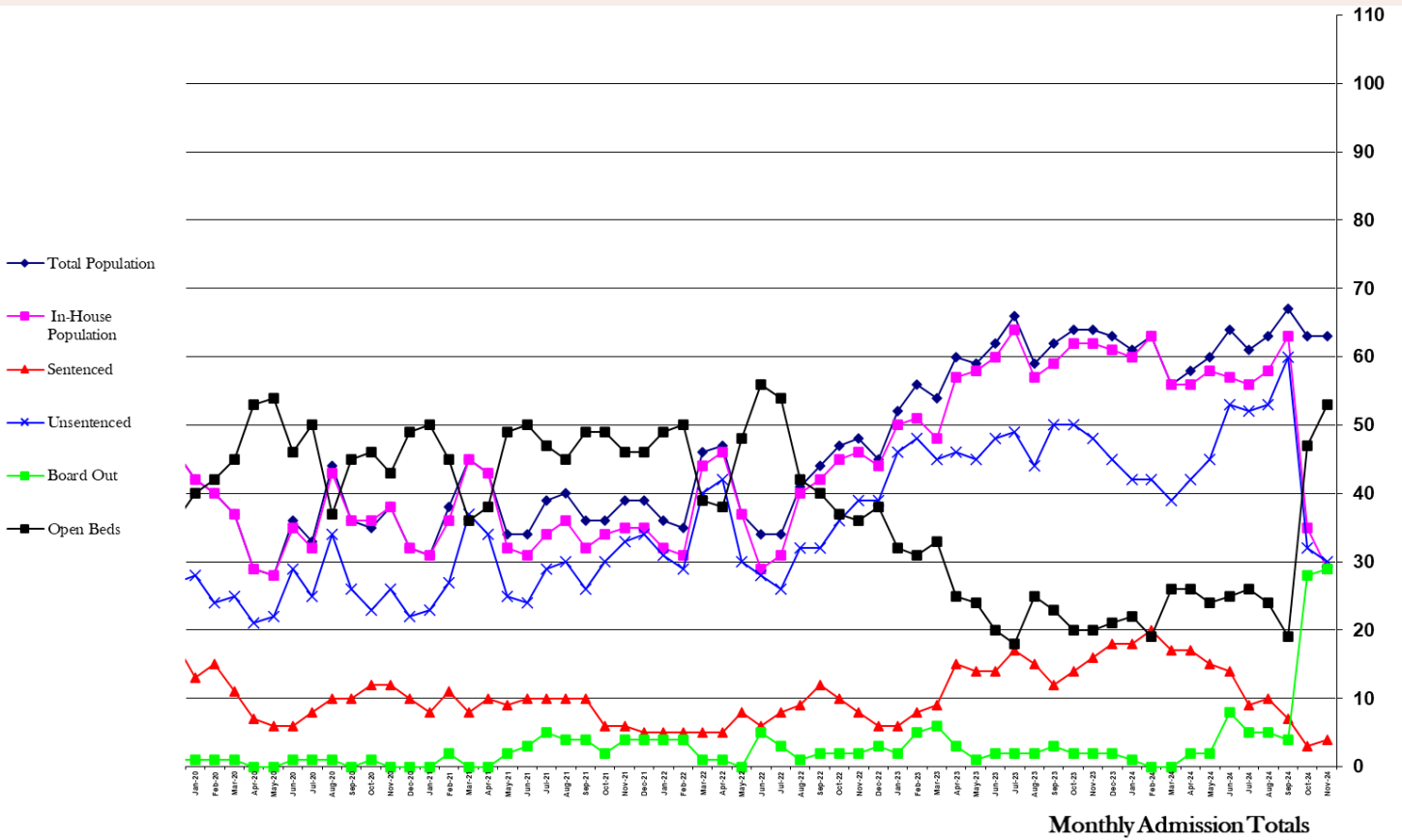

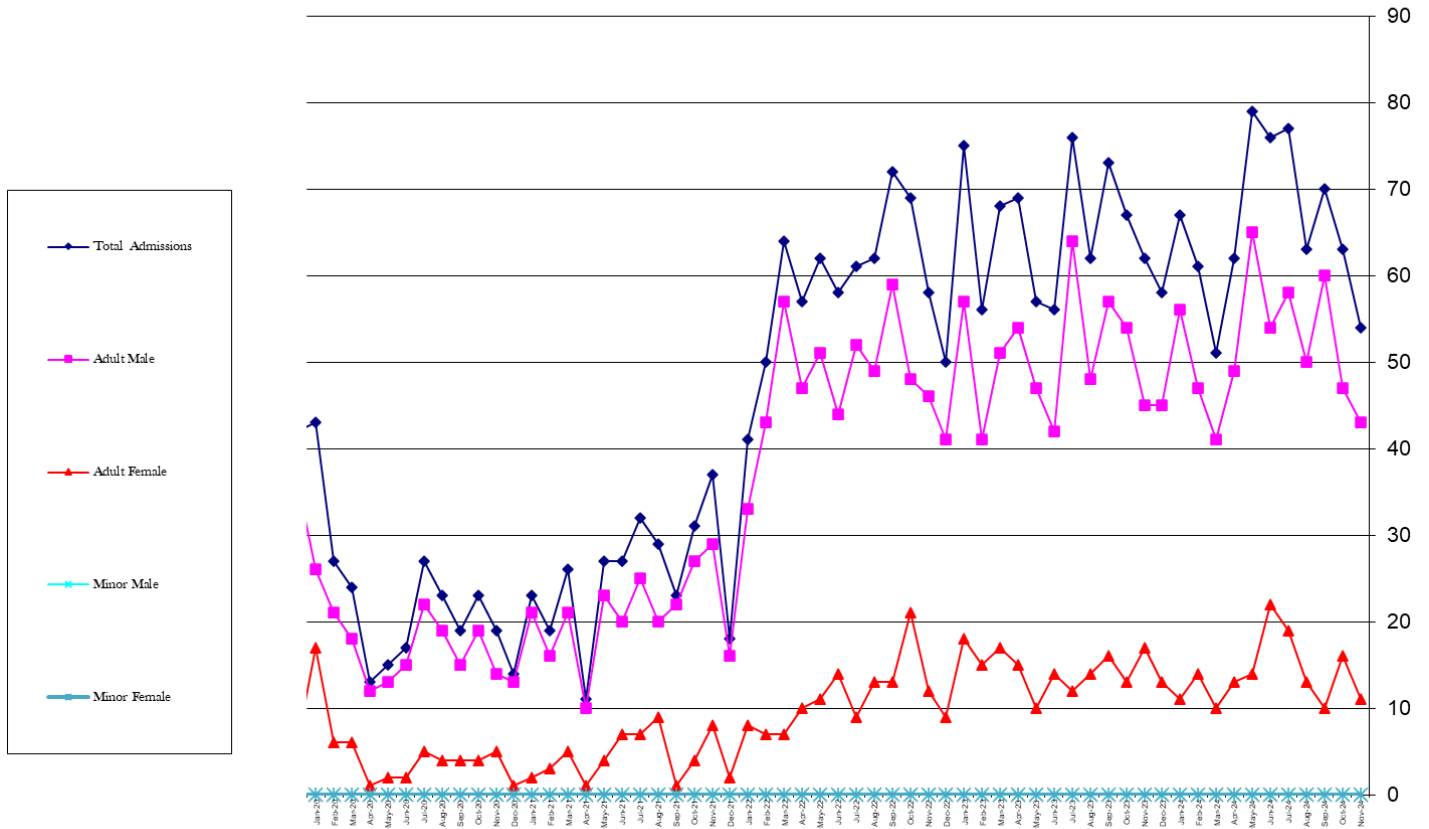

Average Jail Statistics

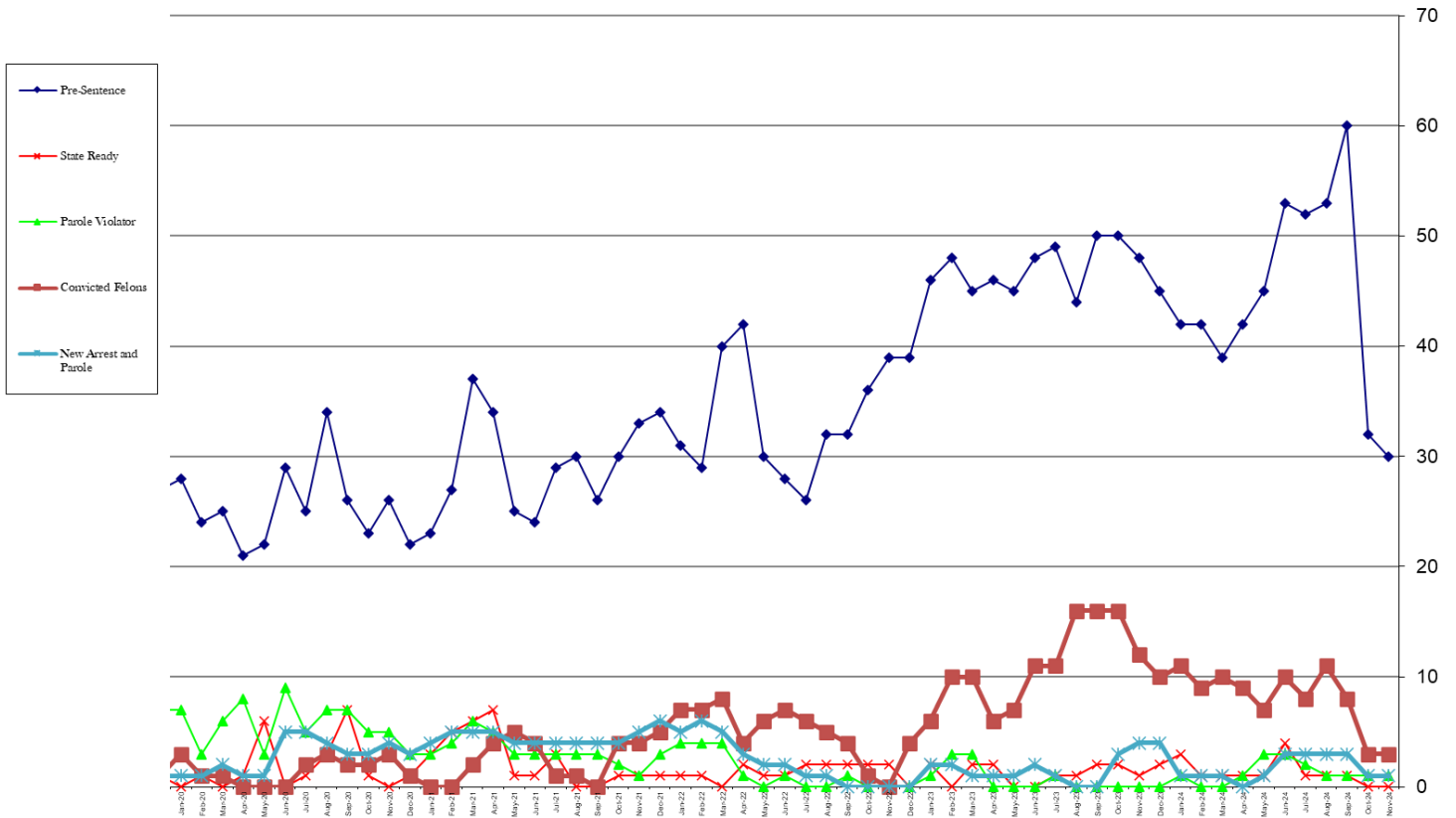


Monthly Admission Totals

- **November 8, 2024:** Officer Casey Nash and Officer Anthony Mase graduated from the New York State Basic Corrections Academy.

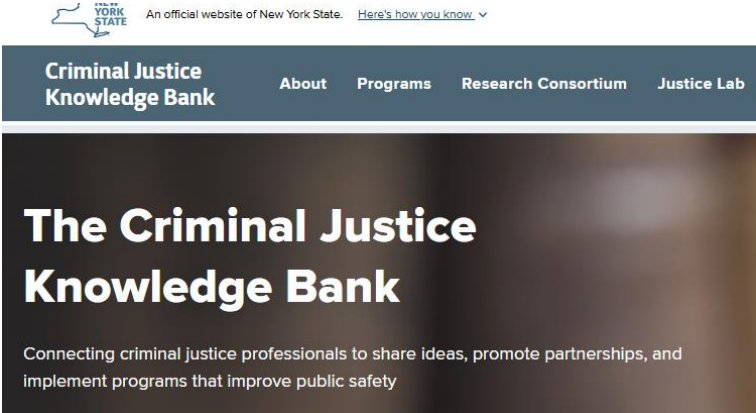


- **November 11, 2024:** TCSO participated in the 4th Annual First Responders Bowl in Cortland and remained undefeated champions with a score of 38-20.

It will help us to appreciate unrecognized opportunities for professional learning, obtain access to new ideas and resources, and hopefully share these results with other law enforcement professionals and agencies. Lastly, we hope our work will improve public safety and community relations".
