Call to Order: Dr. Moylan called the regular meeting of the Board of Health (BOH) to order at noon. Introductions were made and the agenda was adjusted to move up the enforcement action discussion for a vote.

New County Administrator, Korsah Akumfi – Mr. Akumfi introduced himself to the BOH. He is very impressed with the achievements of Tompkins County Whole Health and looks forward to working with the department.

12:10 Dr. Dhundale moved to go into executive session to discuss the Public Health Director's position with Mr. Akumfi, seconded by Ms. Black; all were in favor.

12:45 Ms. Black moved to go out of executive session, seconded by Dr. Koppel; all were in favor.

Privilege of the Floor: Cook Properties CEO Bill Heumann discussed the stipulation agreement with the Board of Health, assuring them that all concerns are being addressed. Glenn Thornton from Thornton Engineering explained that he works on various projects for Cook Properties and that all items detailed

in the resolution will be addressed in the feasibility study, which will be submitted by the deadline. The BOH thanked them for their time and patience.

Approval of December 3, 2024, BOH Minutes: Dr. Dhundale moved to approve the minutes from December 3, 2024, and Ms. Black seconded the motion. All were in favor as written, with Mr. Cantone abstaining, the motion carried.

Financial Summary: Mr. Porter reported that they are in the process of building out the books from last year with no significant budget overages. The full year-end financials will be available in the next couple of months once the County has closed its books.

Medical Director's Report and Discussion: Dr. Klepack referred to his report included in the packet and noted that influenza is on the rise and COVID-19 is still prevalent.

With the federal government moving to withdraw from the World Health Organization (WHO) he emphasized the importance of public health agencies and is concerned about the impact on public health surveillance and response. There are major concerns about the spread of avian influenza (bird flu) becoming a pandemic. Without WHO participation, our ability to monitor and respond to such threats is significantly impaired. WHO is a key agency which monitors and responds to global health threats

Dr. Klepack also highlighted WHO's efforts to eliminate polio and its past success and eliminating smallpox. Crippling WHO at this time, cripples the effort to eradicate polio.

At the time of this report, the federal government has prevented public releases including public health releases from agencies, including the FDA and CDC It is important to know that although our community is not receiving any health advisory reports from any national agency, NYS will not stop it's sharing of important public health information.

Administration Report: Mr. Kruppa announced that this will be his last Board of Health (BOH) meeting as Public Health Director after 14 years in the position. He expressed his gratitude for the support he received from both the Board and the community. Although he is not leaving the community, he will be moving on to another organization with similar goals. Many Board members took the opportunity to express their appreciation and support for his work during his tenure.

Opioid Data Doubling – Dr. Moylan asked about data that shows opioid data doubling. Mr. Kruppa is not sure but believes it could be due to better reporting or more emergency response calls related to the opioid crisis. It could also be more people in need are receiving life-saving interventions.

Status of unhoused individuals – Dr. Moylan asked about the status of the unhoused. Mr. Kruppa said of the 40 unhoused individuals from the encampment, all are housed due to the housing service that

occurred with supports. He noted that there are still people in the encampments, and Environmental Health are in conversations moving with the City around the plan to clean up the next phase.

Children with Special Care Needs (CSCN) Report: Ms. Clark Manderville reported that they are onboarding a second special education teacher who will provide instruction to children in the early intervention program, creating an opportunity to reduce the waitlist to zero.

Division for Community Health (DCH) Report: Ms. Buckwalter reported that the health department is working to proactively coordinate with healthcare providers, farms, and the public to prepare and plan for potential avian influenza cases in the community. They are having conversations with local healthcare providers to ensure appropriate screening and testing processes are in place. They have also reached out to Cornell Cooperative Extension to start communication with local farms, as there have been cases of positive birds on farms in other counties. This is important because the department would be tasked with monitoring any exposed farm workers.

Health Promotion Program Report: Ms. Hillson reported that they have free Radon Test kits available at the health department for the Healthy Neighborhoods program. Radon test kits are also available from the State and big box stores. The Community Health Survey was launched last week. Flyers are available and there is a direct link to the survey on the webpage.

Environmental Health (EH) Report: Mr. Parr reported on Ms. Cameron's behalf. He had nothing to add to the written report included in the packet.

ENVIRONMENTAL HEALTH Enforcement Actions:

 Draft Resolution # EH-ENF-24-0019 – Hanshaw Village MHP, Violations of Board of Health Orders and Subpart 5-1 & 17 of the New York State Sanitary Code (PWS/Mobile Home Parks) (5 min) Dr. Koppel moved to accept the resolution as written; seconded by Dr. Dhundale.

Mr. Parr explained that the resolution was amended from the initial proposal for better clarification of what was needed and is detailed in Exhibit B in the packet. The deadline was extended to February 17, 2025, and the final feasibility study is due by April 4, 2025.

Discussion: Previous fines were paid, and no additional fines were applied.

All were in favor; the vote to approve the resolution as written was unanimous.

Administrative Actions (EH) (5 MINS)

1. The Oral Health Status and Recommendations Concerning the Children of Tompkins County.

Ms. Vemprala presented findings from a survey on the oral health status of children in Tompkins County.

- Access to Dental Care: The survey found significant challenges for families in accessing dental care providers, especially pediatric dentists, and dentists who accept Medicaid
- Importance of Fluoride: The survey highlighted the need to educate the community on the importance of topical fluoride applications and fluoride supplements at home and address communication around fluoride in the water supply.
- Equity Concerns: The access issues were found to impact lower socioeconomic groups disproportionately, but also extended to families with jobs and insurance who still struggled to find appropriate dental care.

The health department is proposing a board resolution to raise awareness of these oral health challenges and inequities, to spark collaboration and action to address the identified problems. The board discussed the potential next steps, including reviewing a draft resolution at the next meeting.

Following next steps regarding the oral health issues for children in Tompkins County:

- 1. The health department will work on drafting a resolution that highlights the key findings from the oral health survey, the implications for equity, and the importance of addressing the problems.
- 2. The draft resolution will be shared with board members before the next meeting, so they can provide feedback and input on the content.
- 3. The discussion on the draft resolution will be put on the agenda for the next board meeting when more board members will be present to provide their perspectives.
- 4. The board expressed interest in reviewing the draft resolution but also wanted to ensure there was a clear plan in place to address the issues, rather than just issuing a statement.

The overall goal is to use the resolution as a way to raise awareness of the status of school children's oral health, emphasize causative areas, and stimulate community engagement.

The next meeting is on Tuesday, February 25th, 2025 @ noon.

In the meantime, the avian influenza situation continues to evolve and not in a favorable direction. Influenza has continued to escalate in prevalence. The situation with regard to public health information generated on the federal level remains problematical.

Whole Health Highlights

- The Whole Health Commissioner position posting has been finalized and is now posted on our website. In the interim, our team remains committed to advancing our work and fulfilling our mission, ensuring continuity in our programs and services and advancement of our Strategic Plan. We appreciate the dedication of our staff and partners as we move forward during this period of transition.
- Many of our Cross-Functional Teams are approaching the conclusion of their current projects/deliverables, with most expected to complete their work by the end of this month. As we transition to the next iteration of Cross-Functional Teams (and Agile team) work, we are preparing for a structured handoff of findings and recommendations. Some teams will be finalizing their work and delivering actionable recommendations for a different, future team, while others will present the proposed next steps for their current team to tackle to Senior Leadership for consideration. This hand off process reflects our ongoing commitment to collaborative problem-solving and continuous improvement across Whole Health Strategic Planning initiatives.

Shared Topics Update

Strategic Planning/Merger

INTEGRATION:

Merge the department structures to become one organization and increase our ability to better serve our clients and community.

- We had our first All-Staff event of the year, held on Jan 29th. The theme of the day was collaboration, which we embedded into the agenda throughout the different sessions and activities of the day. We will continue digging into collaboration across the organization and will plan to transition over to a theme of customer-service partway through the year. We had the opportunity this year to partner with Cinemapolis as our morning venue for the Keynote Speaker, Claire Wardle!
- To deepen the work of our Strategic Plan we will also be initiating Agile Teams in 2025, which will work alongside and compliment the work of our Cross Functional Teams (CFTs). These Agile teams will be on shorter, more rapid and defined timelines with a focus on implementing CFT recommendations/findings that will ultimately save time, energy, and resources across the organization.

CULTURE:

Align the organization around our shared mission and values-based culture to create an empowered, engaged, and cohesive team.

- Our DEIB CFT is embarking on addressing our 2025 equity indicators as deliverables for 2025! We are excited to see the work of this team continue as they build on their successes from last year.
- EI #1: Cultural Alignment Assessment Evaluate how well Whole Health's policies, programs, and staff practices align with our Values-Based Culture to guide meaningful, long-term improvements.
- EI #2: Demographic Data Collection Toolkit Standardize data collection to improve accuracy, ensure equity in service provision, and identify disparities. This will include best practices, training materials, and reporting recommendations.

Highlights

Communicable Disease

NOTABLE COMMUNICABLE DISEASE INVESTIGATIONS, JANUARY 2025:

- Anaplasmosis 1 case: Case patient is a 82 yo co-infected with Lyme, not hospitalized
- **Campylobacter** 3 cases: One case is a young school aged pediatric patient with overnight stay in hospital and shared household between two counties, one case is a 28yo with travel related illness acquired in Peru and one case is a teen with a wound as the source of infection with no GI symptoms
- **Strep Group A Invasive** 1 case: Case patient is a 40 yo with substance use and was hospitalized for 3 days
- Varicella- 1 case: Case is a pediatric patient who is too young for vaccination

IMMUNIZATIONS

- Our January Imms Clinic vaccinated 10 children and 15 adults for a variety of vaccinations.
- 3 Homebound vaccinations were completed in January for Covid and Flu.

COMMUNITY EDUCATION

• Community Health Nurse Karen Whetzel provided a training on Perinatal Hepatitis B to CMC Birthplace staff on January 23rd. Topics covered included lab testing, treatment, Tompkins county data trends and the importance of the Hepatitis B birth dose.

Program Updates

SAFECARE PROGRAM

- Four families are currently enrolled in this program and receiving regular home visits. 8 SafeCare visits were completed in January.
- Senior Community Health Nurse Caryl Silberman is starting SafeCare coach training. Community Health Nurse Emily Baker will be starting SafeCare provider training in February. This will expand our capacity to support this program and handle increased referrals from DSS.

MOMS PLUS+

• Three MOMS PLUS+ nurses are continuing their CLC training and making home visits throughout January.

- Our MOMS PLUS+ nurses completed 76 home visits in January 2025 compared to 53 in December 2024!!
- There were 51 referrals made to the MOMS PLUS+ program in January 2025, up from 43 referrals made in December 2024.
- There were 23 new admissions to the MOMS PLUS+ program in January 2025, up from 15 new admissions in December 2024.
- There were 69 clients enrolled in the MOMS PLUS+ program in January 2025 compared to 66 in December 2024.

RABIES

• 15 rabies vaccines were administered to patients in the month of January. Exposures were from cats, bats, and dogs.

LEAD

- No changes to lead cases during month of January. 16 children in total are being followed for elevated blood lead levels.
- No new admissions/referrals for the months of January.

HIV AND COMMUNITY OUTREACH

- No HIV tests were done during January 2025.
- Our Community Health Nurse checked 11 blood pressures in January 2025 and made referrals to the CHW program and PPGNY.
- Topics discussed at Loaves and Fishes, Magnolia House and Asteri House included mental health and primary care access, medication management, STI screening, housing, pregnancy testing, food pantries, smoking as it relates to blood pressure, vaccines, Narcan and cancer screening.

WIC

- In January we served 542 individuals which is the highest number of people served in one month in four years.
- WIC is currently serving 87.80% of the target caseload of 1320.

- CHW Sarah Curless started seeing their first clients this month, in both HiP (Healthy Infants Partnership) and the CHW program.
- There is a vacant CHW Position after a PICHC CHW left this month for new opportunities.
- Community Action Board is meeting monthly. Projects include expanding doula training to more Black women in Tompkins County, facilitating another Sister Circle, facilitating conversation with medical community.

COMMUNITY HEALTH ASSESSMENT (CHA) & COMMUNITY HEALTH IMPROVEMENT PLAN (CHIP)

• Planning for Community Context Assessment, focused on qualitative data collection, with Cornell MPH and Civic Ensemble

- Community Status Assessment: Defining secondary data indicators, survey promotion and outreach
- Survey goal: 1200-1500 responses, representing all areas of the county

COMMUNICATIONS

- Wrap up of the Rural Health Institute's Harm Reduction Awareness Social Media Campaign, a 9-week effort to normalize harm reduction strategies, with increasing interest in community-wide Narcan training as the primary purpose of the campaign.

Highlights

Staff Training:

- EI Hub started live on October 15th state wide. There have been many training opportunities for all staff and support staff as processes have changed to meet the needs of the new system.
- Process for EI Hub has been finalized and the majority of the billing has gone through with less errors.

Program Updates

EARLY INTERVENTION

- SLP hired by the county has picked up children off the therapy needs list. The SLP had 31 visits a week so far with more potential each week as her caseload grows.
- The proposal for the reallocation of funds to keep 2 positions and to allow for current providers to receive a stipend per service rendered, including ongoing services and evaluations has been approved by the legislator. Contacts with all therapists have been completed and sent out for private providers and agencies to sign.
- The other provider position at the county is now filled with a SI Teacher position. Her start date is 2/3/25. She will be picking up the whole SI wait list soon and will be available to take on more as needed.
- Early Intervention experiencing wait lists for all specialties. Speech (26) Feeding (3), OT (1), PT (18), SI (19), SW (2)
- Referrals received January: 39
- EI has made efforts to make relationships with core teams outside of the county. We have established relationships with Liberty Post in Syracuse and have gotten slots for families to travel there for evaluations. We have also created another local eval team at the Groton Elementary with Liberty Post. Racker has agreed to have more core slots on Mondays and offer 2 additional core slots per week of PT/ST with an occasional OT/ST slot.
- Currently serving 186 active/qualified children in Early Intervention. 1 Total Child Find Cases


Highlights

C&C TOBACCO/CHUCK'S GAS MART, INC. ENFORCEMENT UPDATE:

On May 23, 2023, the Board adopted Resolution #22-0052 assigning 3 or more points to C&C Tobacco, which required EH to make a referral to the appropriate agencies for suspension of their license to sell lottery tickets and their registration to sell tobacco/vapor products. C&C filed and Article 78 petition with the NYS Supreme Court: Tompkins County, seeking to annul the Board's action. This resulted on June 8, 2023, in the Court issuing an Order to Show Cause and a Temporary Restraining Order to Tompkins County Whole Health preventing the referrals to other agencies. Tompkins County was successful in this case, and on December 12, 2024, the NYS Supreme Court confirmed the determination made by Tompkins County Whole Health and dismissed the petition made by legal counsel of C&C Tobacco.

Following the ruling, EH made a referral to NYSDOH to have license to sell lottery tickets and the registration to sell tobacco/vape products suspended. On January 31, 2025, the NYS Gaming Commission sent notice to C&C tobacco informing them that a temporary suspension of their license is effective immediately for 1 year. On February 7, 2025, the NYS Department of Taxation and Finance informed C&C Tobacco that their registration to sell tobacco products is suspended effective February 13, 2025, for one-year. TCEH will be conducting follow-up inspections to ensure compliance with the suspensions.

On December 13, 2024, in response to a complaint about untreated sewage on the ground, staff from Tompkins County Environmental Health (TCEH) made a site visit to the home at 15 Harbor Circle within Hanshaw Village mobile home park. During the visit our staff confirmed the presence of sewage and documented it in an inspection report that was then emailed to you. A compliance deadline of 7 days from the date of the inspection was provided in the report.

On December 24, 2023, TCEH staff returned to 15 Harbor CI to determine if the violation had been abated but could not make a determination because several inches of new snowfall covered the ground. During a reinspection on January 3, 2025, sewage was observed actively discharging to the ground surface.

The discharge of untreated sewage to the ground surface is a violation of both Article VI of the Tompkins County Sanitary Code (S-6.02[b]) and Part 17 of the New York State Sanitary Code (17.6[6]).

We have scheduled an office conference for January 28, 2025, at 9:30am, in the Environmental Health offices at 55 Brown Road, Ithaca, NY, during which we will discuss the enclosed Stipulation Agreement and Orders. This agreement is offered as an alternative to a formal administrative hearing.


