Call to Order

Chairman Pronti called the meeting to order at 8:36 a.m.

Introductions

Mr. Pronti welcomed Ms. Fiacco - ACCES-VR to the Board to succeed Mr. Lance who has retired.

Mr. Pronti announced Ms. Franzese will be the Chair for the One Stop Operations and Oversight Committee to succeed Mr. Bishop who has retired.

Board Action Items

Approval of the action items on the agenda were deferred to the May meeting due to lack of quorum.

Open Discussion - Ms. Mayforth, Director of Jefferson County

Ms. Mayforth presented to the full Board on Employers Resource Network - is a group of businesses in the community who invest in a shared Success Coach to support their employers. Ms. Mayforth reported that success coaches help to retain employer's workforce and help with the needs of employees.

Ms. Mayforth reported that Jefferson County has built a portfolio of resources that Coaches can use to address needs of employees such as childcare, transportation issues, housing, addiction, and mental health issues. The Coaches help them navigate agencies and organizations that can help with needs of employees.

Treasurers Report - March 2022

Ms. Iles reported that the March 2022 Financial reports are the 3rd quarter fiscal reports and will be reported to the Board on a quarterly basis.

Ms. Iles reported that the March 2022 financial report for the Workforce Development Board are on track except for a couple of expenditure lines. The Board wage and fringe lines will increase once the Deputy Director is hired.

Ms. Iles reported that the revenue for grant funding is getting back on track. The pandemic has hindered use of funds. Ms. Avila and Ms. Achilles is working with Ms. Mouillesseaux to move forward using the funds.

Ms. Iles reported that the March 2022 financial report for the Office of Employment and Training have a few areas of concern supportive services, tuition and participant wage and fringe. OET will see an increase due to supporting participants with tuition, car repairs, internet and increasing wages to meet living wage of \$15.32 an hour.

WDB Director Update

Ms. Avila reported that New York State unemployment rate is at 4.7% and Tompkins County is less than 3%.

Ms. Avila reported that the Deputy Director position on the County website has been extended. Ms. Avila will be reaching out to Board members to participate in the interview process in late May.

Ms. Avila reported that the Board Fiscal Monitoring with NYSDOL has concluded with 3 finding and all have been resolved.

Ms. Avila reported that the Board has not received WIOA 2022 draft allocations.

Ms. Avila reported that the Summer Youth Employment Program (SYEP) allocations have not been received and are waiting to move forward with contracts with Office of Employment and Training, Ithaca Youth Beauru, and Constant Connection Consulting.

Ms. Avila reported that the Board will be moving to the new office space at Tompkins Trust Company with IAED in May or June.

Ms. Avila reported that the Board retreat will be planned for September 2022.

Career Center Update

Ms. Mouillesseaux reported that the Communication Specialist has been hired and will start on May 2, 2022. This position will help promote programs, outreach on both the youth and adult programs.

Ms. Mouillesseaux reported that she is in the process of hiring a project assistant to help with Summer Youth Employment Program.

Ms. Mouillesseaux reported that the Career Center has seen an increase of participants that attend workshops since January. The resume workshop increased to 15 to 25 participants attending.

Ms. Mouillesseaux reported that New York State Department of Labor is working on an opening plan. NYSDOL is scheduling appointments to see customers and the Career Center is seeing customers by appointment outside the office.

Ms. Mouillesseaux reported that budgeting challenges of youth participant wage and fringe is due to youth eligibility for JobLink. When staff are working with youth they are coming up on barriers: involvement with the justice system, pregnant, homeless, foster care, disabilities, systemic barrier, and mental health issues. When staff are moving through the process with participants, they need to get resources to help with barriers before participants are job ready.

Committee Reports

Executive Committee

Mr. Pronti reported that the Executive Committee is working on items in the Board agenda for ratification.

Mr. Pronti reported that the Committee is having discussions around vacancies on the Board and potential candidates.

One Stop Operations and Oversight Committee

Ms. Avila welcomed Ms. Harrington to the One Stop Committee.

Ms. Avila reported that Ms. Franzese has accepted the position of Chair of the One Stop Operations and Oversight Committee.

Ms. Avila reported the Ms. Mouillesseaux will be presenting to the Committee on employer services at the Tuesday, May 10th meeting.

Youth Oversight Committee

Ms. Shanks-Booth reported the Committee is working on contract negotiations for 2022 Summer Youth Employment Program.

Ms. Shanks-Booth reported that the Committee is making effort this year to bring more operators to the table and increase the outreach and diversity of programs so all eligible youth in the county have the opportunity and desire to participate.

Ms. Shanks-Booth reported that TCAT transportation will be available for free for 17 and under.

Governance and Membership Committee

Ms. Babuka reported the Governance Committee met Monday, April 25, 2022.

Ms. Babuka reported the Committee is discussing potential candidates to fill vacant positions and reaching out to members with expiring terms for reappointment.

Ms. Babuka reported the Committee is discussing orientation process for new members joining the Board.

Services to Individuals with Disabilities

Ms. Avila reported that the Committee had a meeting Tuesday, April 12, 2022 and will meet every other month. Members of this Committee are predominately from local organizations that provide services to people with disabilities. Ms. Avila is interested in more business partners to join. The Committee's next meeting is Tuesday, June 14, 2022.

The meeting adjourned at 9:43 a.m.

A. What are the Mission and goals of your organization?

Tompkins Workforce New York is a coordinated, employment and training service center for individuals, job seekers, and businesses in Tompkins County. Workforce New York consists of eleven local partners that provide guidance, resources and services to assist job seekers with job search functions, job and career transitions, training and support in securing resources available to address systemic barriers they may be facing. Simultaneously, Workforce New York and its partners serve businesses by hosting and promoting recruitment events, matching employers with qualified candidates for open positions, and developing strategies and education for reimagining the workplace to ensure business success and employee retention in the post-pandemic era. Tompkins Workforce proudly strives to make Tompkins County a strong, economic community that intentionally creates opportunities and addresses issues of equity and access through workforce initiatives.

Tompkins Workforce provides individualized training funding for customers meeting specific eligibility criteria; adults, dislocated workers and youth/young adults. Resources and funding can be applied to various training and education programs to improve skills that increase the marketability and competitiveness of the job seeker. Job LINK, the youth/young adult program provides comprehensive employment training, work readiness, youth development and educational opportunities designed to prepare youth/young adults ages 14-24 for the workforce.

Attachment A

ANTI-DISCRIMINATION CLAUSE

During the performance of this contract, (the contractor) hereby agrees as follows:

(a) The contractor will not discriminate against any employee or applicant for employment for any of the following: race, creed, color, ethnicity, military service, marital status, disability, sexual preference, perceived gender, national origin, or status as an ex-offender, and will take affirmative action to insure that they are afforded equal employment opportunities without discrimination. Such action shall be taken with reference, but not be limited, to: recruitment, employment, job assignment, promotion, upgrading, demotion, transfer, layoff or termination, rates of pay or other forms of compensation, and selection for training or retraining, including apprenticeship and on-the-job training.

(b) The contractor will send to each labor union or representative of workers with which he has or is bound by a collective bargaining or other agreement or understanding, a notice, to be provided by the State Commissioner for Human Rights, advising such labor union or representative of the contractor's agreement under clauses (a) through (f) hereinafter called "non-discrimination clauses". If the contractor was directed to do so by the contracting agency as part of the bid or negotiation of this contract, the contractor shall request such labor union or representative to furnish him with a written statement that such labor union or representative either will affirmatively cooperate, within the limits of its legal and contractual authority, in the implementation of the policy and provisions of these non-discrimination clauses or that it consents and agrees that recruitment, employment and the terms and conditions of employment under this contract shall be in accordance with the purposes and provisions of these non-discrimination clauses. If such labor union or representative fails or refuses to comply with such a request that it furnish such a statement, the contractor shall promptly notify the State Commission for Human Rights of such failure or refusal.

(c) The contractor will post and keep posted in conspicuous places, available to employees and applicants for employment, notices to be provided by the State Commission for Human Rights setting forth the substance of the provisions of clauses (a) and (b) and such provisions of the State's and local Tompkins County Laws against discrimination as the State Commission for Human Rights shall determine.

(d) The contractor will state, in all solicitations or advertisements for employees placed by or on behalf of the contractor, that all qualified applicants will be afforded equal employment opportunities without discrimination because of race, creed, color or national origin.

(e) The contractor will comply with the provisions of Sections 291-299 of the Executive Law and the Civil Rights Law, will furnish all information and reports deemed necessary by the State Commission for Human Rights under these non-discrimination clauses and such sections of the Executive Law, and will permit access to his books, records and accounts by the State Commission for Human Rights, the Attorney General and the Industrial Commissioner for purposes of investigation to ascertain compliance with these non-discrimination clauses and such sections of the Executive Law and Civil Rights Law.

(f) This contract may be forthwith cancelled, terminated or suspended, in whole or in part, by the contracting agency upon the basis of a finding made by the State Commission for Human Rights that the Contractor may be declared ineligible for future contracts made by or on behalf of the State or a public authority or agency of the State, until he satisfies the State Commission for Human Rights that he has established and is carrying out a program in conformity with the provisions of these non-discrimination clauses. Such finding shall be made by the State Commission for Human Rights after conciliation efforts by the Commission have failed to achieve compliance with these non-discrimination clauses and after a verified complaint has been filed with the Commission, notice thereof has been given to the Contractor and opportunity has been afforded him to be heard publicly **Attachment A**

before three members of the Commission. Such sanctions may be imposed and remedies invoked independently of or in addition to sanctions and remedies otherwise provided by law. The Contractor will

include the provisions of clauses (a) through (f) in every subcontract or purchase order in such a manner that such provisions be performed within the State of New York. The Contractor will take such action in enforcing such provisions of such subcontract or purchase order as the contracting agency may direct, including sanctions or remedies for non-compliance. If the Contractor becomes involved in or is threatened with litigation with a subcontractor or vendor as a result of such direction by the contracting agency, the Contractor shall promptly so notify the Attorney General, requesting him to intervene and protect the interests of the State of New York.



Attachment A Contractor's Representation—Livable Wage Policy

Livable Wage Policy: By policy, Tompkins County must “consider the wage levels and benefits, particularly health care, provided by contractors when awarding bids or negotiating contracts, and to encourage the payment of livable wages whenever practical and reasonable.”

Paying the living wage rate to all employees directly involved in providing the contracted County service is not mandatory. However, the attainment of a broadly-applied living wage is a County goal and is therefore an important consideration applied by the County when reviewing contract qualifications

The Current Living Wage: The Living Wage in Tompkins County is computed by the Alternatives Federal Credit Union and is currently \$14.28 per hour if the employer contributes at least half the cost of an employee's health insurance/benefit cost and \$15.37 per hour if the employer does not make such a contribution. The rate will be adjusted again in May 2021.

Requirement of All Contractors: As a part of its proposal or contract representations, a prospective service contractor must advise the County whether it will pay the AFCU livable wage rate to all Covered Employees directly involved in the provision of the contracted service, including employees of any subcontractor engaged to assist in providing the service.

Additionally, contractors are asked to estimate the number of employees who will be directly involved in the provision of the contracted service. If not all employees are going to be paid the Living Wage, contractors are asked to estimate how many full-time, and how many part-time, covered employees will NOT be paid the living wage.

Covered Employees include all full- and part-time employees, other than those Excluded Employees described below, who are directly involved in the provision of the contracted service, including employees of sub-contractors engaged to assist in providing the service.

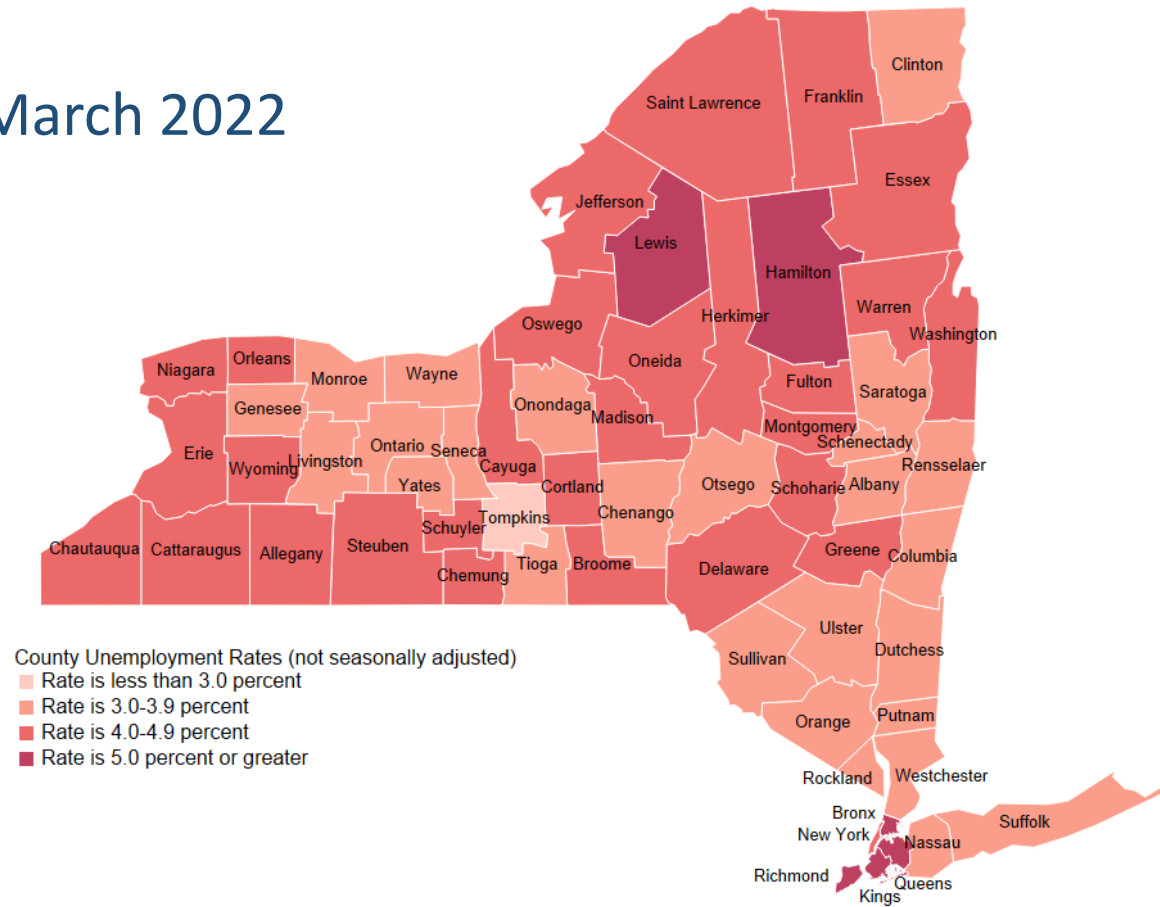

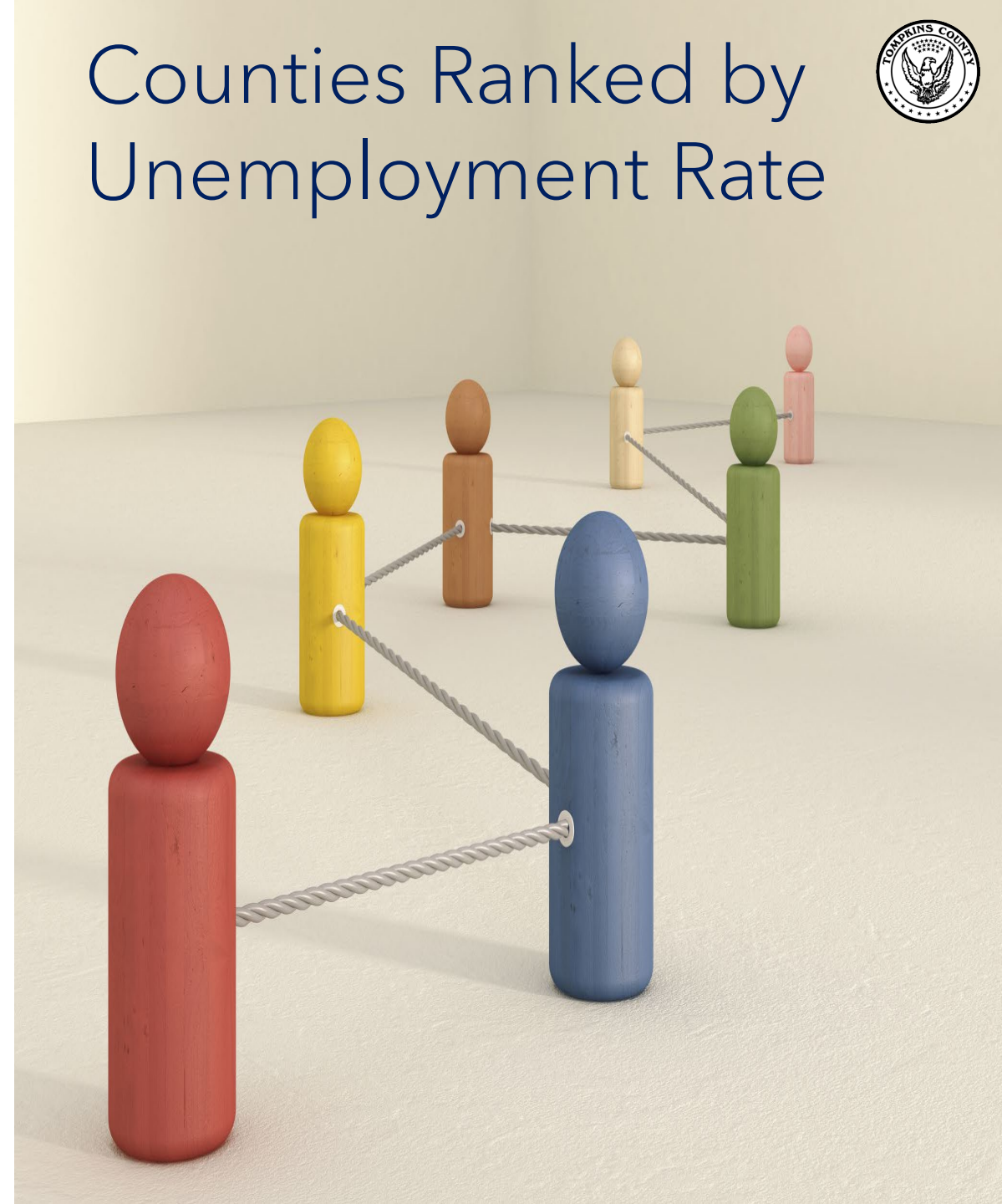
