#### Discussion

#### Downtown Ithaca Alliance (DIA) - Presentation

Ms. Rohrer, Chief Executive Officer, Downtown Ithaca Alliance discussed with the Committee what her role is with Downtown Ithaca Alliance. Ms. Rohrer role is to focus on downtown/neighborhood revitalization and economic development. Ms. Rohrer works with four part-time ambassadors that have 22 blocks of the City of Ithaca and Business improvement district. Their motto is Clean, Green and Welcoming.

Mr. Sponn reported Tompkins Weekly highlighted the SYEP program this summer with a cover story.



## Pre-Employment Transition Services



Criteria for participation in Pre- Employment Transition Services (Pre-ETS):

- Student with a documented disability, AND
- Is enrolled in a secondary, postsecondary, or other recognized educational program, AND
- Is not younger than 14 years of age, AND
- Is not older than 22 years of age when enrolled in secondary education, OR, is not older than 52 years of 200
  - Is not older than of 21 years of age when enrolled in post-secondary education



## Pre-Employment Transition Services through ACCES VR

Pre-Employment Transition Services (Pre-ETS) are a specific category of services defined in the Workplace Innovation and Opportunity Act (WIOA), signed into federal law July 22, 2014. Pre-ETS are specifically designed for students with disabilities between the ages 14-22. With WIOA emphasis on early outreach to students with disabilities, it is expected that students who are age 14 and/or more than two years prior to anticipated exit from high school will receive Pre-ETS services without formal application to ACCES-VR.

#### Job Exploration Counseling

- Vocational Interest Assessments
- Development of personal work values
- Identifying career awareness and career pathways
- Exploration of Labor Market/in-demand occupations
- Providing information about nontraditional employment options, including military, entrepreneurship, and selfemployment
- Developing opportunities for career speakers and informational interviews/attending career fairs



Workplace Readiness Training to Develop Social Skills and Independent Living

- Resume Development
- Interview Skills Preparation
- Expectations of Employers
- Teamwork Attitude Awareness
- Financial Literacy Introduction
- Developing professional communications such as email addresses and voice messages
- Understanding the value of soft skills and applying the skills in the workplace
- Reviewing personal hygiene and grooming expectations in the workplace
- Understanding appropriate clothing across workplace environments and activities (e.g., interview attire vs. employer dress code)



#### Post-Secondary Options Counseling

- Explore types of academic, vocational, and occupational training needed to succeed in the workplace: i.e. Community Colleges, Universities, Apprenticeships
- Postsecondary opportunities associated with a career field or comprehensive transition pathways
- Advise on college/vocational training applications and admissions processes, and completing the FAFSA
- Connect to the disability support services that would be available through other state agencies such as OPWDD or OMH
- Identifying and accessing accommodations
- Individualized student strategies to support a seamless transition from high school to postsecondary education, including:



#### Instructions in Self Advocacy

- Self awareness/understanding the nature of one's disability
- Decision Making/Problem Solving
- Identifying/requesting needed accommodations
- Connecting with peers/natural supports
- Connecting with services available in the community and support to apply
- Identifying intrinsic strengths and abilities
- Understanding rights and responsibilities
- How to request and accept help
- Taking leadership in support plans
- Ability to monitor progress
- Positive Self talk



### Who is Eligible for Pre-ETS?

- Has a documented disability, AND
- Is enrolled in a secondary, post-secondary, or other recognized educational program (e.g., home school, high school equivalency programs, college or a vocational technical program), AND
- Is not younger than 14 years of age, AND
- Is not older than 22 years of age or reached their 23<sup>rd</sup> birthday when enrolled in secondary education under Individuals with Disabilities Education Act (IDEA), OR
- Is not older than of 21 years of age or reached their 22<sup>nd</sup> birthday when enrolled in post-secondary education

# How Does a Student with a Disability Receive Pre-ETS?

SWDs may receive Pre-ETS in one of two ways:

- **Potentially eligible (PE) for ACCES-VR services** and receive Pre-ETS without applying for ACCES-VR services.
- Have applied for and been determined eligible by ACCES-VR and receive Pre-ETS as a service documented on their Individualized Plan for Employment (IPE).

# Where Can a Student Receive Pre ETS services?

- Staff can meet students at their school during a free period
- Staff can meet students at a local library
- Staff can meet students at our own agency office
- Staff can meet students at partner agencies
