# **COMMITTEE UPDATES**

# YOUTH OVERSIGHT

Ms. Avila reported the 2022 Summer Youth Employment will be contracting with 3 organizations: Office of Employment and Training, Ithaca Youth Bureau, and Conscious Connection Consulting LLC.

Ms. Avila reported the Board has not received the allocation for the 2022 Summer Youth Employment. The Board is estimating that we will receive approximately the amount that we received in 2021.

# Fiscal Budget for June Approval

Ms. Avila reported that Ms. Achilles is working on the budget number and the Board is not meeting the funds to support all 4 staff. Ms. Avila reported that the Board will have to ask County to support the funding to move forward with the hiring of the Deputy Director.

Ms. Achilles will work on a preliminary budget for the Committee to review at the June  $7^{\text{th}}$  meeting.

# **One-Stop System Operator**

Ms. Avila is working on contracts for the One-stop System Operator to be approved at the full Board meeting Tuesday, May 24<sup>th</sup> to execute on July 1<sup>st</sup>.

# Workforce Board Meeting, Next Industry Briefing

The Executive Committee discussed what Industry Briefing that will be at the Board meeting Tuesday, May 24<sup>th</sup>.

Mr. Matteson would like to have data reporting 6 months, 12 months, and 18 months on what sector are being hit the hardest through the pandemic. What sectors will have higher needs and what sectors will have a better outcome.
