#### Call to Order

#### Approval of Minutes - May 10, 2022

#### Financial Report - Adult & Dislocated Worker

Ms. Achilles reported to the Committee data on the comparison of WIOA Adult and Dislocated Worker allocations to expenditures on participants from July 1, 2021 to May 30, 2022. Ms. Achilles reported Office of Employment and Training expended 77% compared to 91.67% that OET should be at for this time of year.

Ms. Achilles reported that OET budgeted \$158,000.00 in program expenses for participants and will only have \$58,000.00 left for the next 6 months. We'll need to watch budget and move forward accordingly.

Ms. Franzese would like to see data on number of participants and services provided. Ms. Mouillesseaux will provide information moving forward.

#### Workplan

#### **OET Update**

- Ms. Mouillesseaux reported that Ms. Stanley is the DCR for the new NYSCION funding that we have received and will be submitting the 1st quarter report.
- Ms. Mouillesseaux reported that OET staff are participating in the Green Job Career Expo. Working with TST BOCES and Cornell Cooperative Extension, URO, and ReUse on Wednesday, July 27, 2022 4-6 pm at TST BOCES.
- Ms. Mouillesseaux reported OET staff are participating in Tompkins County World of Skill Job Fair Wednesday, August 31, 2022 9-12 pm at Hotel Ithaca.
- Ms. Mouillesseaux reported that there is a wait list for funding for Adult and Dislocated Workers of 32 participants.
- Ms. Mouillesseaux reported that the Career Center is in a soft opening and hiring for a front desk staff person. Ms. Mouillesseaux is working on hiring a WIOA youth for 20 hours and A42D for the other 20 hours. A42D is a program where adult are moving back into the workplace.

#### NYDOL Update

- Mr. Cerasaro reported to the Committee that NYSDOL and OET that received notification in June do a soft opening.
- Mr. Cerasaro reported that NYSDOL have worked with 34 participants on unemployment claim issues and 19 in person customers. Since the soft opening the Career Center has serves 72 walk-ins. Mr. Cerasaro reported that UI claims are not the majority of the walk-in customers.
  - Mr. Cerasaro reported that NYDOL is working to hire 3 staff members.
- Mr. Cerasaro reported NYSDOL is working to have in-person workshops in the near future once fully staffed. There will always be a virtual options to all workshops.
- Mr. Cerasaro reported the there is a Regional Job Fair that is held virtually every 3<sup>rd</sup> Thursday of the month.

- Ms. Lovelace reported to the Committee data on how many participants that the Career Center has served. Ms. Lovelace reported that the numbers are increasing and will hopefully return to pre pandemic numbers.




