Discretionary permission is granted to Permittee in accordance with the following conditions and restrictions:

- a) County Superintendent of Highways reserves the right to revoke or annul this permit at any time.
- b) This permit must be carried on the vehicle at all times.
- c) NYSDOT Divisible Load Weight Permit (page 1) must be submitted for each unit, with this permit application.
- d) All highways are subject to monitoring and evaluation for deterioration. Adverse weather conditions may/will affect highway stability and accelerate highway deterioration. Deteriorating highway conditions may result in a highway or section thereof being restricted from overweight hauling as required.
- e) Permittees routing more than 20 cumulative overweight loads per day on County highways shall provide a minimum two (2) days advance notice. Email detailed trip information (dates, road, number of trips, etc.) to the County Highway Department at HighwayPermits@tompkins-co.org
- f) All vehicles shall comply with NYSDOT Permit restrictions when traveling on local roads in Tompkins County.
