2023 Outlook

A quick look forward before the retrospective: The year 2023 looks to be an engaging and collaborative one for the Environmental Management Council (EMC). Later this fall, Tompkins County will host the NYS Association of Conservation Commissions (NYSACC) annual conference with the EMC serving as lead organizer. This will engage the EMC with municipal conservation advisory commissions and boards, organizations, nonprofits, and community members both locally and from across New York State.

2022 Fall Outreach Event

A highlight for the EMC in 2022 was our hybrid fall outreach event: *Flooding in Tompkins County? Are you Ready? Let's talk about it.*

This remote and in-person event focused on reaching members of the public who were not already engaged with environmental groups. We had 26 people join remotely and equally that many gather in person at the Tompkins County Public Library. Many of those attending were new faces. Our panel of presenters included:

- Doug Barnes, Tompkins Co. Environmental Health Division Restoring and Testing Your Private Well After a Flood

After the panel of presenters, followed by ample Q&A time, participants moved into small group discussion. Many attendees were particularly concerned with the National Flood Insurance Program and the updated FEMA maps. This information was shared with County Planning & Sustainability Department staff for future collaboration on outreach efforts.

Strengthening Partner Ties Across the State

In 2022, the EMC continued growing our connection to the New York State Association of Conservation Commissions (which also now recognizes EMCs as member organizations). Members attended the virtual NYSACC Conference on the Environment held in October. Long-time EMC member Stephen Nicholson has joined the NYSACC board of directors and is providing Tompkins County with a link to the statewide agency.

2022 EMC Committees

Every January, as part of its annual organizational meeting, the EMC forms committees to focus its efforts on addressing environmental issues relevant to its mission and that of the County Legislature. Members, both voting and associate, serve on at least one committee. Each committee is tasked with specific goals for the year. The following committees met in 2022:

Education & Outreach Committee

The Education & Outreach Committee continued to grow the Tompkins Green Scene newsletter, migrating production to the MailChimp platform for sign-up and distribution ease. This biweekly newsletter compiles local environmental events, news, activities, and notable items into one easily accessible email. Additionally, the Green Scene includes NYS DEC Environmental Notice Bulletins and wastewater discharge alerts related to Tompkins County. It is a valuable resource for anyone looking to stay in the know about events or news in the vast Tompkins County environmental scene. The Education & Outreach Committee also connected with partners at the neighboring Broome County EMC through a presentation given by committee chair Cait Darfler. Cait spoke about the current work of the Tompkins County EMC, sharing both challenges and successes, and engaged in dialogue with colleagues from Broome County.

Unique Natural Areas (UNA) Committee

The UNA Committee met monthly by Zoom and for an in-person fieldtrip on July 18. The field-trip was led by committee member and botanist Robert Wesley to Durfee Hill Oak Woods, UNA-173, in hopes of finding the rare grass *Poa sylvestris* (woodland bluegrass). Unfortunately, the woodland bluegrass was not seen during this trip.



UNA consultants Karen Edelstein and Robert Wesley continued the UNA Inventory updating process, adding new wetlands data and inserting justification of boundary change details into the first two batches of UNA revisions. The remaining UNA updates will be completed later this year (2023). Mr. Wesley performed site visits to UNA-6 Devils Den, UNA-16 Sanguisorba Swamp, UNA-173 Durfee Hill Oak Woods, and UNA-180 Caroline Pinnacles.

The UNA Committee submitted comments for General Municipal Law Section 239-l, -m, and -n County Environmental Reviews related to five projects.

Climate Adaptation Committee

The Climate Adaptation Committee met monthly continuing to gather and sort information on flooding risks in Tompkins County. The work was grounded in our prior involvement in the Tompkins County Hazard Mitigation Plan – 2021 Update, our concerns about its limitations, and how they might be addressed.

The committee discussed at length how best to interpret the forthcoming preliminary FEMA flood maps of the County and to inform community members about the map changes. The Climate Adaptation Committee and EMC as a whole will work with Planning & Sustainability Department staff when the FEMA flood maps are released to support the County's public education efforts.

Finally, Climate Adaptation and Education & Outreach Committee members worked together in the planning, publicity, and execution of the EMC's public information event on flooding in Tompkins County.

A Little Background

Environmental Management Councils are voluntary advisory boards appointed by their County governments throughout New York. EMCs were established under Article 47 of the New York State Environmental Conservation Law passed in 1970.

The Tompkins County EMC was one of the first EMCs in the state, established by Resolution No. 103 of the Tompkins County Board of Representatives in 1971. The EMC was added to the County's Charter in 2003.
