**Call to Order:** Dr. Moylan called the regular meeting of the Board of Health (BOH) to order at 12:01 p.m.

**Privilege of the Floor:** David Shanks from CoreLife Eatery was present. He addressed the Board, stating that he has had a problem for 2 years keeping proteins at the right temperature. He thanked the Board for allowing a variance last year. He stated that they have since gone to cook to order out of respect for the Health Department's request. This will be rolled out to all 52 eateries. He also addressed the other issues that needed to be fixed. He also stated that he is the District Manager, not the owner. He provided the Board with a copy of his receipt and his business card.

Dan Galusha, executive chef, and Cathy Hart, general manager, from Marriott were present. Mr. Galusha addressed the Board, stating he was embarrassed for the infraction but assured the Board that they are keeping up with their logs and apologized to the Board.

**Approval of January 22, 2019 Minutes:** Dr. Evelyn moved to approve the minutes of the January 22, 2019 meeting as written; seconded by Ms. Morgan. The vote to approve the minutes as written: Unanimous approval.

**Introductions:** Jason Molino, Tompkins County Administrator, was present to meet Board members and to speak about the process for evaluating the Public Health/Mental Health joint leadership model.

County Administrator's Remarks on the Public Health/Mental Health Joint **Leadership Model**: Mr. Molino reviewed the memo that was disbursed to the Board of Health and the Community Services Board earlier in March. He invited someone from the Board, as well as the CSB, to assist in evaluating the Joint Leadership Model that has entered its 4<sup>th</sup> year. Mr. Molino stated that there would be multiple parts of reviewing this, going forward, with the first part being taking a look at things from the Mental Health point of view: Client care perspective, community care perspective and the business case model of it. He believes that Mr. Kruppa would be most valuable at this stage of reviewing the Mental Health perspective but thereafter removing Mr. Kruppa from that process. Mr. Molino went on to state that they would likely interview staff from both departments. He discussed the possibility of a staff survey being done again there was one done 3-4 years ago. Client satisfaction survey in the MH side – should those be reviewed, why or why not? Looking to set up a meeting in mid to late April for the task force responsible for reviewing this process with a hope to bring a recommendation to the legislature in November 2019. Mr. McLaughlin asked about the presentation to the legislature in November. Mr. Molino clarified stating that they are hoping to wrap up their review by October with the presentation to the legislature in November. Mr. McLaughlin then asked about the task force meetings and the time dedicated it would entail. Mr. Molino stated that it would likely be 2 meetings per month at approximately 2-3 hours per meeting, with the 1<sup>st</sup> meeting being a planning meeting is important to best capture the interests of the two Boards. Dr. Moylan asked a question regarding legal clarifications between the two Boards. Mr. Molino stated that Jonathan Wood would be involved in the legal portion of the review. Mr. McLaughlin clarified that this is not a review of Mr. Kruppa but a review of the position and stressed the importance for the comfort level of people being able to share their thoughts without ramifications. Mr. Molino stressed confidentiality being of the utmost importance and that any updates brought to the Boards would be broad and not detailed. Dr. Moylan asked if anyone would like to volunteer for the task force; Ms. Morgan volunteered as primary representative with Mr. McLaughlin being the second. Dr. Evelyn as Vice President of the BOH will be the third representative. Mr. Molino stated that he would be in touch to set up the first meeting.

**Financial Summary:** Mr. Kruppa provided a summary of the Financial Summary within the packets provided to the BOH, as Ms. Grinnell Crosby was absent today. He stated that this is the last period for 2018, stating that we are under on everything – expenses, revenues and local share. Mr. Kruppa believes that the budget is going to end up well for us. 2019 is in month two so there is not much to report. Mr. Kruppa stated that the Healthy Neighborhoods program is a grant and Tompkins had applied for another 5-year cycle. There was an issue at the state level with this, but they did grant a one-year extension with needing to re-apply next cycle.

**Administration Report:** Mr. Kruppa reported the advocacy efforts at the State level as well as the population health summit. Both went well. There is a lot of attention from Public Health coming for both those avenues, whether it's the recreational marijuana legalization to looking at Population Health for communities and bringing new partners to the table.

• Mr. Kruppa stated that we have a piece of action to address. We have a physician to fill the vacant physician position on the Board. The Nominating Committee met with Dr. Dhundale, the applicant, and they have the recommendation. Ms. Black recommended Dr. Melissa Dhundale for the BOH, Dr. Moylan seconded. Mr. McLaughlin asked about her connections to the Board. Ms. Black stated that Dr. Dhundale served in the Peace Corps, she is a pediatrician and also works at Ithaca College. She is also the medical director for the Ithaca City School district. Dr. Evelyn stated that Dr. Dhundale has a strong interest in mental health services in Tompkins County. Dr. Moylan called for a vote of approval; vote was unanimous. Mr. Kruppa stated that she should be seated by our next Board meeting.

## **Health Promotion Program Report:** Ms. Hillson reported:

- An event was held last Friday (Blueprint for Health Equity) on 3/22/19. It was well attended. It took place at Green Star. Ms. Black provided a welcome to the event.
- The community health survey has gotten a very good response so far. There have been over 1,000 responses to the survey with about 900 people going through the whole survey, providing their responses.

**Medical Director's Report:** Dr. Klepack was open to questions on his report. There were no questions asked.

**Division for Community Health Report:** Ms. Bishop had nothing to add to her written report.

**Children with Special Care Needs Report:** Ms. Thomas had nothing to add to her written report.

• CSCN team has gone live with their software and it is going well.

**County Attorney's Report:** Mr. Wood had nothing to report.

## **Environmental Health Report:**

- Ms. Cameron stated that they have hired a public health technician and stated they are fully staffed now.
- Inspection reports are now attached to the draft/resolutions to provide more information to Board members.

**Report on the Community Services Board (CSB) Meeting:** Mr. Kruppa provided a brief update on the March meeting. Stated that Ms. Amie Hendrix, Deputy County

Administrator, was present and provided an update on the dual role for the Public Health and Mental Hole role. The subcommittees are beginning their State Priority Plans for 2020. Transportation and housing remain at the top of the lists for priorities, as well as staffing, in the sense of being able to adequately pay those in the field.

Resolution #EH-ENF-18-0050 – Moe's Southwest Grill, C-Ithaca, Violation of Subpart 14-1 of the New York State Sanitary Code (Food): Dr. Evelyn moved to accept the resolution with the penalty due date amendment; seconded by Ms. Morgan.

Ms. Cameron explained that she would like to change the penalty due date to May 15, 2019. This was a hot holding repeat violation for Moe's.

The vote to accept the resolution as amended carried unanimously.

Resolution #EH-ENF-18-0051 – Mix Social Dining, C-Ithaca, Violation of Subpart 14-1 of the New York State Sanitary Code (Food): Ms. Cameron explained that she would like to change the penalty due date to May 15, 2019. This was a temperature violation (refrigerated storage, above temperature).

Dr. Koppel moved to accept the resolution with the penalty due date amendment; seconded by Dr. Evelyn; and carried unanimously.

Resolution #EH-ENF-18-0052 – Ithaca Marriott FSE, C-Ithaca, Violation of Subpart 14-1 of the New York State Sanitary Code (Food): Ms. Cameron explained that she would like to change the penalty due date to May 15, 2019. This was a cold holding violation at Ithaca Marriott.

Dr. Evelyn moved to accept the resolution as amended; seconded by Ms. Morgan; and carried unanimously.

Resolution #EH-ENF-19-0002 – Fat Jack's BBQ, C-Ithaca, Violation of Subpart 14-1 of the New York State Sanitary Code (Food): Ms. Cameron explained that she would like to change the penalty due date to May 15, 2019. Ms. Cameron explained that the restaurant was operating without a permit but had submitted the paperwork except for Worker's Compensation. They had operated without the permit but submitted the required paperwork on the same day as the inspection. The permit was issued later that day.

Ms. Morgan moved to accept the resolution as amended; seconded by Dr. Koppel; and carried unanimously.

Resolution #EH-ENF-19-0003 – Casper's, V-Groton, Violations of BOH Orders #EH-ENF-18-0009 and of Subpart 14-1 of the New York State Sanitary Code (Food): Ms. Cameron explained that she would like to change the penalty due date to May 15, 2019. Restaurant was observed operating without a permit.

Dr. Koppel moved to accept the resolution as amended; seconded by Ms. Morgan; and carried unanimously.

Resolution #EH-ENF-19-0004 – CoreLife Eatery, C-Ithaca, Violations of BOH Orders #EH-ENF-18-0016 and of Subpart 14-1 of the New York State Sanitary Code (Food): Ms. Cameron explained that she would like to change the penalty due date

to May 15, 2019. The district manager presented a summary of the situation to the Board earlier in the meeting, stating that they are changing their ordering procedure and have repaired equipment (receipt provided).

Dr. Koppel moved to accept the resolution as amended; seconded by Ms. Black; and carried unanimously.

Resolution #EH-ENF-19-0007 – Easy Wok Restaurant, V-Lansing, Violation of Subpart 14-1 of New York State Sanitary Code (Food): Ms. Cameron stated that this was a temperature control matter.

Dr. Evelyn moved to accept the resolution as written; seconded by Ms. Morgan; and carried unanimously.

Tompkins County Health Department Request for Discretion to Waive OWTS Replacement Fees/Review of Modifications to 2019 Fee Schedule: Asking for discretion about OWTS fees and local sanitation code.

Dr. Koppel moved to approve Tompkins County Health Department's request for discretion to waive OWTS replacement fees; seconded by Dr. Evelyn; and carried unanimously.

## **HIGHLIGHTS**

News about NYSDOH grant funding, the Healthy Neighborhoods Program (HNP) grant, which was set to end 3/31/19, and for which an RFA was submitted last November, was extended for another year, and a new RFA must be submitted. Also, the Advancing Tobacco Free Communities grant, RFA submitted in January, was awarded for a 5 year period. The Cortland County Health Department holds the grant and TCHD subcontracts for a 20 hour staff person, same as the last 5 years.

The Community Health Survey was open throughout March and the first 2 weeks of April. Following is an early peek at some results:

- Total surveys started: 1,258. About 1,000-1,050 surveys had most questions answered.
- The 3 most cited factors that create a Healthy Community: Affordable housing, Good Paying jobs, Affordable health care.
- The 2 most cited barriers to maintaining or improving health: Time, Cost.
- 33% responded that they or a family member had dealt with a substance use disorder.
- 22% responded that their neighborhood was fair or poor as a place for children to play outdoors
- 27% responded that their neighborhood was fair or poor as a place for adults to walk and be physically active.



## Medical Director's Report Board of Health April 2019

## Influenza:

The latest report, as of March 30<sup>th</sup>, shows somewhat of a decrease in laboratory confirmed influenza, but clinical activity is still being reported as widespread throughout the State. This is slightly later that what I would anticipate for widespread activity (although it does occasionally go into April and some rare times even into May). So far this year there have been a total of 6 Pediatric Influenza deaths. Hospitalizations decreased 20% over the previous week of reporting and the percent of patient visits with influenza like illness dropped below the regional baseline. Hopefully these are indications that the virus is tapering off.

## **Immunizations and Community Immunity:**

With the number of Measles cases rising Nationwide and in New York in particular, I drafted a letter to the editor on the subject of "Community Immunity". This is the concept that if enough people are immunized against a communicable, vaccine preventable, infectious disease, then the spread of that disease can be controlled within the community. Typically, the number 95% is used as the percentage of persons that need to be vaccinated. When large or small subgroups of a population fall below the protective level of 95%, those subgroups are at risk of transmission not only within their particular subgroup, but also for the unimmunized or inadequately immunized people outside of their subgroup. This is what has transpired in Rockland County, NY and localities nationwide. Community Immunity is one of the factors that forms the justification for laws requiring up to date immunizations to be able to attend public school.

My letter made two points. One that Community Immunity is a real dynamic as evidenced by the spread of Measles in the subgroups in which it has been transmitted. The Second point was that Community Immunity protects individuals who cannot be immunized due to medical problems.

Also, with regard to immunizations, I attended the Immunization Coalition Meeting on April 2<sup>nd</sup>. The Coalition refined further its Mission and Vision Statements and in addition discussed further promoting the concept of Community Immunity within the region and the normalization of immunization while helping to expose the misinformation about vaccinations as being untrue.

## Other Activities:

Reviewed further materials on Opioids and other data on THC (tetrahydrocannabinol) and issues related to the chemical and driving safety. Regarding the latter, there is an excellent study from about a year ago looking at the trends in opioid use and traffic accidents and fatalities. Such analyses are a tricky business because of the number of variables that need to be taken into account. The Authors in this study created a model control group to compare the trends pre and

post legalization of THC and also compare them to projections of what would be the case if legalization had not happened. (Due to the prevalence of THC in the states in which the studies were conducted (Colorado & Washington) rising levels of usage and traffic related THC incidents were present both in actual experience and in the projections). The bottom line was when the actual experience post legalization, is compared to the model control group, no statistical difference was found. I include two references which you may be interested in looking into at regarding this issue.

#### Other Activities

I also several Rabies potential exposures which arose during the month which warranted post exposure prophylaxis and received several evaluation forms for Tompkins County employees for respirator fit test evaluation forms.

I also participated in a Performance Review of my work here at the Health Department. This used the relatively new Performance Evaluation Form which has recently been developed. I thought the forms were very constructive and created a meaningful discussion. The form is being used across the Health Department

I also participated in the quarterly meeting of the Community Health Quality and Assurance Committee which monitors the activities of CHS and WIC and particularly focuses on Medicaid Obstetrical Maternal Services (MOMS) (soon to change its name to more accurately reflect its mission) and our lead program as well as others.

## **HEPATITIS A:** Changing recommendations with regard to the vaccination.

Due to widespread outbreaks of Hepatitis A across the United States associated with drug use and homelessness, the recommendation as to who should receive Hepatitis A vaccine has changed. New indications are: providing Hepatitis A vaccine to people who use drugs whether by injection or non-injection, people who are homeless, men who have sex with men, and people with chronic liver disease, cirrhosis, Hepatitis B or C. Also included in this recommendation are people who are or were recently incarcerated (many of whom fall into one of the groups mentioned). A copy of the recommendation has been forwarded to the Tompkins County Jail Medical Services as well as provided to area practitioners.

## Karen Bishop, Director of Community Health March 2019 Report

#### Administration -

- Continued review of documentation forms built in the beta HER and began creating the chart structure in the system.
- Participated on twice weekly conference calls with the EHR software vendor.
- Continued participation on the county Performance Evaluation Team exploring performance evaluation methods and tools for recommendation to the County Administrator to consider for county employees.
- Facilitated the quarterly Community Health Quality Improvement Committee meeting on March 19 with 12 members present. Approved two additions to the approved Abbreviation List: "HRHV" for high risk home visit and "EPDS" for Edinburgh Postnatal Depression Screening. Prenatal record review focused on cases with diagnosis of obesity. 10 records were reviewed, five discharge records and five active records. Of the discharge records, four of five clients met their weight gain goal of less than 20 pounds. All five clients had nutrition and exercise goals. Of the active records, three of five clients had diagnosis of obesity with clearly documented nutrition and exercise goals. Two clients without diagnosis of obesity lacked documentation of referral to WIC which was corrected. Clinic record review of 33 records revealed no vaccine errors made and documentation deficits identified were corrected. All record review findings were shared with staff at their monthly staff meeting. Client/Family Satisfaction Reports for CHS Home Visit Services (MOMS/TB/Lead): 1st Quarter 2019- 100% (7 of 7) reported 'agree' or 'strongly agree' with all care. Clients wrote 7 positive impressions and 0 recommendations for improvement. 41 clients discharged, 7 returned surveys = 17% of total discharges. Reported referral sources included: Website (0), WIC (4), Hospital (1), MD (2), Friends (2), Relatives (0), Department of Social Services (0), Community Agency (0), and Other (0). Client/Family Satisfaction Reports for CHS Clinic Services: 1st Quarter 2019 –100% (25 of 25) reported 'agree' or 'strongly agree' with all care. Clients wrote 18 positive impressions and 1 wrote suggestions for improvement to include wanting free clinic services. 132 clients received clinic services in the 1st Quarter, 25 returned surveys = 20% of total receiving services. Reported referral sources included: Website (1), WIC (0), Hospital (1), MD (3), Friends (8), Relatives (1), Department of Social Services (0), College (1,) Community Agency (3), and Other (5).

**Incident Reports:** Two incidents (1 in CHS; 1 in WIC) occurred this quarter. In CHS – 49-year old female with mild intellectual disability, non-insulin dependent diabetes, hypertension and myoclonic seizures seen in immunization clinic for vaccines needed to participate in Special Olympics in March. MMR, Tdap and Hep A vaccines were

administered. Client developed tremors with urinary incontinence and altered mental state. RNs responded quickly and appropriately. Client was transported via ambulance to ER for evaluation and recovered without further incident. In WIC – During a nutrition appointment, a toddler bit the Nutritionist! The bite did not break the skin of the Nutritionist who appropriately washed the area immediately. Parent was present with multiple children and did not effectively parent this child during the appointment.

- Attended the one-hour presentation on Non-tick diseases by Dr. MacQueen at CMC on March 20.
- Facilitated combined WIC and CHS staff meeting to foster ongoing collaboration on common goals in both programs.
- Attended "Blueprint for Health Equity" all day conference at The Space at Greenstar in Ithaca on March 22. Participated in a poverty stimulation exercise.

## **Continuing Education-**

 Supervising Community Health Nurse Melissa Gatch and Community Health Nurses Karen LaCelle and Celeste Rakovich attended the Annual Immunization Conference in Saratoga, New York March 13-14.

#### Lead Poisoning Prevention- No open lead cases.

#### Communicable Disease-

- Influenza: Influenza activity level has been categorized as geographically widespread for the past 17 weeks. Weekly surveillance is showing a slow decline. Season to date, Tompkins County has had 682 confirmed cases of influenza; compared to same time last season of 1,072 confirmed cases- a 36% decrease this season. Peak appears to be later this season, as we saw 235 cases in March compared to 128 cases in March of last season. In NYS there have been six pediatric flu related deaths reported.
- Measles Outbreak in NYS: The measles outbreak continues to expand in NYS. As of April 10, 2019, there have been 176 cases in Rockland County, 16 cases in Orange County, 5 cases is Westchester County and 2 cases in Sullivan County. Cases in New York City have reached 285, with 21 hospitalizations, including 5 ICU admissions. Most of these cases are among the Orthodox Jewish community, where vaccination rates are lower and herd immunity has not been established. On March 27, 2019, Rockland County executive Ed Day barred unvaccinated children from public places for 30 days. A judge has ruled against the order, temporarily halting it. On April 9, 2019, NYC Mayor de Blasio declared a public health emergency requiring unvaccinated individuals in Williamsburg, Brooklyn to receive the measles vaccine. Locally, data from the 2017-18 school year show that 4 area schools fall below the 95% threshold for herd immunity against measles. These schools are Waldorf School at 66%, New Roots Charter School at 80%, Lehman Alternative Community School at 85%, and Fall Creek Elementary School at 93% of students immunized. The health department, area medical providers and school nurses continue to educate the community about the importance of immunizations.
- **HIV Testing/Counseling:** During the month of March the Health Department offered **13** clinic dates at multiple testing sites. There were **15** people tested, all with negative results.

# ENVIRONMENTAL HEALTH HIGHLIGHTS March 2019

## Outreach and Division News

<u>OWTS Inspectors Find Bad Tanks:</u> During the course of Onsite Wastewater Treatment System (OWTS) inspections in March, Environmental Health inspectors discovered a batch of septic tanks that had been incorrectly assembled at the factory. EH staff worked with contractors and the wholesaler, who contacted the factory, to prevent the further distribution of the backwards tanks. Three tanks had been installed and were replaced by the wholesaler at no cost to the homeowners.

<u>Rabies Services Appreciated:</u> Cynthia Mosher was recently forwarded an article by a grateful Tompkins County resident. The article recounts the author's rabies education after being bitten by a dog and his experience with the Health Department. The author discusses how appreciative he is that there is a system in place to protect people from rabies and that he was unaware of this program.

<u>T-21 in NYS Budget:</u> Two of the Governor's proposals related to tobacco prevention and control endured the negotiation process and were enacted as part of the executive budget. Any retailers selling e-liquid will now have to register with NYS Department of Tax and Finance, with a \$300 annual registration fee. The registration requirement affords Adolescent Tobacco Use Prevention Act (ATUPA) enforcement to be applied to these newly registered retailers, working to prevent sales to underage purchasers. Additionally, there will be a 20% sales tax on the retail price of e-liquid or any product containing e-liquids. It is not known when NYSDOH will provide additional information on how and when to implement these changes in the Division's ATUPA program.

State Septic System Replacement Fund: Liz Cameron filed with the NYS Environmental Facilities Corporation (EFC) the required annual report for the first year of the State Septic System Replacement Fund. For the program, the Environmental Health Division notified almost 500 owners of properties located within 250' of Cayuga Lake with on-site sewage systems. As of March 25, the Health Department has issued awards for 6 properties. Construction has been completed on one property and funds totaling \$5000 reimbursed. The four awards awaiting construction total \$32,400. Three property owners expressed interest in the program but withdrew at various early stages of consideration. We currently have at least one additional property owner interested in the program.

<u>Accela:</u> EH continues to meet approximately weekly with ITS to address issues with and improvements to the Accela software program. One of the highest priorities is to resolve the current inability for online credit card transactions through Official Payments to transfer to Accela. ITS believes that this problem was resolved with the new updates to Accela; however, when the updates were applied to our Accela-Test system, the public portal ACA can no longer be accessed. ITS is trying to work with Accela to identify the remedy to this new problem.

In a more immediately successful effort, Janice Wood has started digitizing historical spill records and uploading them to Accela. This will eventually decrease our paper files for these records in our office. The more immediate benefit is that records can now be rapidly located and distributed in response to FOIL requests or other needs.

**Training:** On March 27, Scott Freyburger, Cynthia Mosher, and Liz Cameron participated in the NYSACHO 2019 Environmental Health Summit. The summit focused on *Legionella* and included presentations on the history of legionellosis outbreak investigations; legionellosis trends nationally and in New York State; regulations, policies and practices; and resources available to local health departments.

## Rabies Control Program

There was one confirmed case of rabies found in a bat during March 2019. The bat bit a person while being handled, was euthanized, and then submitted for testing. Bats will begin to migrate from winter hibernaculums and start to appear in homes for a brief period as females begin to search for nesting sites. Bat exclusion repairs should be performed once there are three nights in a row that stay above 50 degrees F. The Health Department began outreach efforts regarding bat exclusion through social media and to the Landlords Association.

Five spring rabies clinics are scheduled to occur during the first three weeks of May.

If the pet is still healthy at the end of 6 months, the exposure did not result in rabies and the pet is released.

## Food Program

Inspections can be sorted to meet the needs of the viewer (by facility, date, etc.) by clicking on the column heading of interest. These are valuable tools for easily providing information to the public.

Routine facility inspections are conducted to protect public health. The inspections are made without advance notice to ensure that food processes are adequate, safe, and meet code requirements. It is important to keep in mind that inspections are only a "snapshot" in the entire year of a facility's operation and they are not always reflective of the day-to-day operations and overall condition of the operation.

Critical violations may involve one or more of the following: the condition of food (e.g. food that may be at improper temperatures on delivery or damaged by rodents), improper food cooking and storage temperatures (e.g. food cooked to and/or held at improper temperatures), improper food preparation practices (e.g. preparing ready-to-eat foods with bare hands), and water and/or sewage issues (e.g. low disinfection levels in the water system). These critical violations relate directly to factors that could lead to food related illness.

## Critical Violations were found at the following establishments:

#### Spicy Asian, C-Ithaca

Potentially hazardous foods were not kept at or below 45°F in cold holding. Products in cold holding were observed to be at 56°F. The product was discarded during the inspection.

#### Kung Fu Tea - Collegetown, C-Ithaca

Potentially hazardous foods were not kept at or above 140°F in hot holding. Product in hot holding was observed to be at 137°F. The facility has a waiver for time as a public health control for this product but was not maintaining temperature log sheets as required.

#### U Tea, C-Ithaca

Potentially hazardous foods were not stored under refrigeration. Products on a counter were observed to be at 74°F and 82°F. The facility has a waiver for time as a public health control for the products but was not maintaining temperature log sheets as required.

#### Seabring Inn, T-Newfield

Cooked or prepared foods were subject to cross-contamination from raw foods. Storage was rearranged during the inspection.

#### Old Mexico, C-Ithaca

Potentially hazardous foods were not cooled by an approved method. Two products in refrigerated storage were observed to have been cooled using unapproved methods. The products were discarded during the inspection.

## Friends & Pho, V-Lansing

Potentially hazardous foods were not kept at or below 45°F during cold holding. Product in cold holding was observed to be at 50°F. The product was removed from service and rapidly chilled to 45°F or less before use.

#### Hotel Ithaca, C-Ithaca

Food was adulterated on premises in three locations. The food products were discarded during the inspection.

#### Plum Tree Japanese Restaurant, C-Ithaca

Food workers prepared ready to eat food products without washing hands and changing gloves in between.

Cooked or prepared foods were subject to cross-contamination from raw foods. Product was discarded during the inspection.

An accurate thermometer was not available to evaluate potentially hazardous foods during cooking, cooling, reheating and holding. The thermometer in use was observed to be off by 10°F and was recalibrated during the inspection.

Potentially hazardous foods were not stored under refrigeration. Products on a counter were observed to be at 50-51°F. The products were removed from service and placed in refrigerated storage to be rapidly chilled to 45°F or less before use.

#### **Linda's Corner Diner, T-Lansing**

Water/ice was unsafe. The facility is required to maintain a free chlorine residual on their water system at all times of operation. At the time of the inspection no chlorine residual was available in the system. A Boil Water Notice was issued during the inspection.

### Dryden Veterans Memorial Home, T-Dryden

Cooked or prepared foods were subject to cross-contamination from raw foods. Storage was rearranged during the inspection.

#### Foodnet Central Kitchen, V-Lansing

Potentially hazardous foods were not cooled by an approved method. Product in a cooler was observed to be at 50-51°F. The product had been cooked and placed in the unit the previous day. The product was discarded during the inspection.

#### Casablanca Mediterranean Cuisine & Pizzeria, C-Ithaca

Potentially hazardous foods were not stored under refrigeration. Product in a display for customer service was observed to be at 75-80°F. The facility has a waiver for time as a public health control for this product but was not maintaining temperature log sheets as required.

#### Shahi Pakwan, C-Ithaca

Food from an unapproved source was found on premises. The product was discarded during the inspection.

Potentially hazardous foods were not kept at or above 140°F during hot holding. Products in hot holding were observed to be at 108°F and 80-87°F. The facility has a waiver for time as a public health control for this product but was not maintaining temperature log sheets as required.

**Temporary Food Service Operation Permits** are issued for single events at one location. The Food Protection Program **issued 27 temporary permits**.

**Temporary food operation inspections** are conducted to protect public health. The inspections are made without advance notice to ensure that the food processes at the event are adequate, safe, and meet code requirements. The operation must correct Critical Violations during the inspection. When a Temporary Food Operation has Critical Violation/s, a re-inspection is conducted when the event is longer than one day.

Action: Keep cooked tapioca at or below 45 degrees F, or apply for a waiver and record time and date each batch of tapioca is brought out.

Interview with operator indicated that he typically makes log entries at 2:30pm after lunch is over; the sushi rice is prepared each day at 11am.

Correction: An entry for today was added to the log based on an 11am start time.
