APPROVAL OF MINUTES

Tompkins County Board of Health April 23, 2024 12:00 Noon Rice Conference Room and via Zoom

Call to Order: Dr. Moylan called the regular meeting of the Board of Health (BOH) to order at noon.

Privilege of the Floor: None

Approval of March 25, 2024, Minutes: Ms. Merkel moved to approve March 25, 2024, minutes; second by Mr. Ravinder. The vote to approve the March 25, 2024, meeting minutes as written was unanimous; the motion carried.

Financial Summary: Mr. Kruppa reported on behalf of Mr. Porter who is out on medical leave. The staff is working on finalizing the 2023 budget.

Medical Director's Report and Discussion: Dr. Klepack had nothing to add to his written report.

Administration Report: Mr. Kruppa reported that the County is updating the webpage which includes Whole Health and should be fully launched by the end of the calendar year without interruption in accessing the BOH public documents. County Finance is updating the process of purchasing requirements for Request For Proposals (RFP).

Division for Community Health (DCH) Report: Ms. Buckwalter had nothing to add to her written report. DCH is looking to fill the senior nurse position and asked for referrals or recommendations.

Health Promotion Program Report: Ms. Hillson reported that community visioning boards have been displayed throughout the County for community residents to provide input to the Tompkins County Community Health Improvement Process (CHI Tompkins). Virtual and live events are being held for more engagement and input from the community with a focus on the two questions below.

- 1. What is their ideal vision for the vision for the health of our community?
- 2. What do they feel are the overlapping identities that make up our community?

The summary of input and ideas collected will shape the one vision statement to guide the CHI Tompkins process.

Children with Special Care Needs (CSCN) Report: Ms. Clark Manderville reported they are interviewing for a speech-language therapist in-house position. The new billing platform the state is launching (Early Intervention Hub) will launch on October 15th of this year. Mr. Kruppa added that they are looking to submit an alternative proposal to County Administration that would allow the hiring of more needed speech therapists for the County through other funding or a stipend due to insufficient State funding, despite a 5% rate increase from the State budget.

Environmental Health Report: Mr. Shea had nothing to add to the written report. Ms. Black asked to explain fees regarding a fee to a homeowner. He described the standard fees and noted that it is uncommon to see replacement system plans from an outside engineer to do the work that the Health Department requires unless EH needs to make a referral to an outside engineer due to extreme complexity. Mr. Shea is unsure how the homeowner found out there was a problem with their sewage system and there are no reduced fees for an outside engineer.

Ms. Black moved to refund the homeowner the permit \$190 fee; seconded by Mr. Ravinder.

Discussion: The homeowner has the option to use an outside engineer/contractor. The EH fee schedules, processes, and contract information have always been listed on the website. Mr. Kruppa added that EH thoroughly explained the process to the homeowner and they were receptive but the EH team will look further into the matter. He feels it may have been a misunderstanding between the homeowner and the contracted engineer.

Four were opposed to refunding the permit fee, and three were in favor; the motion failed to pass.

ENVIRONMENTAL HEALTH

Enforcement Actions:

Draft Resolution #EH-ENF-24-0002 – Ithaca Press, Violations of Subpart 14-1 of the New York State Sanitary Code (Food Service) – Ms. Merkel moved to accept the motion as written; seconded by Dr. Koppel.

No discussion.

All were in favor; the vote to approve the resolution as written was unanimous.

Draft Resolution #EH-ENF-24-0006 – Brew 22 Coffee, Violations of Subpart 5-1 of the New York State Sanitary Code (Public Water) – Ms. Black moved to accept the motion as written; seconded by Ms. Touchton.

Discussion: Ms. Merkel asked for an explanation of the fees. Mr. Kruppa could not fully explain all the fines totaling \$8,700 in significant multiple violations that include unverifiable water sample reports and many other missed reports.

It was decided that this matter be tabled and heard again at next month's meeting.

OTHER ACTIONS

Encampment Notice of Violation Update:

Mr. Kruppa shared an update on the encampment situation that resulted in the issuance of a Notice of Violation to the City of Ithaca and the railroad in the area bordering Tabor Street and the railroad tracks which negatively impacts the waterways. The City and the railroad responded well and agreed to develop a plan and clean up the affected area. The notice of violation gave both entities 30 days to submit the plan to Environmental Health from the issuance of the violation. He added that the City recently posted keepout signs, and some cleanup has begun and looks forward to a sustainable proposal from the City for the land to be sanitarily maintained.

Whole Health's Overdose Follow-Up Presentation:

Mr. Kruppa provided a follow-up and update on Whole Health's response, data collection, and communication strategies related to opioid overdoses.

Tompkins County opioid information, data, and resources can be found on the Whole Health webpage at Opioid Use and Resources | Tompkins County NY.

Communication strategies include issuing press releases on topics of mental health and substance use disorder issues in the community, alerting the community of fentanyl being laced in drug supplies, updating the community, informing about available resources, avenues of support, community initiatives, Requests for Proposals (RFPs), data on opioid-related overdose deaths regularly, via TV, radio, and newspapers.

Data is posted regularly on the website with a recent posting around demographics on unintentional overdose deaths.

911 Call for Overdose Emergency - The 911 Center provides overdose/poisoning call data based on the type of emergency. The Community Justice Center, which is involved in public safety reform, recently put out a data page that has more information about the 911 Call Center. The Sheriff's Office and the Ithaca Police Department also have data on their web pages.

Drug-Related Deaths Data - Based on records filed by the Tompkins County Medical Examiner. The data is an aggregate of the last five years (2019 - 2023) identified by a variety of demographics.

Unintentional Fatal Overdoses – Includes those for which the manner of death is classified as an accident and substance identified in a toxicology screening is ruled as the immediate cause of death. The data was broken down into several categories. He noted that individuals working in food service under the

occupation category were higher than expected and this identified population group will be investigated and addressed differently as they are disproportionately affected.

They are looking at non-fatal overdoses with conversations with Cayuga Health Partners to get their data on individuals entering the emergency room.

Drug-Related Deaths – Includes all deaths in which drugs are involved. In these cases, the immediate cause of death is not or not solely drugs, and drugs are often listed under "Other significant contributions." These also include those in which the manner of death is not ruled as an accident.

Opioid Quarterly Reports - The summary of Tompkins County Data Published April 2024 is slightly behind as it comes from New York State quarterly but helps in how resources are targeted. Community Health Improvement Plan (CHIP) – Mr. Kruppa reviewed the community plan areas of CHIP which focused on Promoting Well-Being and Preventing Substance Use Disorders and Mental and Substance Use Disorders Prevention and their goals.

The community plan is designed to be a road map of how the community addresses issues and how we can help improve them. CHIP 2022 – 2024 can be found on the webpage at CHACHIP2022-TompCo-TOC-CHIP.pdf (tompkinscountyny.gov).

The Tompkins Mental Hygiene Local Services Plan for 2024-2028 was developed by a workgroup composed of the Chair of the Community Services Board, the Chair and Co-Chairs of the Mental Health, Substance Use and Developmental Disabilities Subcommittees, and the Director of Community Services. The workgroup solicited feedback from community members, local provider agencies, and the Community Service Board and subcommittee members through a Local Services Plan Priority Needs Survey conducted in May and June 2023. The Local Services Plan can be found at Tompkins County Whole Health Local Services Plan (tompkinscountyny.gov)

Local Services Plan Goal Areas:

- 1. Workforce
- 2. Housing
- 3. Crisis Services
- 4. Cross System Services
- 5. Non-Clinical Supports
- 6. Adverse Childhood Experiences
- 7. Transition Age Services

The biggest challenge is the shortage of available workers including social workers, psychiatrists, peers, etc. from the research and work of Developmental Disabilities, Mental Health, and Substance Use subcommittees. Housing is a primary problem.

- > Expanded Opioid Overdose Prevention Program from Green Street to Brown Road
- ➤ Launched Dual response CARE Team program with the Sheriff's Office and Ithaca Police Department
- Received pilot funds from OMH to Outreach Worker program to rural parts of the county

- Advocate for and received funds from TC legislature to continue the program
- Facilitate an RFP process to find a vendor to administer the program
- ➤ Facilitated County Opioid Settlement Funds Task Force distribution of \$725,000 to community organizations
- ➤ Led the Community Services Board to create a rapid housing and crisis services program using Opioid Settlement Funds

Call to Order: Dr. Moylan called the regular meeting of the Board of Health (BOH) to order at noon.

Privilege of the Floor: None

Approval of April 22, 2024, Minutes: A quorum was not met and the April 22, 2024, minutes could not be approved. The meeting moved forward with discussions of the agenda items.

Financial Summary: Mr. Kruppa reported on behalf of Mr. Porter, who is on medical leave. He reported that the first quarter financials are on track but are below schedule on expenses.

Medical Director's Report and Discussion: Dr. Klepack referred to the reported Avian influenza cases, which continue to be an issue but reported that there have been no additional human cases. Pasteurized milk is safe to drink and advises against consuming raw or unpasteurized milk.

Administration Report: Mr. Kruppa reported that the New York State Public Health Partnership Conference will be held at the new "Ithaca Downtown Conference Center" on Green Street in 2025.

Division for Community Health (DCH) Report: Ms. Buckwalter was not present.

Health Promotion Program Report: Ms. Hillson reported that there will be a kickoff event for the Community Health Improvement Process (CHIP) on June 7th to explain the process, planning, structure, and framework (MAP 2.0) and provide an overview of the past six months.

Children with Special Care Needs (CSCN) Report: Ms. Clark Manderville was not present.

Environmental Health (EH) Report: Mr. Parr introduced EH Administrative Coordinator, Brenda Coyle who is extremely instrumental in compiling the fees and managing EH's data.

Highlighted Updates:

- ➤ Boil Water Order EH meets with the Village of Dryden on the boil water order for an after-action review to coordinate communication across agencies
- ➤ City Encampment EH received a request for a copy of the City's work plan for the encampment. The City's work plan is currently under review and once finalized it will be released

Mr. Kruppa responded to a concern of the campers by the inlet and said that they are aware of the campers and there are no violations but will continue to monitor. The City's plan is inclusive of the City zone project and the next area of focus is around Nate's.

Avian influenza update

There have now been 3 human cases. Two in Michigan and one in Texas. None have been epi-linked. The farmworker in Michigan who was the latest case had a cough and sore throat in addition to conjunctivitis. Due to these expanded symptoms, concern has heightened regarding person-to-person transmission. So far, no secondary cases have been detected. The death of a Mexican was traced to H5N2 not to H5N1. That situation is also being closely monitored. No human cases or infected herds have been detected in New York State.

Milk and milk products that are pasteurized continue to be safe.

For the public to be protected avian influenza must be tracked and cases investigated. These fundamental steps have been hampered by key states refusing to allow the CDC and the Department of Agriculture to conduct studies. In addition, dairy industry businesses have been reluctant due to impacts on their businesses. The impacts are in at least two areas:

- 1. Cost of testing workers, cows, and milk,
- 2. Loss of milk when a herd is infected (the milk production and milk quality per cow infected decreases.)

To encourage participation, they must receive support from society. The measures and supports created so far are:

- 1. Limiting the interstate movement of lactating dairy cattle from April 29 forward.
- 2. Economic assistance for producers with H5N1-affected premises to improve on-site biosecurity in order to reduce the spread. Financial support (up to \$2,000 per affected premises monthly) for producers supplying PPE to employees and/or providing uniform outerwear laundering.

Support producers in biosecurity planning and implementation.

Provide support (up to \$1,500 per affected premises) to develop biosecurity plans based on existing secure milk supply plans. This includes recommended enhanced biosecurity for individuals who frequently move between dairy farms – milk haulers, veterinarians, feed trucks, AI technicians, etc. In addition, USDA will provide a \$100 payment to producers who purchase and use an in-line sampler for their milk system.

3. Financial support **for producers, and workers** who participate in the study are also eligible for financial incentives to compensate them for their time, regardless of whether the study is led by federal, state, or local public health professionals.

4. The USDA is taking steps to make available financial tools for lost milk production in herds affected by H5N1. Provide funding for heat treatment to dispose of milk in a bio-secure fashion.

If a producer establishes a system to heat treat all waste milk before disposal, USDA will pay the producer up to \$2,000 per affected premises per month.

- 5. Reimburse producers for veterinarian costs associated with confirmed positive H5N1 premises. This provides support to producers to cover veterinary costs necessarily incurred for treating cattle infected with H5N1, as well as fees for veterinarians to collect samples for testing. This can include veterinary fees, and/or specific supplies needed for treatment and sample collection. Veterinary costs are eligible to be covered from the initial date of positive confirmation at NVSL for that farm, up to \$10,000 per affected premises.
- 6. Offset shipping costs for influenza A testing at laboratories in the National Animal Health Laboratory Network (NAHLN). USDA will pay for the cost of shipping samples to NAHLN labs for testing. USDA will pay actual shipping costs, not to exceed \$50 per shipment for up to 2 shipments per month for each affected premises. Testing at NAHLN laboratories for samples associated with this event (e.g., pre-movement, testing of sick/suspect animals, samples from concerned producers) is already being conducted at no cost to the producer.
- 7. **Compensate producers for loss of milk production**. USDA is taking steps to make funding available to compensate eligible producers with positive herds who experience loss of milk production. While dairy cows that have been infected with H5N1 generally recover well, and there is little mortality associated with the disease, it does dramatically limit milk production, causing economic losses for producers with affected premises. USDA can support farmers with the ELAP program to offset some of these losses. This compensation program is distinct from the strategy to contain the spread.
- 8. Work with states to limit the movement of lactating cattle. Additionally, USDA will work with and support the actions of States with affected herds as they consider movement restrictions within their borders to further limit the spread of H5N1 between herds to reduce further spread of this virus.

USDA will make \$98 million in existing funds available to APHIS to fund these initiatives. If needed, USDA has the authority, with Congressional notification, to make additional funds available.

Highlights

COMMUNICABLE DISEASE

- Review of notable CD investigations in May:
 - Campylobacteriosis- two cases: one with chronic GI problems, one with questionable source of infection, ate out at restaurant in neighboring county
 - Giardia- one case: eats out often, was in PA, Toronto and NYC, took medication which helped Sx improve
 - o Yersiniosis- one case: chronic GI problems, traveled to Columbia, also ate venison
 - o Dengue- one case in a child; part of family that had traveled to Guadalupe and all got it
 - Shigellosis- one case: co-infected with Campylobacter, r/o unpasteurized milk, ate out at restaurant in neighboring county.
 - Anaplasmosis- seven cases: age range 39-72: most serious 72yo hospitalized at Upstate for 6 days
 - Babesiosis- one case: chronic health problems, hospitalized for 7 days
 - Haemophilus Influenzae not type B one case: 79 yo very ill with multiple comorbidities, came from nursing home, deceased.
 - Tick borne diseases:
 - Rise in Lyme Disease: May 2024 50 cases compared to May 2023 22 cases
 - Anaplasmosis: about the same for May 2024 vs May 2023
 - Babesiosis: May 2024 -1 case and May 2023 none

STAFFING

- Recruitment efforts in March/April resulted in three offers being made to three nurse candidates. All offers were declined.
- A new round of recruitment for two Community Health Nurse vacancies and one Senior Community Health Nurse vacancy will be starting.
- Retired CHS nurses Karen LaCelle and Karen Bishop will be working per diem to fill the staffing gap until we can hire into our open full time positions.
- CHS fellow Dorota Kossowska completed her fellowship in CHS. Her last day was May 24th. She
 will be missed and we wish her the best on her next career step—nursing school at SUNY
 Binghamton.

IMMUNIZATIONS

 CHS Director Rachel Buckwalter attended the Statewide Immunization Conference in Albany on May 16-17. This conference focused on the workplan for the Immunization Action Plan grant.
 Rachel was able to network with nurses working in immunizations in other counties and hear from NYSDOH officials on their priorities for immunization programs.

WIC

- In May the WIC Director, Michelle Hall attended the 2024 NYS WIC Managers workshop. The
 conference focused on embracing the future of the WIC program, implementing high quality inpersons and services, advancing equity in the WIC program and strategies for enhancing
 recruitment and retaining current employees.
- The Farmers Market Nutrition Program (FMNP) started June 1st and will continue through September 30th. Each eligible WIC participant is issued FMNP coupons (\$25.00) in addition to their regular WIC benefits. These coupons can be used to buy locally grown fruits and vegetables from farmers, farmers markets, or roadside stands. The program provides farmers with the opportunity to earn additional revenue while providing healthy, local farm fresh produce to lower-income families.
- New York State DOH contracted with Hunger Solutions New York (HSNY) to work with different WIC agencies on their outreach efforts to promote WIC enrollment and participation. TCWH WIC agency was selected and over the next few months staff will work with outreach specialist to deepen existing partnerships and establish new partnerships with targeted WIC allies in our county. The agency will also have the opportunity to consult with marketing agencies to build website and social media presents.

Program Updates

SAFECARE PROGRAM

One family is currently enrolled in SafeCare.

MOMS PLUS+

- 60 home visits were completed in May which included 25 new admissions.
- As of June 1st the Moms PLUS+ client caseload stands at 62 clients enrolled which is our highest caseload in over a year!
- Currently CHS only has two nurses doing home visits for Moms PLUS+. Visit numbers and referrals have been on a steady increase despite our staffing struggles.

RABIES

 Rabies: May started the 2024 rabies season. CHS nurses have been busy vaccinating and case managing people authorized for rabies post-exposure prophylaxis. There were 23 rabies vaccine visits in May. • These people were exposed to rabies due to contact with bats (or bat in the bedroom while sleeping), raccoons and a possibly rabid coyote.

LEAD

- There was one new admission to the lead program in May for a child with a BLL of 6.7 mcg/dl residing in Groton. Environmental assessment occurred on June 13th to determine sources of lead within the home. Report from that visit is pending.
- No discharges from the lead program in the month of May. Currently 17 children are receiving case management in the lead program.

Highlights

POTENTIALLY RABID BABY RACCOONS:

On Friday, May 31, Environmental Health was notified that a woman had raccoon kits at a school bus stop near the Milton Meadows Apartment Complex in Lansing, resulting in multiple potential rabies exposures. The raccoons were also posted for sale on social media, and one raccoon had been taken to a child's birthday party on May 18. The woman who had initially taken the raccoons was not initially cooperative, and the raccoons were not immediately located by NYSDEC or EH. Within a week, however, all five kits were located and submitted for rabies testing. Four of the raccoons tested negative; one was unable to be tested. A press release was issued in an effort to identify all people who were potentially exposed and printed fliers were distributed at the apartment complex. After multiple, time-consuming conversations, EH staff was able to rule out most potential exposures; however, five children were authorized for rabies post-exposure prophylaxis.

We greatly appreciate the efforts of EH staff directly involved in this investigation, specifically Dillon Shults, René Borgella, Skip Parr, Doug Barnes, Cameron Cowburn, and our administrative team — Michelle Luther, Bee Walsh, and Brenda Coyle, and CHS nurses Rachel Buckwalter and Caryl Silberman. We also appreciate the assistance of the staff at the NYSDOH, Lansing School District, the Tompkins County SPCA, and many members of the public who provided helpful information regarding the potential exposures. This scenario underscores the importance of cooperating with our office during an on-going investigation. If the raccoons had been turned over to our office in a timely manner, they could all have been tested for rabies, and if negative for rabies, would have conclusively ruled out multiple potential exposures and avoided having multiple children undergo the rabies prophylaxis series.

POTENTIALLY RABID COYOTE AT MONKEY RUN:

On June 2, EH was notified that a wild/feral dog or coyote attacked a person at the Monkey Run trail head near Hanshaw Road. Out of an abundance of caution, EH authorized rabies post-exposure treatment for a resulting injury that may have resulted from the fall or the attack. Two additional reports were received on June 4, resulting in additional rabies post-exposure treatment. EH staff (Dillon Shults and René Borgella) coordinated with Cornell University and NYSDOH regarding the incidents. Cornell closed the area to public access and, working with Wildlife Resolutions, attempted to locate and trap the animal. TCWH issued a press release to alert the public. These efforts were not successful. As of June 14, the status of the coyote is unknown. If the coyote was rabid, then it is likely that the coyote

has died or is near death because of rabies. Cornell reopened the trails on June 11 and TCWH issued a press release notifying the public and urging continued caution in this area on June 14.

SPRING RABIES CLINIC:


EH hosted a free rabies clinic at the Enfield Highway Garage on May 23, 2024. This event marked the first clinic held in Enfield since the summer of 2022. During the clinic, a total of 108 cats and dogs were vaccinated. Thanks to the collaboration between the Enfield Highway Department (Buddy Rollins), our veterinarian partners (Dr. Ann Chaffee and Addie Barlow), certificate writers (Diane Crouch, Jamie Breedlove and Bonnie Hart), Tompkins County IT staff (Mark Patterson and Ariel Casper), and our own Environmental Health staff (Skip Parr, Kate Walker, Cameron Cowburn, René Borgella and Dillon Shults), the event went smoothly and was a great success.

CHILDHOOD LEAD PRESENTATION TO LANDLORDS ASSOCIATION:

On May 20, René Borgella (EH) and Darryl Heffron (Eco-Testing Services) made a presentation on preventing childhood lead poisoning to the Landlords Association of Tompkins County (LATC). About 25 people (plus zoom participants for a total of about 60) attended the meeting at the Tompkins County Public Library Borg Warren room. The presentation was well received and generated great questions and interest from the attendees. Kudos to René and Darryl for providing this information!

Whereas, operators of public water systems are required to comply with Subpart 5-1 of the New York State Sanitary Code (NYSSC); and

Whereas, Brew 22 Coffee and Espresso (Brew 22) is a public water system and is regulated as a food service establishment under Subpart 14-1 of the New York State Sanitary Code; and

Whereas, Subpart 5-1.51(b) of the NYSSC requires Brew 22 to submit quarterly total coliform sampling results and an annual nitrate sample result to Tompkins County Environmental Health (TCEH); and

Whereas, Subpart 5-1.30 of the NYSSC requires Brew 22 to ensure disinfection systems are operating as designed; and

Whereas, Subpart 5-1.71 requires an operator to exercise due care and diligence in the maintenance and supervision of the public water system; and

Whereas, on May 26, 2020, Tompkins County Board of Health Resolution #EH-ENF-20-0009 ordered Brew 22 to submit quarterly total coliform results, monthly operating reports and an annual nitrate sample as required by Subpart 5-1; and

Whereas, on September 8, 2021, Tompkins County Board of Health Resolution #EH-ENF-21-0010 ordered Brew 22 to submit quarterly total coliform results, monthly operating reports and an annual nitrate sample as required by Subpart 5-1; and

Whereas, TCEH did not receive total coliform sample results for the 3rd and 4th quarters of 2022, and did not receive total coliform sample results the 2nd, 3rd, and 4th quarters total coliform sample result for 2021; and

Whereas, TCEH did not receive annual nitrate sample results for 2022 and 2023; and

Whereas, on March 14, 2024, TCEH performed a water system inspection at Brew 22 and observed the UV system was not properly functioning and TCEH issued a Boil Water Order; and

Whereas, on March 15, 2024, TCEH received a total coliform sample result submitted for compliance purposes with a collection date of November 2023; and

Whereas, on March 19, 2024, TCEH received a letter from the laboratory where the total coliform sample was reportedly analyzed, stating that the report was falsified; and

Whereas, on March 25, 2024, TCEH received total coliform sample results submitted for the release of the Boil Water Order issued on March 14, 2024. These laboratory reports were also determined to be falsified: and

Whereas, on March 26, 2024, TCEH received an email from Riley Brewer, operator of Brew 22, indicating that an employee was responsible for the falsified reports, and that individual had been terminated; and

Whereas, on March 28, and March 30, 2024, TCEH received two satisfactory total coliform samples for the release of the Boil Water Order; and

Whereas, on April 2, 2024, TCEH performed a follow-up inspection verifying proper operation of the UV system and the Boil Water Order was released; and

Whereas, Riley Brewer, Operator, signed a Stipulation Agreement with Whole Health Commissioners Orders on April 10, 2024, agreeing that Brew 22 violated these provisions of the New York State Sanitary Code; now therefore be it

Resolved, on recommendation of the Tompkins County Board of Health, That Brew 22 Coffee & Espresso LLC, Owner, is ordered to:

- 1. Pay a penalty of \$8,700 for these violations, due by August 15, 2024. (Do Not submit penalty payment until notified by the Tompkins County Environmental Health Division.); and
- 2. Contract with a NYSDOH Certified Water Operator to manage the ongoing operation of the Brew 22 Coffee & Espresso water system and provide the operator contact information to Tompkins County Environmental Health by July 15, 2024; and
- 3. Submit total coliform sample test results for each quarter of operation by the 10th day of the following month; and
- 4. Submit completed monthly operation reports of daily UV intensity readings by the 10th day of the following month for every month; and
- 5. Submit the 2024 annual nitrate sample result to Tompkins County Environmental Health by April 30, 2024 (Received 5/1/24); and
- 6. Beginning in 2025, submit the annual nitrate sample result by January 10th of the following year;

To whom it may concern,

On Monday March 25th I received a call from the Tompkins County Health Department after submitting two water sampling reports that were provided to me after having an employee drop these tests of for sampling.

I then received a call from Skip Parr, notifying me that these reports were altered, and not accurate for the samples I had instructed to be delivered.

As I was visiting my sister in Charleston, I arrived back in town the afternoon of March 25th and asked about these reports.

Back in November, we had a new employee start who had made us aware of some health issues he faced, but we had brought him on anyway as we felt he would be a good fit, and he needed employment. During these first few weeks, and offer was made that he could drop a November water sample off for us as he was working a very limited schedule due to his health and could use the extra funds to do the running around and emailing me the reports for submittal.

His health continued to decline, and as he was only working around 5-8 hours per week, I figured allowing him to deliver the samples to remove our boil water notice would get some extra money in his pocket and help me out as I was getting ready to head out of town and visit my sister.

As it turns out, an old report dated from 2022 was altered three total times, and these water samples did not get to the lab at all. The roughly \$72 per test was pocketed, and I am assuming we honestly would not have caught on unless an individual at the health department realized the issues. These forms were readily available in our email, as I have always saved any water testing report in a single folder for easy access.

While this employee was terminated, and access to our email account (Brew22coffee@gmail.com) removed, I do however take full responsibility for this incident, with something of importance such as water samples, this absolutely should have been a process I performed myself to ensure chain of custody, but at the same time, I did not think altering a form was a possibility.



Hanshaw Village Mobile Home Park CNY MHPS, LLC, Owner and Cook Properties, NY, Operator 1871 Hanshaw Road, T-Dryden Dryden, NY 13068

Whereas, operators of public water systems are required to comply with Subpart 5-1 of the New York State Sanitary Code (NYSSC); and

Whereas, Hanshaw Village Mobile Home Park is a public water system and is regulated as a mobile home park under Part 17 of the NYSSC; and

Whereas, Part 17.6.a.1 of the NYSSC requires CNY MHPS, LLC and Cook Properties, NY, the owner and operator to provide drinking water in adequate quantity and quality as applicable to the requirements of Part 5 of NYSSC; and

Whereas, Subpart 5-1.22(a) of the NYSSC requires Hanshaw Village Mobile Home Park to obtain health department approval prior to the modification of a water system; and

Whereas, Subpart 5-1.71(b) of the NYSSC requires Hanshaw Village Mobile Home Park to exercise due care and diligence in the operation and maintenance of a water treatment plant and distribution system; and

Whereas, on November 9, 2023, Tompkins County Environmental Health (TCEH) inspected Hanshaw Village Mobile Home Park, and observed that modifications were made to the approved treatment system at the park's finished water storage tank; and

Whereas, on November 22, 2023, TCEH issued a Boil Water Order (BWO) and Public Health Director's Orders #EH-NOV-23-0008 requiring Hanshaw Village Mobile Home Park to provide bottled water to each home as a result of the tenants being without water for an extended period. This BWO was released on December 11, 2023; and

Whereas, on December 18, 2023, a BWO was issued to Hanshaw Village Mobile Home Park after TCEH observed that the UV and filtration system was taken out of service without approval from TCEH. This BWO was released on December 26, 2023; and

Whereas, CNY MHPS, LLC, and Cook Properties, signed a Stipulation Agreement with Whole Health Commissioners Orders on April 25, 2024, agreeing that Hanshaw Village Mobile Home Park violated these provisions of the New York State Sanitary Code; now therefore be it

Resolved, on recommendation of the Tompkins County Board of Health, That CNY MHPS, LLC, and Cook Properties, NY, Owner/Operator, are ordered to:

1. Pay a penalty of \$1,500 for these violations, due by **August 15, 2024**. (**Do Not** submit penalty payment until notified by the Tompkins County Environmental Health Division.); **and**

- 2. Maintain all equipment listed in the Approval of Completed Works document dated 8/17/2021, and the approved plans from 1/5/2021, attached hereto as Exhibit A, operational at all times, unless prior approval is granted by TCEH and/or a Force Majeure Event causes the operational failure. As used herein a Force Majeure Event shall include acts of God, work stoppages due to labor disputes or strikes, fires, explosions, epidemics, riots, war rebellion, sabotage or any other fact or circumstance beyond the reasonable control of CNY; and
- Develop and submit to TCEH by May 10, 2024, an Emergency Response Plan (ERP) that
 includes procedures for providing potable water to residents of the park during outages
 exceeding 24 hours and for restoring the operation of equipment referenced in Exhibit A
 without unreasonable delay (ERP received by TCEH on 5/9/24); and
- Notify TCEH by phone at 607-274-6688 within 24 hours if the UV light warning alarm referenced in Exhibit A is triggered, or if the UV disinfection unit or any other component of the water system is otherwise not operating as designed; and
- 5. Maintain at least one spare UV light and additional cartridge filters at all times; and
- 6. Notify TCEH by phone at 607-274- 6688 immediately, if disinfected water is unavailable to the residents of Hanshaw Village MHP for at least four hours; and
- 7. Develop Standard Operating Procedures (SOPs) for equipment in the lower creek pump house, as outlined in Exhibit A, and submit to TCEH by May 10, 2024. The SOPs may incorporate materials developed by the manufacturer of the equipment at the lower creek pump house. These SOPs must be stored and accessible at the lower creek pump house at all times (SOPs received by TCEH on 5/9/24); and

Hanshaw Village Mobile Home Park CNY MHPS, LLC, Owner and Cook Properties, NY, Operator 1871 Hanshaw Road, T-Dryden Dryden, NY 13068

Property owner, CNY MHPS, LLC (CNY), and operator, Cook Properties, NY agree that on the dates of November 9 through November 26, 2023, and December 18, 2023, Hanshaw Village Mobile Home Park was in violation of PHDO #EH-NOV-23-0008, Part 17 of New York State Sanitary Code (NYSSC), and Part 5 of the NYSSC for failing to supply bottled water and not providing drinking water that was adequate in quantity and of a quality to the residents of Hanshaw Village MHP.

CNY and Cook Properties NY agree to pay a penalty not to exceed \$1,500 for these violations following adoption of a resolution by the Board of Health. (Do not submit penalty payment until notified by the Tompkins County Environmental Health Division (TCEH).)

CNY and Cook Properties NY intend to apply for a new permit making CNY, the owner and intended operator, of the Hanshaw Village Mobile Home Park.

The owner and operator agree to comply with the following Orders when signed by the Tompkins County Whole Health Commissioner:


- Maintain all equipment listed in the Approval of Completed Works document dated 8/17/2021, and the approved plans from 1/5/2021, attached hereto as Exhibit A, operational at all times, unless prior approval is granted by TCEH and/or a Force Majeure Event causes the operational failure. As used herein a Force Majeure Event shall include acts of God, work stoppages due to labor disputes or strikes, fires, explosions, epidemics, riots, war rebellion, sabotage or any other fact or circumstance beyond the reasonable control of CNY; and
- 2. Develop and submit to TCEH by May 10, 2024, an Emergency Response Plan (ERP) that includes procedures for providing potable water to residents of the park during outages exceeding 24 hours and for restoring the operation of equipment referenced in Exhibit A without unreasonable delay; and
- 3. Notify TCEH by phone at 607-274-6688 within 24 hours if the UV light warning alarm referenced in Exhibit A is triggered, or if the UV disinfection unit or any other component of the water system is otherwise not operating as designed; and
- Maintain at least one spare UV light and additional cartridge filters at all times; and
- 5. Notify TCEH by phone at 607-274- 6688 immediately, if disinfected water is unavailable to the residents of Hanshaw Village MHP for at least four hours; and
- 6. Develop Standard Operating Procedures (SOPs) for equipment in the lower creek pump house. as outlined in Exhibit A, and submit to TCEH by May 10, 2024. The SOPs may incorporate materials developed by the manufacturer of the equipment at the lower creek pump house. These SOPs must be stored and accessible at the lower creek pump house at all times; and
- 7. Exercise both wells in the lower creek pump house, as outlined in Exhibit A, on a monthly basis and detail the treated water volume of each such well on the monthly operation report beginning with the April 2024 report; and

Whereas, EH conducted a satisfactory inspection of the pool on June 10, 2024; and

Whereas, as of June 10, 2024, the Holiday Inn Express has not provided proof of course completion to satisfy the provisions of Board of Health Resolution #ENF-23-0026; and

Whereas, the Board of Health has the authority to fine \$500 to \$2000 for each violation and this fine can be assessed for every day that the violation continues; now therefore be it

Resolved, on recommendation of the Tompkins County Board of Health, That Cassidy Fox, Operator, is ordered to:

- Pay a penalty of \$250 for these violations, due by August 15, 2024. (Do Not submit penalty payment until notified by the Tompkins County Health Department.); and
- Pay a penalty of \$250 due by August 15, 2024. This penalty will be waived upon receipt of proof of completion of certified pool operator course by July 15, 2024; and
- 3. Ensure a qualified swimming pool water treatment operator is on staff to maintain the pool during hours of operation.
- 4. By July 15, 2024, submit to Tompkins County Environmental Health a valid certificate demonstrating successful completion of an approved course; **and**
- 5. Comply with all requirements of Board of Health Resolution #ENF-23-0025; and
- 6. Comply with all the requirements of Subpart 6-1 of the NY State Code for Swimming Pools.

A valid certificate demonstrating successful completion of an approved course must be provided to Tompkins County Environmental Health before February 28, 2024." On February 28, 2024 Environmental Health staff reached out to your facility and was told that the test for the course had been delayed and would be completed on March 8, 2024. As of the date of this letter we have not received proof of completion of the Certified Pool Operator Course by your staff.

Whereas, the owner/operator of a Swimming Pool must comply with the regulations established under Part 6-1 of the New York State Sanitary Code (NYSSC); and

Whereas, on April 25, 2023, the Tompkins County Board of Health Resolution #EH-ENF-22-0055 ordered Holiday Inn Express to provide facility personnel with knowledge about pool operations on premises at all times the pool is in use, maintain skimmers and flow meter in working order at all times of operation and provide an accurate pool chemistry test kit and tablets; and

Whereas, on October 19, 2023, the Holiday Inn Express pool was observed to be open without a knowledgeable facility staff person on premises, skimmers and flow meters were observed to not be functioning, and the pool test kit available was observed to be an unapproved OTO (orthotolidine) test kit; and

Whereas, on October 19, 2023, Holiday Inn Express violated these provisions of the New York State Sanitary Code and the provisions of Board of Health Resolution #ENF-22-0055; now therefore be it

Resolved, on recommendation of the Tompkins County Board of Health, That Cassidy Fox, Operator, is ordered to:

- 1. Pay a penalty of \$800 for these violations, due by March 15, 2024; and
- 2. Provide monthly logs to Tompkins County Environmental Health by the 10th day of the following month showing that facility personnel with knowledge about pool operations is on premises at all times the pool is in use and conducting at least one visual check daily, prior to operation/use. The visual check shall confirm the pool is in compliance, including safety equipment and water quality. The personnel must sign the log and record the time of inspection and number of persons using the pool; and
- Provide proof of repair or replacement of the pool's flow meter to Tomkins County Environmental Health by February 28, 2024; and
- 4. Maintain the chlorine level of the pool at 0.6 mg/l up to a pH of 7.8 and at a minimum of 1.5 mg/l for a pH between 7.8 and 8.2; and
- Complete Monthly Operating Reports for the pool documenting chlorine and pH levels at least three times a day. Submit reports to the Environmental Health Division by the 10th day of the following month; and
- 6. Maintain skimmers so that they are properly working at all times; and
- 7. Provide an accurate pool chemistry test kit and tablets; and

- Ensure a qualified swimming pool water treatment operator is on staff to maintain the pool during hours of operation. A valid certificate demonstrating successful completion of an approved course must be provided to Tompkins County Environmental Health before February 28, 2024; and
- 9. Comply with all the requirements of Subpart 6-1 of the NY State Code for Swimming Pools.

Refund Policy; Removal of refund fee

In 2011, Environmental Health (EH) developed a refund policy approved by the Board of Health. The policy included a \$25 refund processing fee to cover administrative costs.

On average, the Division processes 15-20 refunds annually. However, EH generally only recovers \$100 in total revenue from the refund processing fee. Many refunds are due applicants applying for a permit that is not required, where we don't charge the \$25 for each refund.

Considering the additional administrative burden in tracking and applying the refund processing fee and the minimal financial benefit gained, EH is proposing to eliminate the \$25 refund processing fee effective January 1, 2025, and request the Board's approval of the attached revised refund policy.

Environmental Health Division Policy for Refunds of Permit, Application and Plan Review Fees Draft for BOH Review May 2024

Background:

The Tompkins County Environmental Health Division receives fees from the public for water system operations, onsite wastewater system applications, realty subdivision developments, permits to operate, plan reviews, and other services. This policy addresses those instances when the Division receives a request for a refund of these fees.

Policy:

- 1. There will be a \$25 processing fee for any refund issued by the Division. Refunds may take 2 4 weeks to process.
- 2. For operating and facility permit fees, refunds will be issued to the applicant upon request if the request is received within 6 months of the issue date of the permit and if the facility has not operated and if the permit has not expired.
- 3. For other application and plan review fees, refunds will be issued upon request if the request is received within 6 months of the submittal date of the application or plan and if the Division technical staff has not conducted a field visit or spent more than 1 hour reviewing the submittal.
- 4. Requests for fee refunds received within 6 months from the date of permit issuance or application or plan submittal may be issued for extenuating circumstances (e.g., in case of death or serious emergencies) with the approval of the Environmental Health Director.
- Applicants that are denied a refund may submit a written statement or speak during privilege of the floor at a regularly scheduled Board of Health meeting to ask the Board to consider their request.

Subject: Revised Recommended Environmental Health Division Fees for 2025

The information in this packet addresses our proposed facility operating and plan review fees and other revenue projections for 2025.

We saw little change in our proposed cost to revenue recovery in most programs and are therefore only proposing the following changes to our fees:

- **Onsite Wastewater Treatment System (OWTS) Fees:**
 - OWTS Replacement Permit w/ Plans Fee: We are proposing to add the discount for replacement systems, with no site evaluation, that was removed in 2024. Until prior to 2024, we are now seeing an increased number of applications received by outside engineers that fall into this category.
 - o **OWTS Plan Review Fee:** We are proposing a 10% increase in the OWTS plan review fee design rates for 1,000-1,999 and 2,000+ gallons per day. We are seeing a slight decrease in our cost recovery due to the review time involved for these larger systems.
 - o OWTS Application Renewal Fee: We currently have the discretion to waive the permit renewal fee/transfer and are adding the same discretion to the application renewal/transfer fee.
- Refund Request Fee: We are proposing to eliminate the \$25 refund processing fee in accordance with the proposed revised policy.

Request: That the Board of Health grant a waiver from S-6.02 of the Tompkins County Sanitary Code (TCSC) for the installation and use of a replacement Onsite Wastewater Treatment System (OWTS) at 175 Williams Glen Road, Ithaca, NY 14850.

Discussion: Tompkins County Sanitary Code Article VI, Section 6.02(a) states: Where a municipal sewage system is available and accessible, no person shall construct any other sewage system except for temporary use in connection with a construction project. When a municipal sewage system is available and accessible to any property, the permit issuing official may order the owner to abandon the use of any other sewage system and to connect with the municipal sewage system within a specified period of time.

Ithaca Town Law Article II, Section 214-5 states: Except as otherwise provided in this article, the owner of any house, ... hereby required at his expense to connect with the municipal public sewer and, also, at his expense, to install plumbing and toilet facilities therein and to connect such facilities directly with the public sewer in accordance with the provisions of this chapter, and even if sewage collection and disposal facilities are provided by any other public agency in such area.

The owners of the property, Joshua and Rachel Lambert, need a waiver from the Tompkins County Sanitary Code in order to construct a replacement OWTS permit for this residential home on this property. On April 22, 2204, the owners received a waiver from the Town of Ithaca Article II, Section 214-5 law (attached).

The owners of the property are now requesting a waiver from Article VI, Section 6.02(a) of the TCSC to install a replacement OWTS because of financial hardship (attached). The cost to connect to the municipal system was estimated to be between \$80,000 and \$100,000. The proposed onsite system includes an Enhanced Treatment Unit as part of the design. The Environmental Health Division supports this waiver request.
