



# Vaccine Safety & Efficacy



Protect Us All



- The COVID-19 vaccines have gone through the same rigorous review that all vaccines must follow in the U.S. As of December 30, 2020, two vaccines have been approved by the FDA: the Pfizer/BioNTech vaccine and the Moderna vaccine.
- These approvals followed three rounds of clinical trials with tens
  of thousands of participants with a diverse range of race, age
  and other demographics (posted on TCHD website).
- In New York, the State's independent COVID-19 Clinical Advisory Task Force, made up of prominent health experts, also approved these COVID-19 vaccines as safe and effective.
- Additionally, even after a vaccine is approved, multiple safety systems at the FDA and the CDC constantly monitor for adverse events. If an adverse event is found, it is immediately investigated to determine if it poses a true health issue.
- mRNA vaccines do not use the live virus that causes COVID-19



# Vaccine Distribution Begins in Tompkins County



Protect Us All



- Over 1,500 doses have been distributed to phase 1A eligible recipients in Tompkins County, with 1,800 more planned this week. (# does not include nursing homes)
- 94% of doses received by CHS have been distributed.
  - Phase 1A includes healthcare workers and emergency medical services personnel
- TCHD Website will update eligibility list weekly and will include link to register. Eligibility updates will coincide with public information and press releases.
- Currently an indoor location at the Shops at Ithaca Mall is serving as the Point of Dispensing (POD) for vaccines.
- PODs are being done in coordination with CHS, the State and the regional hub.

## Ongoing Disease Management & Surveillance

While the vaccines become more widely available, we will continue to use all of the tools in our toolbox to help stop the spread of COVID-19.

# Vaccine Distribution Updates





- 7,287 doses administered by CHS/TCHD to-date
  - No additional doses allocated for week of 1/18
- TCHD was cited by the Governor's office as a top performer in NYS, distributing 100% of available doses.
  - Cayuga Health leads the state in distribution of available doses to staff
- Operating one Point of Dispensing (POD) at the Shops at Ithaca Mall. The POD is designed to maximize efficiency of delivery with the limited number of doses allocated through New York State. As eligibility and supply increase, more PODs will be opened throughout the community.
- We will continue to communicate more information as it becomes available through press releases, the Health Department website, robocalls, and other methods.
- 2-1-1 will be managing vaccine related questions through their call center.
  - Unable to register individuals due to availability.





# Vaccine Web Page Statistics






## **COVID-19 Disease Prevalence**





## COVID-19 Positive Cases since 7/1 (2,839 Total)








## **COVID-19 Disease Prevalence**



## Tompkins County Vaccine Registry, Launched 2/24: tompkinscountyny.gov/health/covid19vaccineform

- The registry will collect information from currently eligible individuals and allow TCHD to communicate directly with those who are eligible when doses become available.
- Caregivers, family members, or friends can complete this registry on behalf of someone who does not have access to the Internet.
   Individuals without computer and/or internet access may also call 2-1-1 (877-211-8667) and someone can register them over the phone
- If indicated in the registry, individuals who do not have computer access will be called by a staff member from 2-1-1 or the County's Office for the Aging to register for an appointment.
- This registry does not guarantee a vaccine appointment.
- Eligible individuals should continue to seek available vaccine appointments through pharmacies and State-run sites if they are able.
- This registry does not replace those processes.





# **Ethnicity**














# **COVID-19 Disease Prevalence**







On May 12, following FDA guidance, NYS authorized use of the Pfizer-BioNTech COVID-19 Vaccine to include adolescents 12 through 15 years of age. TCHD Began putting plans in place to run clinics targeted to this population in partnership with CHS and local school districts.






# **COVID-19 Disease Prevalence**






## Hospitalizations

# Understanding the Delta Variant

#### 8/10/21 Press Release

#### **Delta FAQ on TCHD Website**

Data continue to show that COVID-19 vaccines are highly effective at preventing severe illness, hospitalization, and death both locally and nationally, even for those infected with the Delta variant.

#### The New Normal

- Vast majority of cases across the U.S., NYS, and Tompkins County
- Of the 87 samples from the months of June and July that were available for sequencing, 86 samples were of variants, and 80 of those were the Delta variant.
- All samples of fully vaccinated individuals sequenced in this batch resulted from infection by the Delta variant.

### **Higher Transmission Rate**

- The Delta variant is known to be more contagious and spread more rapidly than the original COVID-19 virus.
- Data has also emerged showing that vaccinated individuals infected with the Delta variant can still contract and spread the virus.
- A majority of the positive cases in Tompkins County in June and July resulted from large indoor gatherings and domestic travel.
- In areas with substantial or high transmission rates, fully vaccinated individuals should wear a mask in public indoor settings to help prevent the spread of Delta and protect others.

















































# Combined COVID-19 Hours & Expenses Over Time









Tompkins County residents total for 120 days ending December 7, 2021; N=3,268











Tompkins County residents. Totals Feb. 1 through Dec. 20, 2021. N=21.













Running total of vaccinations for Tompkins County as compiled in the NYS Vaccine Tracker.








## Age Distribution of Confirmed COVID-19 Cases

Tompkins County residents during 120 days ending December 21, 2021; N=5,932











### **Vaccination Status of Positive Cases (weekly totals)**

All cases are residents of Tompkins County, N.Y. The date for each 7-day report is the end of the reporting week.




