ITEM III.

Review of 2024-2025 UPWP and Resolutions 2024-01 and 2024-02

Report: The latest draft of the Simplified Statement of Work/UPWP for the April 1, 2024–March 31,2025 fiscal year has been emailed to committee members for review and comment. The Planning Committee reviewed and recommended the draft 2024/2025 UPWP for approval during its January 16,2024 meeting. The Policy Committee must approve a final UPWP during their February 13,2024 meeting in order to meet the NYSDOT deadline of March 1. A copy of the draft UPWP was sent to NYSDOT's MPO Bureau for comments and their feedback will be incorporated in the document. Please send any comments to Fernando de Aragón.

Please note that the draft UPWP includes the following project for use of the required 2.5% Set Aside for Safe and Accessible Transportation Options. No other proposals were submitted. The total available is **\$9,469**.

 Expand the bike parking survey performed in the City of Ithaca area to include all municipal populations centers in Tompkins County, plus Cornell, Ithaca College, and TC3. The work will be performed by Bike Walk Tompkins, a program of the Center for Community Transportation. Project outcome will be survey data and an interactive map of bike parking facilities in Tompkins County.

Looking ahead, the principal staff-led initiatives for 2024-2025 will be the LRTP update and the TIP update. The TIP update process is expected to begin in the fall of 2024.

Action Requested: Policy Committee approval of the draft 2024-2025 UPWP and Operating Budget via Resolutions 2024-01 and 2024-02 (below).

RESOLUTION 2024-01

APPROVAL OF THE 2024-2025 ITHACA-TOMPKINS COUNTY TRANSPORTATION COUNCIL OPERATING BUDGET

- WHEREAS, the *Ithaca-Tompkins County Transportation Council* was designated by the Governor of the State of New York as the Metropolitan Planning Organization for the Ithaca-Tompkins County Metropolitan Area; AND
- WHEREAS, as the designated Metropolitan Planning Organization for the Ithaca-Tompkins County Metropolitan Area the *Ithaca-Tompkins County Transportation Council* receives certain federal and state grants for the purpose of conducting transportation planning activities in a "comprehensive, continuing, and cooperative" manner; AND
- WHEREAS, the *Ithaca-Tompkins County Transportation Council* is provided with administrative services, including budget and financial services, by its Host Agency, Tompkins County; AND
- WHEREAS, the *Ithaca-Tompkins County Transportation Council* has reviewed its proposed 2024-2025 Operating Budget for the period of April 1, 2024 through March 31, 2025;
- NOW THEREFORE BE IT RESOLVED, that the *Ithaca-Tompkins County Transportation Council* does hereby adopt the 2024-2025 Operating Budget for the period April 1, 2024 through March 31, 2025 and directs the Host Agency to implement said budget;
- **BE IT FURTHER RESOLVED,** that the *Ithaca-Tompkins County Transportation Council* does hereby authorize its Staff Director to take the necessary administrative actions to implement and administer said budget, as represented in "ATTACHMENT A", which is hereby made an integral part of this resolution;
- **BE IT FURTHER RESOLVED,** that the *Ithaca-Tompkins County Transportation Council* does hereby request that the Host Agency take the appropriate actions necessary to cause this adopted budget to be fully implemented without interruption prior to March 31, 2024.

RESOLUTION 2024-02

APPROVAL OF THE 2024-2025 UNIFIED PLANNING WORK PROGRAM

- **WHEREAS,** federal transportation legislation requires that Metropolitan Planning Organizations be established in each urbanized area of over 50,000 in population; AND
- WHEREAS, the *Ithaca-Tompkins County Transportation Council* has been designated by the Governor of the State of New York as the Metropolitan Planning Organization for the Ithaca-Tompkins County Urbanized and approved Metropolitan Planning Areas; AND
- WHEREAS, the Metropolitan Planning Organizations are required to carry out a "*continuing, cooperative, and comprehensive*" urban transportation planning process that addresses all modes of transportation; AND
- WHEREAS, in order to implement a continuous, cooperative, and comprehensive transportation planning process in the Ithaca-Tompkins County Metropolitan Area, it is a requirement to develop an annual Unified Planning Work Program (UPWP); AND
- WHEREAS, the Ithaca-Tompkins County Transportation Council, in accordance with the requirements of regulations (23 CFR §450.308(d)), has developed a Simplified Statement of Work for fiscal year 2024-2025 that serves as the Unified Planning Work Program; AND
- WHEREAS, in order to support the elements of the 2024-2025 Unified Planning Work Program, the *Ithaca-Tompkins County Transportation Council* continues its designation of the New York State Department of Transportation to be the grant applicant on its behalf; AND
- WHEREAS, the New York State Department of Transportation has agreed to apply for necessary regular program funding under the Federal Transit Administration Section 5303 program, under the Federal Transit Administration Section 5307 program, and under the Federal Highway Administration "PL" transportation planning program in amounts consistent with this approved 2024-2025 Unified Planning Work Program;
- **NOW THEREFORE BE IT RESOLVED,** that the *Ithaca-Tompkins County Transportation Council* hereby approves the 2024-2025 Unified Planning Work Program and directs the submission thereof to the appropriate Federal and State agencies and directs the filing of the appropriate grant applications to support the program;
- **BE IT FURTHER RESOLVED,** that the Transportation Policy Committee of the *Ithaca-Tompkins County Transportation Council* hereby authorizes and directs its Staff Director to execute and administer the 2024-2025 Unified Planning Work Program in cooperation with and with the assistance of the Transportation Planning Committee.

2023-2027 TIP Action Amendment - Update of FTA 5307 Table-FFY 2024

Report: Tompkins County is requesting a 2023-27 TIP/STIP amendment to the FTA Sect.5307 Tables in FFY 2024. The amendment reallocates FTA Sec. 5307 funding from FFY 22/23 to FTA Sec. 5307 for FFY 23/24, on behalf of Tompkins Consolidated Area Transit, Inc. (TCAT), Gadabout Transportation Service, Inc. (Gadabout), and Tompkins County. Eight project budgets are amended as shown in the TIP amendment form below. The TIP and STIP will remain fiscally constrained.

Action Requested: Policy Committee approval of proposed 2023-2027 TIP amendment of the FTA 5307 table.

2023-2027 TRANSPORTATION IMPROVEMENT PROGRAM

Amendment

Update of FTA 5307 Table-FFY 2024

The Policy Committee of the Ithaca-Tompkins County Transportation Council (ITCTC) approved an amendment to the 2023-2027 Transportation Improvement Program (TIP) on February 13, 2024, during a regularly scheduled meeting. The amendment was reviewed and approved by the ITCTC Planning Committee on January 16, 2024. The actions on the ITCTC's 2023-2027 TIP include amending eight activities to the Section 5307 Urban Formula Program. The changes to the current State Transportation Improvement Program (2023-2027 STIP) affect Section 5307 activities to the FTA Tables for FFY 2024, as described below and in the attached table.

Description:

Tompkins County requests the ITCTC approve a 2023-27 TIP/STIP amendment to the FTA Tables in FFY 2024. The amendment allocates FTA Sec. 5307 funding from FFY 22/23 to FTA Sec. 5307 for FFY 23/24, on behalf of Tompkins Consolidated Area Transit, Inc. (TCAT), Gadabout Transportation Service, Inc. (Gadabout), and Tompkins County.

Eight project budgets are amended:

- Operating Assistance TCAT
- Transit Facility Rehab Project
- Low or No Vehicle emissions Program
- Tompkins County Project Administration
- Tompkins County Mobility Management
- Tompkins County SCMP Mobility Management
- Gadabout Acquire ADP Software
- Gadabout replacement Buses

A total of \$31,114,255 in federal funding is being used from the 2023 Section 5307 Urban Formula Program for the above eight projects in FFY 23/24.

Update of FTA 5339 Table-FFY 2024

The Policy Committee of the Ithaca-Tompkins County Transportation Council (ITCTC) approved an amendment to the 2023-2027 Transportation Improvement Program (TIP) on February 13,2024, during a regularly scheduled meeting. The amendment was reviewed and approved by the ITCTC Planning Committee on January 16, 2024. This amendment to the ITCTC's 2023-2027 TIP adds two projects utilizing Section 5339 funds and apportionments of small Urbanized Areas (SUZA) and State/Territory allocation to Tompkins County. The changes to the current TIP and State Transportation Improvement Program (2023-2026 STIP) affect Section 5339 SUZA and State Territory activities in the FTA Tables for FFY 2024, as described below and in the attached table.

Description:

Tompkins County requests the ITCTC approve a 2023-27 TIP/STIP amendment to the FTA Tables in FFY 2024. The amendment adds two new projects allocating FTA Sec. 5339 SUZA and State/Territory funding from FFY 23 to FFY 24, on behalf of Tompkins Consolidated Area Transit, Inc. (TCAT) and Tompkins County. The actions on the ITCTC's 2023-2027 TIP include two projects with a total of five activities. The two projects with associated activities are as follows:

Project 1-Transit Facilities Upgrades

- Security Fobs for entrance doors
- Facility Security Cameras
- Carbon Monoxide Detectors for our facility

Project 2- Computer software upgrades and replacement

- Server and Computer Upgrades
- Route Planning Software Replacement

A total of \$545,208 (\$436,167 federal) in Section 5339 Formula Program funding is being used for the two new projects. The proposed amendment to the 2023-2027 TIP and STIP are shown in Attachment A table. The table shows the projects as they will appear in the TIP and STIP. The TIP and STIP will remain fiscally constrained.

2023-2024 UPWP Amendment – Resolution 2024-03

Report: Two unanticipated salary/fringe budget items have been recently identified and are addressed in Resolution 2024-03. The resolution reprograms carry-over funds to accommodate these unanticipated expenses. The items needing action are:

- Fernando de Aragón, Staff Director of the ITCTC, formally retired from the NY State Local Retirement System on August 19, 2023. To complete the retirement process, Tompkins County, as the ITCTC host agency, was required to pay for the accumulated fringe time (vacation & personal) as of the retirement date, an amount totaling \$8,835.12.
- Tompkins County has completed an evaluation and update of salary pay scales. The Transportation Analyst position pay scale was adjusted from pay grade 13 to 14. The resulting increase in pay amounts to \$6,114 combined salary and fringe. The increase is retroactive to January 1, 2024. This UPWP amendment accounts for the period from January 1-March 31, 2024, adding to the budget a total of \$1,100 salary and \$500 fringe.

Resolution 2024-03, below, describes the changes and shows the updated budget tables for the 2023-24 UPWP. Table 2 shows the proposed changes in **bold**.

Action Requested: Policy Committee approval of the proposed amendment to the 2023-2024 UPWP via Resolutions 2024-03 (below).

RESOLUTION 2024-03

APPROVING AMENDMENTS TO THE 2023-2024 UNIFIED PLANNING WORK PROGRAM

- **WHEREAS,** federal transportation legislation requires that Metropolitan Planning Organizations be established in each urbanized area of over 50,000 in population; AND
- WHEREAS, the *Ithaca-Tompkins County Transportation Council* has been designated by the Governor of the State of New York as the Metropolitan Planning Organization for the Ithaca-Tompkins County Urbanized and approved Metropolitan Planning Areas; AND
- WHEREAS, in order to implement a continuous, cooperative, and comprehensive transportation-planning process in the Ithaca-Tompkins County Metropolitan Area, the *Ithaca-Tompkins County Transportation Council* has developed and adopted the 2023-2024 Unified Planning Work Program, which is in accordance with federal requirements; AND
- WHEREAS, Fernando de Aragón, Staff Director of the *Ithaca-Tompkins County Transportation Council*, formally retired from the NY State Local Retirement System on August 19, 2023; AND
- WHEREAS, to complete the retirement process, Tompkins County, as the *Ithaca-Tompkins County Transportation Council* host agency, was required to pay for the accumulated fringe time (vacation & personal) as of the retirement date, an amount totaling \$8,835.12; AND
- WHEREAS, Tompkins County performed an evaluation and update of salary pay scales and determined that the Transportation Analyst position pay scale will increase from pay grade 13 to pay grade 14; AND
- WHEREAS, the Transportation Analyst salary increase will be paid retroactively to January 1, 2024 resulting in an increased salary and fringe expense from January 1, 2024 to March 31, 2024 of \$1,100 in salary and \$500 in fringe; AND
- **WHEREAS,** the Ithaca-Tompkins County Transportation Council has access to Federal Highway Administration (FHWA) carry-over funds that can be reprogrammed to cover agency operation expenses;

- NOW THEREFORE BE IT RESOLVED, that the Ithaca-Tompkins County Transportation Council does hereby amend the 2023/2024 Unified Planning Work program by increasing the FHWA Auditable Budget by \$9,100 for the PERSONNEL budget line, and \$500 for the FRINGE/LEAVE budget line. These fund transfers are to be reflected in the 2023/2024 Ithaca-Tompkins County Transportation Council Operating Budget with an increase of \$9,100 to the "Combined Salaries" budget line under 'Expenses', an increase of \$500 to the "Fringe" budget line, and an increase of \$9,600 to the "Reprogrammed Funds" budget line under 'Revenues'; and an increase of \$9,600 to federal FHWA P.L. funds and corresponding state and local match adjustment in the 2023/2024 Programmatic Funding Summary table. These changes are shown in bold in the attachment to this resolution.
- **BE IT FURTHER RESOLVED**, that the *Ithaca-Tompkins County Transportation Council* hereby authorizes and directs its Central Staff Director to submit the necessary copies of this amendment and any necessary revisions to the <u>2023-2024 Unified Planning Work Program</u> document to the pertinent State and Federal Agencies.

Policy Committee Action: The 2023-2027 TIP Amendment: Updating Highway Safety Performance Targets for 2024—Text Amendment, and Resolution 23-09, Supporting NYSDOT's 2024 Targets For Highway Safety Performance Measures, were Moved by Rod Howe, seconded by Jason Leifer, and approved by consensus.

Resolution 23-09 SUPPORTING NEW YORK STATE DEPARTMENT OF TRANSPORTATION'S 2024 TARGETS FOR HIGHWAY SAFETY PERFORMANCE MEASURES

- WHEREAS, the Ithaca-Tompkins County Transportation Council has been designated by the Governor of the State of New York as the Metropolitan Planning Organization responsible for the comprehensive, continuing, and cooperative transportation planning process for the Ithaca-Tompkins County Urbanized and approved Metropolitan Planning Areas; AND
- **WHEREAS,** the Highway Safety Improvement Program (HSIP) final rule (23 CFR Part 490) requires States to set initial targets for five safety performance measures by August 31, 2020; AND
- WHEREAS, As required by 23 CFR Part 490, New York State must set annual safety performance targets (5 year rolling averages) for five safety performance measures; AND
- **WHEREAS,** the New York State Department of Transportation (NYSDOT) has established year 2024 targets based on five year rolling averages for the following performance measures:
 - (1) Number of Fatalities,
 - (2) Rate of Fatalities per 100 million Vehicle Miles Traveled (VMT),
 - (3) Number of Serious Injuries,
 - (4) Rate of Serious Injuries per 100 million VMT, and
 - (5) Number of Non-Motorized Fatalities and Non-motorized Serious Injuries, AND
- WHEREAS, the NYSDOT coordinated the establishment of safety targets with the 14 Metropolitan Planning Organizations (MPOs) in New York through the New York State Association of Metropolitan Planning Organizations (NYSAMPO), AND
- WHEREAS, the Governors Traffic Safety Committee has adopted safety targets for number of fatalities, rate of fatalities and number of serious injuries as set forth in the Highway Safety Strategic Plan (HSSP), and NYSDOT has officially adopted identical 2024 safety targets in the Highway Safety Improvement Program annual report dated August 31, 2023, AND
- **WHEREAS,** the Ithaca-Tompkins County Transportation Council may establish safety targets by agreeing to plan and program projects that contribute toward the accomplishment of the State targets, or establish its own target within 180 days of the State establishing and reporting its safety targets,
- **NOW THEREFORE, BE IT RESOLVED,** that the ITCTC Policy Committee has agreed to support NYSDOT's 2024 targets for the five highway safety performance targets as attached herein, AND
- **BE IT FURTHER RESOLVED,** that the MPO Policy Committee directs the ITCT Staff Director to update the 2023-2027 TIP to include the 2024 highway safety targets, AND
- **BE IT FURTHER RESOLVED,** that the MPO Policy Committee will plan and program projects that contribute to the accomplishment of said targets.

2023-2027 TRANSPORTATION IMPROVEMENT PROGRAM **Amendment**

<u>Updating Highway Safety Performance Targets for 2024 -</u> <u>Text Amendment</u>

The Policy Committee of the Ithaca-Tompkins County Transportation Council (ITCTC) approved an amendment to the text of the 2023-2027 Transportation Improvement Program (TIP) on **December 19, 2023** during a joint meeting with the Planning Committee. The amendment was reviewed and approved by the ITCTC Planning Committee during the meeting. The action on the 2023-2027 TIP is described below.

Description:

Federal rules require the State to set targets for five safety performance measures in coordination with MPOs. NYSDOT worked with the NY State Association of MPOs (NYSAMPO) and its working groups to develop a set of targets. The Ithaca-Tompkins County Transportation Council may establish safety targets by agreeing to plan and program projects that contribute toward the accomplishment of the aforementioned State targets or establish its own targets. The ITCTC, along with other NY State MPOs, has opted to support the State targets. Starting on 2017 the ITCTC has passed resolutions annually *supporting New York State Department of Transportation's Targets for Safety Performance Measures*. These targets have been updated in the TIP each year.

NYSDOT has developed 2024 Targets for safety performance measures. These targets are supported by the ITCTC per Resolution 23-09: Supporting New York State Department of Transportation's 2024 Targets for Safety Performance Measures.

This text amendment to the 2023-2027 TIP follows a format as agreed by NYSDOT and FHWA in coordination with NYSAMPO. The amended text serves to update performance measure safety targets to 2024 as shown in Attachment A (underlined/strike through text) below. The TIP and STIP will remain fiscally constrained.

Addressing Performance Targets

Background

Unchanged

HSIP and Highway Safety

On March 15, 2016, FHWA published the final rule for the HSIP and Safety Performance Management (Safety PM) Measures in the *Federal Register* with an effective date of April 14, 2016.

The 2017 New York Strategic Highway Safety Plan (SHSP) is intended to reduce "the number of fatalities and serious injuries resulting from motor vehicle crashes on public roads in New York State." The SHSP guides NYSDOT, the MPOs, and other safety partners in addressing safety and defines a framework for implementation activities to be carried out across New York State. The NYSDOT Highway Safety Improvement Program (HSIP) annual report documents the statewide performance targets.

The ITCTC agreed to support the NYSDOT statewide targets for Safety PM measures as shown in the table below, based on five year rolling averages per Title 23 Part 490.207 of the Code of Federal Regulations. Resolutions agreeing to support statewide targets were approved as follows:

- December 19, 2023, Resolution 2023-09: Supporting NYSDOT's 2024 Targets for Safety Performance Measures
- October 24, 2017, Resolution 2017-05: Supporting NYSDOT's 2018 Targets for Safety Performance Measures
- September 11, 2018, Resolution 2018-04: Supporting NYSDOT's 2018 Targets for Safety Performance Measures
- October 15, 2019, Resolution 2019-06: Supporting NYSDOT's 2020 Targets for Safety Performance Measures
- August 25, 2020, Resolution 2020-03: Supporting NYSDOT's 2021 Targets for Safety Performance Measures
- September 14, 2021, Resolution 2021-03: Supporting NYSDOT's 2021 Targets for Safety Performance Measures
- September 13, 2022, Resolution 2022-06: Supporting NYSDOT's 2023 Targets for Safety Performance Measures

Anticipated Effects

Safety is a critical component of the ITCTC's mission, and the projects on the TIP are consistent with the need to address safety. Safety is a primary consideration in the selection of projects to be included in the TIP. "To improve the safety of the overall transportation system" is an overarching goal of the ITCTC Long-Range Transportation Plan (LRTP). In addition, the LRTP includes goals and policies prioritizing safety as a base component of all infrastructure design. The Initial Project Proposal utilized during TIP development requires a description of each project's safety benefits regardless of funding source. HSIP funded projects include additional safety analysis. The TIP includes projects programmed with HSIP funds and other fund sources that are expected to materially benefit the safety of the traveling public on roadways throughout the metropolitan planning area. The anticipated effect of the overall program is that it will contribute toward achieving NYSDOT's safety performance targets. b. <u>2023-2027 TIP Amendment: MbC Rte. 13/34/96 Elmira Rd. to N. Ithaca City Line – New SDF Funding.</u> Fernando de Aragón reported that NYSDOT is requesting an amendment to add 100% SDF funds to both the construction and inspection phases of this project. Dave Roth added that this is part of the paving program, funding was awarded, and this action adds money to the project. MbC is *maintenance by contract.*

MbC Rt 13/34/96 – NEW SDF FUNDING

The Policy Committee of the Ithaca-Tompkins County Transportation Council (ITCTC) approved an amendment to the text of the 2023-2027 Transportation Improvement Program (TIP) on **December 19, 2023**, during a scheduled joint meeting with the Planning Committee. The action on the 2023-2027 TIP is described below.

Description:

NYSDOT is requesting an amendment to add 100% SDF funds to both the Construction and Inspection phases of the *MbC Route 13/34/96*, *Elmira Road to North Ithaca City Line*-PIN 305767 project. The changes are as follows.

- 1. New FFY 24/25 Construction phase composed of \$7,364,000 in SDF funds.
- 2. New FFY 24/25 Construction phase composed of \$736,000 in SDF funds.

The tables in Attachment A include the project as it will appear in the TIP (note: changes shown in **bold**). This amendment will not affect the funding of projects within any other jurisdiction. The TIP and STIP will remain fiscally constrained.

 - The project kicked off on November 28, 2023.
 - o Several meetings have been held and public outreach efforts will begin soon.
 - Erin Cuddihy reported that the next meeting is being held today at 3:00pm.
- GHG Performance Measure.
 - This new regulation will be implemented in 2024.
 - More information will come before the committees next year.
 - o It makes sense to do statewide numbers.
 - It will be incorporated into the LRTP update.
- LRTP.
 - A press release went out last week; it should be showing up in local papers this week.
 - Members were sent the press release; please include it in your municipal newsletters and websites.
 - The ITCTC website has a page just for the LRTP update.
 - o <u>https://www.tompkinscountyny.gov/itctc/lrtpupdate</u>
- Solar Eclipse.
 - There will be a total eclipse of the sun on Monday, April 8, 2024 with the path of totality being just barely to the north of Tompkins County. This event draws tens of thousands of people to an area for a short period of time, resulting in significant transportation impacts. Municipalities should be planning ahead for this to mitigate the negative impacts and to see if there are ways to benefit from the influx of visitors; plans and events that encourage a longer stay will also help to lessen the transportation impacts and help local businesses.

- BUILD NY grant for Curry Road is moving forward; waiting to get the agreement with the state fully executed.
- Expecting to receive the last payment for Cemetery Road bridge soon.
- The town is working on an application for the next round of the grant.

2. Joel Gagnon (Town of Danby).

• Paving will begin in the spring and normal maintenance will be ongoing this winter.

3. Ronny Hardaway (Village of Lansing).

- The sewer extension work in Cayuga Heights has been paused for the winter with clean up and repaving done in the spring.
- Next spring and summer will have a major project on Dart Drive and Graham Road.
- The north end entrance to the Shops at Ithaca Mall, heading to the Y and Target will see a project next year of paving, improving the width, and lane marking.

4. Tim Logue (City of Ithaca).

- E. State Street mill and pave has been a successful project, winning a Pride of Ownership Award from the Rotary Club. Suit-Kote was an excellent company to work with.
- The Black Diamond Trail bridge over the flood control channel is temporarily open for the winter; the finish work will be done in the spring.
- The S. Albany Street bridge is open for the winter; it will be finished up in the spring.

5. Dave Roth (NYSDOT Region 3).

- The TAP process has begun; pre-applications started last week.
- There is a new round of Bridge NY grants; applications are due by the end of January.
- NYSDOT is gearing up for new program updates; the regional program is being reviewed.
- The Rt 13/34/96 project is going through design approval; it will go to the city in January. Fernando de Aragón added that this project will generate a lot of public interest.

6. Ruth Groff (Town of Lansing).

• Currently concentrating on trails and the town center.

7. C.J. Randall (Town of Ithaca).

- There was a kick-off meeting with DOT; the Townline Rd. bridge has been authorized to move forward to scoping.
- The Safety Corridor is under pre-review; an application will be prepared in January.

8. Kate Kelley-MacKenzie (Town of Caroline).

- Hoping for trail extension at the South Hill Recreation Way in the future. Rod Howe reported that there is a meeting with NYSEG today.
- The Town Highway Barns are being rebuilt.

9. Katrina Bergan (NYSDOT Region 3).

• The Route 13/34/96 project got design approval last week.

10. Mike Lane (Tompkins County Legislature).

- Bridge projects in "the making": Midline Road, Podunk Road, Cortland St. bridge (in Groton).
- The Airport was told by FAA that it needs a new fire station; the county continues to look for grants to help cover the cost.

11. Brent Cross (Village of Cayuga Heights).

- A question for Dave Roth: Does the Bridge NY program have local decision-making in awarding the grant? David Roth replied that the MPO takes part in the review process of bridges but the Culvert NY are under regional state review, with the MPO only being informed of the awards. Brent Cross asked how a municipality could get a "better shot" at culvert funding. Dave Roth suggested applicants should have the ROW needs clear, when it can be done, and confirm ownership of culverts to be competitive.
- The village has two TAP projects for sidewalks: "Walking Safe" on Kline Road hopes to have a consultant soon, and Cayuga Heights Road sidewalk project has selected Hunt Engineers.

12. Curt Parrish (TCAT).

 TCAT will need to find a place to park approximately 30 buses from mid to late summer during the garage floor project; they will be reaching out to everyone soon.

13. Jason Leifer (Town of Dryden).

- There was a public meeting on Genung Road last night.
- The trail bridge construction should be done by next year.
- Freese Road has been delayed.

14. Erin Cuddihy (*City of Ithaca*).

- SS4A: Eleven municipalities joined together for the project; there will be a project check-in today at 3:00 pm. The
 consultant sent out data requests to municipalities.
- Smart Grant: The transit signal priority project is underway. An ad was submitted to Contract Reporter for RFPs; there are proposals from at least six companies to review.
- **Carbon Reduction:** a consultant has been selected; working to get a contract signed. This project will include a conceptual bike network, a plan of cycling networks adopted by the city, and improvements to the corridor.
- Build Grant (Rt. 13) meeting: It is in design, Bergman consultants worked on three alternatives; public outreach will take place in 2024.
- TAP application: Floral Ave. crosswalks and bike safety.

15. Rod Howe (Town of Ithaca).

• Pleased to hear the county is partnering with municipalities on electric car charging stations.

16. Ray Burger (Town of Dryden).

• Put in a TAP application for the region.
