2023-2027 TRANSPORTATION IMPROVEMENT PROGRAM **Amendment**

New Bridge NY 2023 Project

The Policy Committee of the Ithaca-Tompkins County Transportation Council (ITCTC) approved an amendment to the 2023-2027 Transportation Improvement Program (TIP) on **November 5, 2024**, during a regularly scheduled joint meeting with the Planning Committee. The action on the 2023-2027 TIP and the current State Transportation Improvement Program (STIP) affects one (1) project as described below.

Description:

Tompkins County, in coordination with NYSDOT, is requesting an amendment to create a new Bridge NY project to replace the Falls Rd over Taughannock Creek Bridge. The new project is titled *Falls Rd over Taughannock Creek Bridge Replacement* - PIN 375757 and consists of Federal BFP Off System funds and Local funds. The project funding is structured as follows:

PIN 375757

- a. Total of \$4,750,000 in 100% Federal BFP Off System funds.
- b. Total of \$250,001 in Local funds.

LRTP Update – Final Draft Review

Report: A near final draft of the 2045 Long Range Transportation Plan has been available for final comments for the last month - https://www.tompkinscountyny.gov/itctc/lrtpupdate. The document follows a similar format from the 2040 version, but with updated data and information. All comments received, including input from the online survey, have been included in Appendix C. The public comment period closed on November 1. Final approval of the document is scheduled for the December 17, 2024 joint meeting of the ITCTC.

ITEM VIII

2026-2030 TIP Update

Report: The TIP Update is now underway. The new TIP will cover the 5-year period from FFY 2026-2030, that is Oct.1, 2025-Sept.30, 2030. Final TIP approval is scheduled for June 2025.

Project sponsors with projects that extend into the next TIP have been asked to provide any required schedule or funding changes that will facilitate project completion. This analysis is ongoing. Once completed we will have an idea of what funds are available for new projects. At that time a call for projects will be announced.

The steps and timeline for completion of the TIP Update process are as follows – exact dates are yet to be determined:

- Meeting with sponsors of continuing projects Dec or January
- Call for projects Initial Project Proposal (IPP) submission deadline likely late March
- Meeting of current and potential project sponsors March/April 2025
- Staff prepares draft TIP likely in May 2025

- Public Comment period May/June 2025
- Final Approval ITCTC Joint Meeting June 2025

As usual, funding is quite limited. Staff will work with all project sponsors and applicants, together with our partners in NYSDOT, to facilitate an update process that is fair and inclusive and results in the most advantageous use of available funding for our community.
