FREE GIS (Mapping and Analysis) SERVICES FOR MUNICIPALITIES

2020 Guidelines

The Tompkins County 2020 budget provides up to \$500 in free GIS services to municipalities within Tompkins County through the Department of Planning and Sustainability (TCDPS). This equates to roughly 10 hours of GIS analysis and three poster-sized maps.

What is GIS?

A geographic information system (GIS) is a framework for gathering, managing, and analyzing data. Rooted in the science of geography, GIS integrates many types of data. It analyzes spatial location and organizes layers of information into visualizations using maps and 3D scenes. With this unique capability, GIS reveals deeper insights into data, such as patterns, relationships, and situations—helping users make decisions (www.esri.com).

Examples of how GIS can assist a municipality:

- Bringing together multiple pieces of information to inform decisions, such as examining floodplains, wetlands, waterways, zoning, etc. when considering the vulnerability of future development to flood hazards.
- Providing evidence needed for successful grant applications, such as visually depicting results of a housing conditions survey to support an application for a Community Development Block Grant (CDBG) award for a housing rehabilitation program.
- Creating visual materials to help with municipal efforts, such as depicting proposed zoning changes.

Examples of commonly used data available for this analysis:

- Tax parcel data
- Wetlands, watersheds, and waterways
- Soils
- Aerial Imagery (air photos)

MUNICIPAL TRAINING OPPORTUNITIES

The Tompkins County Department of Planning and Sustainability (TCDPS) collaborates with other partners to offer municipal board trainings to meet New York State professional development requirements and to educate municipal officials and staff on relevant topics. TCDPS welcomes suggestions about training topics of interest.

2019 Training Events

Fall Local Government Conference was held at Tompkins Cortland Community College (TC3) in Dryden on October 24, 2019. TCDPS staff partnered with TC3, Town of Dryden, and NYS Department of State to bring a diversity of presenters on the following topics: municipal ethics, open meetings law, NYS retirement reporting, State Comptroller audit process, disaster preparedness and response, agricultural districts law, SEQR: Short EAF, case law updates.

Wetlands training was held in Groton on October 29, 2019. TCDPS and Soil and Water Conservation District staff partnered to present an hour-long training on wetland definitions, regulations, and maps and demonstrated how to use online mapping resources.

Stream buffer workshop was held in Ithaca on November 21, 2019. A committee of the Water Resources Council coordinated the event with speakers from the Upper Susquehanna Coalition, TCDPS, NYS Water Resources Institute, and Soil and Water Conservation District. The workshop included talks on riparian buffers, buffer protection tools, watershed planning, project implementation, and case studies. Videos are available for each presentation (approximately 20-30 minutes each): ccetompkins.org/buffers **You are welcome to use these videos for your own in-house training.**

Incremental Development Alliance, a national nonprofit that coaches on implementation of neighborhood-scale development, hosted four trainings in 2019. In April they gave a public presentation on the Incremental Development movement. In June IncDev provided a half-day ticketed seminar for prospective small developers, followed by a half-day training with municipal staff and board members in September. IncDev returned in October to conduct a zoning analysis exercise as well as a training for TCDPS staff to be able to replicate and improve on that process for additional municipalities.

2020 Training Events – in the planning stages

Fall Local Government Conference will be held at TC3 mid-September through November. Tentative topics include procurement/bid policy, cyber security, stormwater plan review, reading a site plan. <u>What topics would you like?</u>

Stream buffer workshop: site visit – planning is underway for a field-oriented stream buffer training in May.

MUNICIPAL PARKS AND TRAILS GRANT PROGRAM

2020 Program Guidelines

The Tompkins County 2020 budget includes \$50,000 to fund small grants for municipalities within Tompkins County that wish to improve their municipal parks and/or trails. The fund is administered by the Department of Planning and Sustainability.

Eligible Applicants and Funding

- City, town, and village governments within Tompkins County are eligible to apply for these funds.
- Grant awards of up to \$5,000 are available to fund improvements to publicly managed or supported parks and/or trails.
- Municipalities may apply for more than one project or grant; however, the total approved funding for any one municipality shall not exceed \$5,000.
- A resolution from an elected body or a support letter from a supervisor or mayor should be included in the application.

Eligible Projects

- 1. Park or trail infrastructure (e.g., construction of new trail segments, water connections for restrooms or fountains)
- 2. Park or trail improvements (e.g., benches, trash cans, lighting, tree plantings)
- 3. Park or trail recreational equipment (e.g., playground equipment, soccer goalposts)
- 4. Land acquisition for parks or trails, including easements
- 5. Staffing costs for installing infrastructure, improvements, or equipment funded by the grant. (Note: programming and staffing for operations are ineligible for this program.)

Evaluation Criteria

Preference will be given to municipalities that did not receive funding in 2019. Proposals will be evaluated on how well the project achieves the following criteria:

- Improves publicly owned, managed, or supported parks or trails
- Can be completed within one year of grant award
- Demonstrates history of successful completion of other projects funded by the County (if applicable)

Process

The online application will open March 2, 2020, and the deadline for submission is **5:00 PM on April 2, 2020**. The application form will be accessible via a link on the Department of Planning and Sustainability webpage (http://tompkinscountyny.gov/planning). The application will ask for contact information, amount requested (with detailed breakdown), project category, location, description, and timeline, SEQR requirements, and documentation of municipal support.

Project proposals will be reviewed by the Tompkins County Department of Planning and Sustainability, with approval by the Commissioner of Planning and Sustainability. Applications will be reviewed for completeness and evaluated based on the evaluation criteria identified above. In mid-April, applicants will be notified if their proposal will receive funding or not. Upon approval, the County will prepare a contract for the awardee's signature. The County will make payments to the municipality upon receipt of documentation of funds spent.

TOMPKINS COUNTY NATURAL INFRASTRUCTURE CAPITAL PROGRAM

Program Guidelines

The Natural Infrastructure Capital Program provides funding to protect natural systems that can help mitigate the adverse impacts of climate change. At this time, the focus is on: 1) mitigating the potential for downstream flooding and sedimentation, and 2) establishing important migratory corridors to enable plant and animal species to be more resilient in the face of a changing climate.

Eligible Applicants and Funding

- Local governments and non-profit 501(c)(3) organizations that have been operational for at least three years and have proven capacity to own, hold, and steward land for conservation purposes. Other entities interested in accessing this funding should contact the Tompkins County Department of Planning and Sustainability (TCDPS) to determine if they would be eligible to apply for these funds.
- The County cost will not exceed one-third of the most recent assessed value of the land that is eligible for this program, as valued by the County Assessment Department, up to a maximum of \$200,000.

Eligible Projects

The proposed project must meet <u>all</u> of the following minimum requirements:

- 1. The project must result in the long-term protection of the resource through fee-simple acquisition or a conservation easement being held on the property;
- 2. The property owner is a willing participant;
- 3. A qualified public or not-for-profit entity will be responsible for holding title or easement on the property, including future management and stewardship;
- 4. The project will provide permanent protection of the resource;
- 5. The project is at least partially located within:
 - a. A Natural Features Focus Area or Priority Protection Area as defined in the Tompkins County Conservation Plan or
 - b. An area of high habitat connectivity value as defined in the Tompkins County Habitat Connectivity Plan or
 - c. An area of high scenic, recreational or trail value;
- 6. The project is not the result of complying with local land use regulations that require the preservation of open space as part of a development proposal.

Project Selection Process

- 1. Projects should be submitted to TCDPS, where they will be screened on a rolling basis for project and applicant eligibility;
- 2. Eligible projects will be evaluated by TCDPS and the Natural Infrastructure Committee of the Planning Advisory Board (PAB) to determine the proposed project's ability to fulfill the program purpose;
- 3. If TCDPS and the Natural Infrastructure Committee recommend a project be funded, the proposed project will be reviewed by the full PAB;
- 4. Pending support from the PAB and the Commissioner of Planning and Sustainability, the project will be presented to the relevant County Legislature committee;
- 5. If approved by the Legislature committee, the project will go to the County Legislature for final approval;
- 6. If approved, the applicant will be notified as such and the project will move forward in full compliance with County procedures for contracting for capital projects; project funds will be administered by TCDPS.

MUNICIPAL PLANNING ASSISTANCE

Program Guidelines

The Tompkins County Department of Planning and Sustainability has set aside up to 200 hours of staff time to work on planning projects identified by municipal officials. Our work can take one of two forms: Direct Services or Best Practices Reports.

Direct Services.

The Department will work for and under the direction of an individual municipality on a specific local project, such as helping to write a chapter of a comprehensive plan, facilitating public meetings on planning-related topics, or updating a portion of a local ordinance.

Best Practices Report.

The Department will research best practices for local governments to address a specific issue they are struggling with, such as implementing form-based codes or identifying alternative methods for preparing population projections. A final written "Best Practices Report" would be provided to all municipalities and, if appropriate, the County would conduct a training session on its findings and recommendations.

Eligible Applicants:

Every town, village or city government within Tompkins County is eligible for this program.

Cost of Assistance:

<u>For Direct Services</u>, the municipality will pay for half of the assigned planner's time at a rate of \$27 per hour. The County will pay the other half of the planner's time and cover minor incidental costs (such as local travel, printing, and the like).

For a Best Practices Report, there would be no charge to any municipality.

Project Selection:

Call for Projects [2020]

Three projects have already been selected for 2020. However, if any of these projects are canceled and the Department has staff available, we will reach out to municipalities to announce our availability.

Call for Projects [2021]

A formal call for projects for 2021 will be made in September. Municipal officials are encouraged to contact the Department at any time to discuss project ideas.

Selection Criteria

The selection process is based on the availability of staff with the required expertise; and, preference is given to

- municipalities without professional planning staff,
- projects that would further the principles and policies of the Tompkins County Comprehensive Plan, and,
- municipalities who have not previously participated.

The Department selects as many projects as it can support (probably one to three in any year).

HOUSING AFFORDABILITY & SUPPORTIVE INFRASTRUCTURE GRANT

2020 Program Guidelines

The Tompkins County 2020 Annual Budget includes \$50,000 to support municipalities working to address the community's housing shortage. In particular, this program is intended to:

- Increase the number of municipalities applying for state or federal funding related to housing affordability, including Community Development Block Grants (CDBG), HOME, and New York State Consolidated Funding Applications (CFA), and to increase the success of these applications.
- Increase the supply of housing that is available and affordable for Tompkins County residents.
- Increase the development of housing in Tompkins County locations with access to existing infrastructure and amenities and low transportation costs.
- Improve and maintain the affordability of existing housing.

Applicant and Project Eligibility

The proposed project must meet all of the following minimum requirements:

- Only municipal governments are eligible to apply for these funds.
- The project must support housing affordability.
- The County cost will be no more than 90% of the total project cost.
- Projects must have a reasonable expected completion date within nine months of award date.
- Projects may request no more than \$10,000 in County funds.
- Funding may be used to hire consultants or to add staff time to perform the following:
 - 1. Write and/or administer grants
 - 2. Prepare zoning amendments to meet program intentions
 - 3. Conduct research necessary to increase housing development and lower housing costs
 - 4. Develop infrastructure studies
- Funding may also be used to implement infrastructure improvements that support affordable housing development (ex. sidewalk connections, water and sewer connections).

Project Priority Criteria

The proposed project must substantially address at least two of the objectives in each of the following three categories:

Impact on Housing Affordability

Ability to complete project in less than nine months

Address housing shortage for underserved market segments

Increase neighborhood diversity (unit types, price points, underserved groups)

Increase supply of affordable housing

Supports Tompkins County and Local Comprehensive Plans

In or near a Development Focus Area

Compatible with Municipality's Comprehensive Plan

Compatible with County's Comprehensive Plan and Housing Strategy

County or Locally adopted Energy Goals

Local Match and Support

Cash or in-kind match of no less than 10%

Support from the municipality's planning board, elected body, town supervisor or mayor

Process

Project proposals for 2020 will be accepted by the Tompkins County Department of Planning and Sustainability (TCDPS) on a rolling basis from February 28, 2020 until November 1, 2020. Proposals seeking \leq \$5,000 of County funds will be reviewed by TCDPS staff based on the Applicant and Project Eligibility and Project Priority Criteria. The Commissioner of Planning and Sustainability will be authorized to approve applications for \leq \$5,000 that clearly meet the letter and intent of the program. Projects applying for more than \$5,000 will be brought to the relevant committee of the Tompkins County Legislature and then to the full Legislature for approval.
