#### Call to Order

- Mr. Pronti, Board Chairperson, called the meeting to order at 8:31 a.m.
- Mr. Pronti welcomed Board members and new Staff member Ms. Rusk, Workforce Development Specialist and Mx. Frost, Communications Specialist

#### **Board Action Items**

#### Approval of Minutes - March 26, 2024

It was moved by Ms. Franzese, seconded by Mr. Levesque, and unanimously adopted by voice vote of members present to approve the minutes of March 26, 2024, as written.

#### Approval to Contract 2024 Summer Youth Employment Program (SYEP)

It was moved by Mr. Holden, seconded by Ms. McDaniel, and unanimously adopted by voice vote of members present to approve to move into contract negotiations for the 2024 Summer Youth Employment Program.

### Workforce Development Director Update

#### **WIOA Legislation Updates**

Mr. Sponn reported NYATEP has been giving WDBs guidance on the renewal of WIOA. Currently NYATEP is advocating on behalf of the Boards in Congress.

#### **Deputy Director of Board Interviews**

Mr. Sponn reported Deputy Director Interviews are complete and hopes to make a decision this week.

### Application for NDWG for Opioid Crisis

Mr. Sponn reported the Tompkins WDB applied for a NDWG opportunity with NYSDOL. The grant would provide funding for those impacted by the Opioid crisis and even those who know individuals impacted. Funding can go towards training funding and work experience opportunities.

#### Trades Council Meeting for Tompkins Build

Mr. Sponn reported Ms. Szabo of IAED is working to create Tompkins Build that will be structured similar to Syracuse Build for construction and trades.

#### Micron Regional Construction Industry Partnership in Syracuse

Mr. Sponn reported that leaders in Syracuse are working with Micron to move forward with environmental study and to start building in 2025.

### **Youth Assertive Community Treatment Program**

Mr. Sponn reported Ms. Shanks-Booth from Tompkins County Youth Services is working with the community to help with youth that have mental health issues and connected Workforce Development to the Children's Home Youth Assertive Community Treatment Program. Mr. Sponn met with leadership to discuss collaborations.

#### **Energy Warriors Career Pathways**

Mr. Sponn reported he is in discussions with Mr. Airewele of CCE in finding employment partners for the career pathways programs. Mr. Sponn reported they are also exploring more ways to collaborate through different funding streams. Mr. Sponn

reported Ms. Beck of formerly of BlocPower now works with NYSERDA, but discussions will continue with BlocPower.

#### Youth Employment Resource Team

Mr. Sponn reported the March meeting was held at the Learning Web. The April meeting will be held at Tompkins Cortland Community College for a tour and discussion. In May the group will go to Ithaca ReUse for a tour.

#### Oven Fresh Job Fair

Mr. Sponn reported that the Oven Fresh Job Fair was held on May 16, 2024 at Tompkins Cortland Community College and was able to make connections with businesses and potential participants. Mr. Sponn intends on being present at future job fairs to promote the department and engage with the community.

#### Menlo Micro

Mr. Sponn reported he met with HR leadership from Menlo Micro. There were concerns over childcare and transportation. Mr. Sponn reported he shared available resources and provided more information on the services of Workforce Development.

### **Career Center Update**

Mr. Cerasaro reported to support the design and implementation of career-readiness curricula statewide, the New York State Department of Labor in partnership with the New York State Education Department has launched the first New York State Department of Labor Educator Career Development Ambassador Program, a four-week summer training for teachers. Tompkins County will have one likely start in July.

Mr. Cerasaro reported that the new Business Service Representative at the Career Center has been a good fit and working out well. Mr. Lyman is a dedicated business service representative that will meet with businesses and connect them to the Career Center. He will focus on OJT's, business issues, job fairs to target different sectors, and will work with Ms. Sloan from Workforce Development.

#### **Committee Reports**

#### **Executive Committee**

Mr. Pronti reported that the Executive Committee has been in discussions about staffing and what can be accomplished with a full staff.

#### One Stop Operations and Oversight Committee

Ms. Franzese reported the One Stop Operations and Oversight Committee sent out updates after the last Workforce Development Board meeting. The One Stop has two new

members: Ms. Whitmore of TC3 and Ms. Walters of TST BOCES. The Committee is also talking about the Career Center and if there are needs for a security guard.

### **Youth Oversight Committee**

Mr. Sponn reported that the Youth Oversight Committee has been working on 2024 Summer Youth Employment Program contract amounts.

#### Governance and Membership Committee

Mr. Sponn reported that the Governance and Membership Committee will meet next on Thursday, May 16,2024.

#### Services to Individuals with Disabilities Committee

Mr. Sponn reported that the Services to Individuals with Disabilities Committee has been working on a new Committee name and duties. The Committee also had a presentation from Wegmans and how they are making accommodation for individuals with disabilities.

- Tax credit for apprentices employed full-time for at least six months
- Enhanced tax credits
  - Disadvantaged youth
  - Apprentices with a mentor
- Focus on demand occupations

### **APPRENTICESHIP EXPANSION GRANT**

### Apprenticeship Expansion Grant (AEG) Request for Applications (RFA)-Bid Number AEG-4

- \$3M in funding available (100% of this RFA is financed with federal funds)
- Goal is to expand RA
- 130 apprentices with a focus on underrepresented populations
- Apprentices to enter trades in high-demand occupations
- Funding will cover costs associated with training apprentices through RA
